

### Criminal background

- **MLAs with criminal cases:** Out of the 126 MLAs analysed, 14(11%) MLAs have declared criminal cases against themselves. Out of 126 MLAs analysed during Assam Assembly elections in 2011, 13 (10%) MLAs had declared criminal cases against themselves.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption

- **MLAs with serious criminal cases:** 10(8%) MLAs have declared serious criminal cases including cases related to **murder, attempt to murder** etc. Out of 126MLAs analysed during Assam Assembly elections in 2011, 8 (6%) MLAs had **declared serious criminal cases** against themselves.




Figure: Comparison of MLAs with declared criminal cases in 2011 and 2016

- **MLAs with cases related to murder and attempt to murder:** 3 MLAs have declared cases related to **murder and attempt to murder**. Out of the total 3, 1 each of All India United Democratic Front (AIUDF) and Indian National Congress (INC) declared cases related to murder in their respective affidavits and 1 BJP MLA Kushal Dowa from Thowra constituency has declared 1 charge related to **Murder** and 1 charge related to **Attempt to Murder** in his affidavit.
- **Party wise MLAs with criminal cases:** 7(12%) out of 60 MLAs from BJP, 5(19%) out of 26 MLAs from INC, 1(8%) out of 13 MLAs from AIUDF and the 1 and only elected Independent MLA have declared criminal cases against themselves in their affidavits.
- **Party wise MLAs with serious criminal cases:** 6(10%) out of 60 MLAs from BJP, 3(12%) out of 26 MLAs from INC and 1 (8%) out of 13 MLAs from AIUDF have declared serious criminal cases against themselves in their affidavits.




Figure: Party wise number of MLAs with declared criminal cases




Figure: Share of wealth among MLAs

- Crorepatis MLAs:** Out of the **126** newly elected MLAs, **72 (57%)** are crorepatis. Out of 126 MLAs analysed during **Assam 2011 assembly elections**, **47 (37%)** MLAs were crorepatis.

- Partywise crorepati MLAs:** 34 (57%) out of 60 MLAs from **BJP**, 16 (62%) out of 26 MLAs from **INC**, 10 (71%) out of 14 MLAs from **AsomGanaParishad**, 7 (58%) out of 12 MLAs from **Bodoland Peoples Front**, and 5 (39%) out of 13 MLAs from **AIUDF** have declared assets valued more than **Rs 1 crore**.
- Average assets:** The average of assets per MLA who won in the Assam 2016 assembly elections is **Rs. 2.45 crores** whereas the average asset for each candidate who contested in the 2016 assembly elections was **Rs 1.37 crores**. In 2010, the average assets per 126 MLAs analyzed was **Rs 1.65 lakhs**.
- Party wise average assets:** Among major parties, the average assets per MLA for **60 BJP** MLAs analysed is **Rs 2.23 crores**, **26 INC** MLAs have average assets of **Rs 2.46 crores**, **13 AIUDF** MLAs have average assets of **Rs 2.38 crores**, **14 AsomGanaParishad** MLAs have average assets worth of **Rs.4.14 crores** and **12 Bodoland Peoples Front** MLAs have average assets of **Rs. 1.83 crores**.

- **Number of re-elected MLAs:** Number of re-elected MLAs analysed in the assembly elections of 2016 is 41
- **Average assets of re-elected MLAs in 2011:** The average assets of re-elected MLAs in 2011 was Rs. Rs 1.54 crores
- **Average assets of re-elected MLAs in 2016:** The average assets of re-elected MLAs in 2016 is Rs 2.87 crores
- **Average growth in assets of re-elected MLAs from 2011 to 2016:** The growth in average assets of re-elected MLAs is Rs 1.33 crores i.e. by 86%.

- **Education Details of MLAs:** 42 (33%) MLAs have declared their education qualification to be between 5<sup>th</sup> pass and 12<sup>th</sup> pass while 82 (65%) MLAs have declared having an educational qualification of graduate or above.
- **Age details of MLAs:** 65 (52%) MLAs have declared their age to be between 25 and 50 years while 61 (48%) MLAs have declared their age to be between 51 and 80 years.
- **Gender details of MLAs:** Out of 126 MLAs, 8 (6%) MLAs are women. In 2011, out of 126 MLAs, 14 (11%) MLAs were women.


