Analysis of Donations Received by Chhattisgarh's Major Political Parties – An All India Report

Executive Summary

• Income of Political parties:

o INC (Rs 2,00,871.74 lakhs) tops the list of highest total income collected between FY 2004-05 and 2010-11 followed by BJP (Rs 99,476.67 lakhs) and BSP (Rs 43,839.84 lakhs)

• Share of Donations:

- BJP tops the list of maximum donation collected between FY 2004-05 and 2010-11 with Rs 82,000.50 lakhs, which forms 82.43% of its total income while INC has showed a total donation of Rs 27,250.48 lakhs which is only 13.57% of its total income.
- o BSP's donations of Rs 30,731 lakhs forms 70.1% of its total income

• Share of donations above Rs 20,000:

- o In spite of a total income of Rs 2,00,871.74 lakhs between FY 2004-05 and 2010-11, INC has declared that only 8.85% of its total income is covered by donations above Rs 20,000
- o BJP, with a total income of Rs 99,476.67 lakhs, has only 19.46% coming from donations above Rs 20,000 collected during the same period.
- o Inspite of total donations of BSP being Rs 30,731 lakhs, the party has declared that there was **not a single donation received above Rs 20,000** where details of donors have to be disclosed

• Number of Named contributors:

- BJP has declared the maximum number of contributions for the FY 2011-12 with 1104 donations amounting to Rs 33,41,94,113 (~ Rs 33 crores) in total while INC has only 342 donations amounting to Rs 9,59,10,664 (~ Rs 9 crores) in total during the same period
- Only INC and BJP had <u>donors from Chhattisgarh</u> while BSP had listed no donations as received from Chhattisgarh

• Year-wise donations to Political Parties from Chhattisgarh

- While comparing the amount donated by donors to INC and BJP from Chhattisgarh, it is seen that between FY 2003-04 and 2011-12, INC has failed to receive donations from Chhattisgarh only for 2 Financial Years whereas BJP has managed to receive donations only for 4 Financial years
- While INC accumulated a total of Rs 10,13,376 from Chhattisgarh donors whereas BJP collected a total of Rs 1,38,76,000
- o In FY 2003-04, a single donor has donated Rs 25,00,000 to BJP while INC received donations from 14 donors amounting to Rs 4,96,375





- While 4 donors donated to INC in FY 2006-07 amounting to Rs 1,56,000, 2 donations (Rs 51,000) were made to BJP
- o BJP received Rs 17, 00,000 from 16 donors in FY 2010-11 while INC received Rs 94,200 from 3 donors in the same period

Foreign Funds to BJP & INC:

- Both INC and BJP amounting to Rs 983.50 lakhs and 1,942.50 lakhs respectively received <u>foreign funding</u> <u>between FY 2003-04 and 2011-12</u>. Such donors include the Vedanta group (Sesa Goa, The Madras Aluminium Co. Ltd, Sterlite Industries), Public and Political Awareness Trust of Vedanta, Hyatt Regency (an Americal International company) and Dow Chemicals (headquartered in Michigan, USA)
- Vedanta group is the top donor to both the parties with its subsidiary, Sterlite Industries donating Rs 600 lakhs followed by Sesa Goa Ltd donating Rs 2,78.50 lakhs to INC while the Public and Political Awareness Trust of Vedanta donated Rs 1450.00 lakhs to BJP followed by Vedanta The Madras Aluminium Co. Ltd donating Rs 350.00 lakhs between FY 2003-04 and 2011-12.

• Major Donors of Political Parties:

- o General Electoral Trust is a major donor to INC (Rs 3,641 lakhs) for the Financial Years 2003-04 to 2010-11 while it must be noted that the trust has not made any contribution for the FY 2011-12
- Other major donors include Torrent Power donating Rs 1415 lacs followed by Bharti Electoral Trust donating Rs 1100 lacs to INC neither of which has made any contribution to INC in the FY 2011-12
- Top donor to BJP has been General Electoral Trust (Rs 2,657 lakhs) followed by Public & Political Awareness
 Trust (Rs 1,450 lakhs) and Torrent Power Limited (Rs 1,300 lakhs)





Analysis of Donations Received by Chhattisgarh's Major Political Parties – An All India Report

Political parties rely heavily on donations for fighting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals.

Section 29C of the Representation of People Act, 1951 says that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. Named contributions seem to be very small i.e. single contributions above Rs 20,000 seem to be very few in numbers for all the parties.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Moreover, these are cash donations and it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus, it becomes all the more important to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

Share of Donations in Total Income and Donations from Named Sources from all over India

- The total Income of political parties considered have been calculated from the income to the parties from various sources all over India as submitted in their Income Tax Returns. Major political parties from Chhattisgarh are Indian National Congress (INC), Bharatiya Janata Party (BJP) and Bahujan Samaj Party (BSP).
- Details of donors who made donations above Rs 20,000, such as their names, address, PAN No., mode of payment and amount donated, have to be made public by the political parties and such donors are called named donors.
- INC (Rs 2, 00,871.74 lakhs) tops the list of highest total income collected between FY 2004-05 and 2010-11 followed by BJP (Rs 99,476.67 lakhs), BSP (Rs 43,839.84 lakhs).
- BJP tops the list of maximum donation collected between FY 2004-05 and 2010-11 with Rs 82,000.50 lakhs
 which forms 82.43% of its total income while INC has showed a total donation of Rs 27,250.48 lakhs which is
 only 13.57% of its total income
- BSP has showed a total donation of Rs 30,731 lakhs which is 70.10% of its total income
- In spite of a total income of Rs 2,00,871.74 lakhs between FY 2004-05 and 2010-11, INC has declared that only 8.85% of its total income is covered by donations above Rs 20,000
- BJP, with a total income of Rs 99,476.67 lakhs, has only 19.46% coming from donations above Rs 20,000 collected during the same period
- Inspite of total donations of BSP being Rs 30,731 lakhs, the party has declared that there was not a single donation received above Rs 20,000 where details of donors has to be disclosed

Total Number of Contributors Contributing Above Rs 20,000 from Chhattisgarh

In 9 years, the donations report of BSP has stated that the party had received no donations above Rs 20,000 from any donor all over India. The two major National Parties INC and BJP have given a remarkably low number of donors donating above Rs 20,000 from Chhattisgarh.

If a donor has made multiple contributions in any one financial year, each contribution has been individually counted. Hence, if a donor has donated twice, the number of contributors would be counted as 2.

Year-wise Donations to Political Parties from Chhattisgarh

- While comparing the amount donated by donors to INC and BJP from Chhattisgarh, it is seen that between FY 2003-04 and 2011-12, INC has failed to receive donations from Chhattisgarh only for 2 Financial Years whereas BJP has managed to receive donations only for 4 Financial years
- While INC accumulated a total of Rs 10,13,376 from Chhattisgarh donors, BJP collected a total of Rs 1,38,76,000
- In FY 2003-04, a single donor has donated Rs 25,00,000 to BJP while INC received donations from 14 donors amounting to Rs 4,96,375
- While 4 donors donated to INC in FY 2006-07 amounting to Rs 1,56,000, 2 donations (Rs 51,000) were made to BJP
- BJP received Rs 17, 00,000 from 16 donors in FY 2010-11 while INC received Rs 94,200 from 3 donors in the same period

- Chattishgarh Mini Steel Plant Association is one of the major donors of INC contributing Rs 1,00,001 between FY 2003-04 and 2011-12 followed by Shri Dharmendra Shahu (Rs 75,000) and Tarun Chatterjee (Rs 60,000)
- Top donor to BJP has been Jindal Steel & Power Ltd. (Rs 25,00,000) followed by Trilok Surana (Rs 2,00,000) and Ashok Sharma (Rs 2,00,000) making contributions between FY 2003-04 and 2011-12 from Chhattisgarh

Modes of Payment of Donors to Political Parties from Chhattisgarh (FY 2003-04 to 2011-12)

- It is to be noted that while 61.72% of the total donations of INC was made in cash by 18 donors, no donation was made in cash to BJP
- 36.07% of the total donations of INC was made by cheque (8 donors) whereas 97.84% of the total donations was made by cheque (117 donations) to BJP
- Though no money was electronically transferred to INC as donations from Chhattisgarh, a total of Rs 2 lacs was donated via electronic transfer to BJP
