Summary and Highlights

Tamil Nadu Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of **29 Ministers including the Chief Minister** from Tamil Nadu State Assembly 2016.

Criminal Background

- **Ministers with Criminal Cases:** **8 (28%)** out of the 29 Ministers have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** Out of the 8 Ministers who have declared criminal cases, **4 have declared serious criminal cases**. These cases include attempt to murder, voluntarily causing hurt by dangerous weapons or means etc.

Financial Background

- **Crorepati Ministers:** Out of the **29** Ministers, **24 (83%)** are crorepatis.
- **Average Assets:** The average assets of **29** Ministers are **Rs 8.55 crores**.
- **Details of PAN:** Only **1** minister has not declared PAN details. She is **V. M. Rajalakshmi** from **Sankarankovil** constituency
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Selvi J Jayalalithaa** from Dr Radhakrishnan Nagar constituency with assets worth **Rs. 113.73 crores**. The top three Ministers with highest declared assets are:

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
