## Summary and Highlights

West Bengal Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of **42 Ministers including the Chief Minister** from West Bengal State Assembly 2016. The list of Ministers in this report has been derived from media reports due to unavailability of an official list on the website of the West Bengal government.

### Criminal Background

- **Ministers with Criminal Cases:** 9 (21%) out of the 42 Ministers have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** Out of the 9 Ministers who have declared criminal cases, **7 have declared serious criminal cases**. These cases include attempt to murder, kidnapping, communal disharmony etc.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Cronepati Ministers:** Out of the 42 Ministers, **24 (57%)** are crorepatis.
- **Average Assets:** The average assets of 42 Ministers are **Rs 3.36 crores**.
- **Details of PAN:** All ministers have declared PAN detail in their affidavits.
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Jakir Hossain** from Jangipur constituency with assets worth **Rs. 28.04 crores**. The top three Ministers with highest declared assets are:

- **Ministers' Education:** A total of **33 (79%)** Ministers are graduates or have higher degrees while **9 (21%)** Ministers have education qualification of 12<sup>th</sup> pass or below.
- **Ministers' Age:** A total of 10 ministers have declared their age between 31 to 50 years. 29 Ministers have declared their age to be between 51 and 70 years and 3 Ministers declared their age to be between 71 and 80 years. The **youngest minister** is **Laxmi Ratan Shukla** aged 35 years from Howrah Uttar constituency.

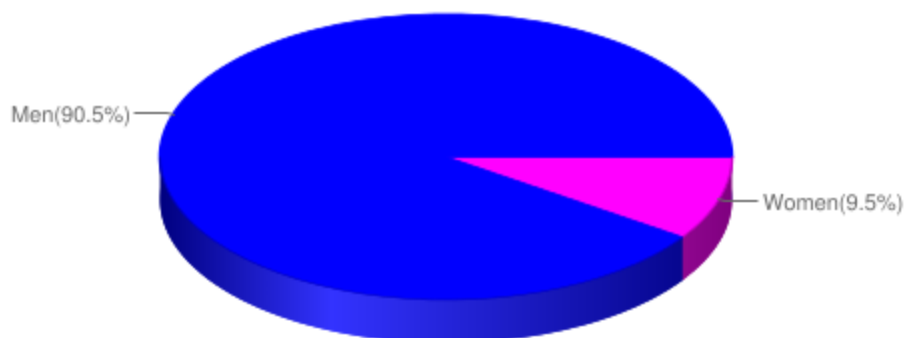
