Analysis of Income, Expenditure and Donations received by Major Political Parties of Odisha [FY 2012-13 to 2014-15]

Political parties represent citizens of the country at various levels of the government, voice people's demands and concerns to the administrative and legislative machinery, and therefore serve as a link between citizens and the government.

Apart from collecting donations/voluntary contributions, it is seen from the IT Returns of political parties that a few parties are collecting funds by issuing coupons in lieu of receipts to donors for cash contributions. Being cash donations, it is difficult to establish the identity of the donor. It is possible that a lot of cash donations received, remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued. Thus, it is imperative to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

By filling RTI applications, ADR has collected copies of the ITRs and donations from IT Departments and Election Commission of India (ECI) for the financial years 2012-13, 2013-14 and 2014-15.

Analysis of Total Income & Expenditure of Major Political Parties of Odisha, FY 2012-13 to 2014-15 <u>Total income of political parties during 3 years</u>


- The income of Political Parties during FY 2012-13 to 2014-15 are calculated from their IT returns filed annually with the Income Tax Department.
- BJP has the highest total income of Rs 1968.41 crores between FY 2012-13 and 2014-15, this is 44.95% of the total income of all national parties during the same time.
- INC has the second highest income of Rs 1617.06 crores which is 36.93% of the total income of all national parties.
- Total income of **BJD** is **Rs 38.5 crores** which is **higher than the total income of CPI** (Rs 5.35 cr) during the period between FY 2012-13 and 2014-15.

Top sources of income of political parties during FY 2012-13 to 2014-15

- From the table below, it can be noted that there is neither standardization nor consistency in the parties' declaration of their sources of funds.
- Income from Voluntary Contributions, Grants and Donations are the most common and the top most source of income for all 7 political parties of Odisha.
- **Voluntary Contributions, Grants** and **Donations** totally amount to **Rs 2534.71 crores**, constitutes **57.38%** of the total income of all political parties in 3 FYs.
- Other sources of income which are most common amongst parties are **Interest & dividend**, **Membership fees** and **subscription**.
- Through Interest & dividend parties have collected a sum of Rs 138.14 crores, which forms 3.13% of the total income of parties. Followed by Membership Fees and Subscription which is also a common source of income for parties through which parties have collected Rs 83.83 crores. (In case of parties, where interest & dividend and Membership Fees and Subscription is not a part of top 3 sources, it has been included in other income)
- BSP has received 31.40% of its income from Sale of Property Immovable and Movable assets.
- BJD has only two sources of income; Grant/Donations/Contributions through which it has received Rs 36.43 crores which is 94.62% of its total income and Fees & Subscriptions through which it has received Rs 2.07 crores.

Table: Top sources of income for National and Regional Political Parties of Odisha during FY 2012-13 to 2014-15








Chart: Top source of Income of National and Regional Party of Odisha, FY 2012-13 to 2014-15

Top items of expenditure of National and Regional Parties during FY 2012-13 to 2014-15

- Between FY 2012-13 and 2014-15, **INC** has the highest expenditure of Rs 1723.53 crores, followed by BJP which declared an expenditure of Rs 1464.997 crores, and CPI-M which spent Rs 242.444 crores in total.
- The most common items of expenditure across parties include expenses towards **Elections**, **Advertising & Publicity** and **Travelling & Conveyance**.
- Under election expenses, the maximum expenditure has been incurred by INC which spent Rs 1019.38 crores, (forms 59.14% of its total expenses), followed by NCP whose election expenses aggregate to Rs 80.76 crores, 54.85% of its total expenses. BJP has shown no election expenses in this period.
- The maximum expenditure of BJP has been towards Advertisement & Publicity which constitutes 49.32% (Rs 722.48 crores) of its total expenses, followed by travelling on which it has spent 22.69% (Rs 332.42 crores) of its total expenses.
- For **BJD**, which is the only regional party of Odisha, total expenditure was for **Rs 22.37 crores**, out of which **69.87%** (or **Rs 15.63 crores**) was spent on **Elections**.






Chart: Top Items of expenditure of National and Regional Party of Odisha, FY 2012-13 to 2014-15





Analysis of Voluntary Contributions Received by Political Parties FY 2012-13 to 2014-15

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals. Section 29C of the Representation of People Act, 1951 states that political parties submit details of contribution received in excess of Rs 20,000 from any person or a company to the ECI annually.


Total number and amount of Donations received by National Political Parties from Odisha,

FY 2012-13 to FY 2014-15

- Only 3 national parties, BJP, INC and CPI, have received donations from Odisha* during this period. BJP received the highest amount of Rs 64.99 lakhs from 2 donations, followed by INC which received Rs 5.69 lakhs from 3 donations. CPI received the least amount of Rs 4.09 lakhs amongst all national parties.
- Donations received by BJP is 86.92% of the total donations received by all political parties during this period.
- CPI-M, NCP and BSP have not received any donation from Odisha between FY 2012-13 to 2014-15.




Total number and amount of Donations received by Regional Parties of Odisha from all over India, FY 2012-13 to FY 2014-15

- BJD received a total of Rs 35.62 crores from 94 donations from all over India*, during FY 2012-13 and 2014-15.
- The party, in FY 2012-13, had declared that it did not receive any donations above Rs 20,000 during the year.
- It received **61.20**% of its total donations (or **Rs 2180.04 lakhs**) in FY 2014-15, while the remaining **38.80**% or **Rs 1382.30 lakhs** was received in FY 2013-14.
- BJD has received the highest amount of donations from Maharashtra for Rs 3000.63 lakhs (84.23% of its total donations), followed by Rs 384.21 lakhs from Odisha (10.79%), Rs 152 lakhs from Jharkhand, and Rs 25 lakhs from New Delhi. Donation worth Rs 0.50 lakhs have incomplete information.



Known and Unknown sources of Income of National and Regional Political Parties of Odisha (FY 2012-13 to 2014-15)

The contribution statements, submitted by the political parties declaring names and other details of donors who contribute above Rs 20,000, are the only **known source**. The **unknown sources** are income declared in the IT returns but **without giving source of income for donations below Rs.20,000**. Such unknown sources include 'sale of coupons', 'Aajiwan Sahayog Nidhi', 'relief fund', 'miscellaneous income', 'voluntary contributions', 'contribution from meetings/ morchas' etc. The details of donors of such voluntary contributions are not available in the public domain.

- Total income of National parties between FY 2012-13 and 2014-15: Rs 4,378.85 crores
- Total income of BJD between FY 2012-13 and 2014-15: Rs 38.5 crores
- Total income of political parties from known donors (details of donors as available from contribution report submitted by parties to Election Commission): Rs 1004.93 crores, which is 22.75% of the total income of the parties (6 National Parties and BJD)
- Total income of political parties from other known sources (e.g., sale of assets, membership fees, bank interest, sale of publications, party levy etc.): Rs 473.71 crores, or 10.72% of total income
- Total income of political parties from unknown sources (income specified in the IT Returns whose sources are unknown): Rs 2938.71 crores, which is 66.53% of the total income of the parties

<u>Sector-wise donations to National and Regional Political Parties of Odisha</u> (FY 2012-13 to 2014-15)

- **BJP, INC** and **CPI** are the only national parties to have received donations from Odisha between FY 2012-13 to 2014-15.
- 2 donations that have been received by BJP during this period, both are from Corporate/Business Houses.
- CPI has received Rs 3.04 lakhs from Odisha State Council without declaring the name of the contributors. Thus, these donations have been categorized under undeclared donors, which is 74.33% of the total donations received by CPI from Odisha.
- BJD has received 92.15% of its total donations or Rs 3282.62 lakhs from Corporate/Business Houses, while it has received only 7.85% of its total donations or Rs 279.72 lakhs from individuals.




Chart: Sector-wise donations received by BJD from all over India


Party-wise donations without declaration of PAN details

- None of the donations received by INC and CPI from Odisha, between FY 2012-13 and 2014-15, have PAN details.
- Of the 94 donations declared by BJD, the party received **Rs 1,820 lakhs** from **3 donations**, in which PAN details were not provided. These 3 donations form **51.09% of the total amount of** donations received by it from all over India, between 2012-13 and 2014-15.

Mode of contribution to National and Regional Political Parties of Odisha (FY 2012-13 to 2014-15)

- INC has received **Rs 0.48 lakhs** from donations in **cash**, this forms **8.44**% of the total donations received by it from Odisha between FY 2012-13 and 2014-15.
- BJD has received 60.17% of its total donations or Rs 2143.33 lakhs from donations with incomplete mode of contribution details.

Recommendations of ADR

- The ECI had **issued guidelines** to the political parties in order to **promote transparency** in the parties' functioning and to aid the Commission **to conduct free and fair elections.** Those parties playing a decisive role at the national political arena should **lead by example** by voluntarily declaring their sources of income and endorsing transparency in the daily functioning of the party.
- The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.
- Full details of all donors should be made available for public scrutiny under the RTI. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for 80% of the source of funds to be unknown, but at present it is so in India.
- Those parties not following the ICAI guidelines for auditing of reports should be scrutinized by the IT department.
- The National and regional political parties must provide all information on their finances under the Right to Information Act. This will only strengthen political parties, elections and democracy.
