Executive summary of MLAs

Delhi Election Watch (DEW) has analyzed affidavits of the 68 MLAs (out of the maximum 70) in the current assembly. Affidavits of 2 MLAs have not been analyzed since they are either incomplete.

Criminal

- MLAs with Criminal Cases: Out of these 68 MLAs analyzed for Delhi Assembly Elections, 29 MLAs or 43% have declared criminal cases against them.
- Party wise MLAs with Criminal Cases: Out of 39 MLAs of INC- 15(38%) have declared criminal cases, out of 24 MLAs of BJP- 11 (46%) have declared criminal cases. There is only 1 Independent MLA, 1 MLA from RJD and 1 MLA from LJP and all of them have declared criminal cases against themselves.
- MLAs with serious criminal cases: Out of the 29 MLAs who have declared criminal cases against themselves, 6 (9%) MLAs declared serious criminal cases like murder, attempt to murder, kidnapping, theft etc.

Financial

- Average Assets: Average Asset per MLA (of 68 analyzed MLAs) in current Assembly is Rs. 3
 Crores. Among major parties, the average asset per MLA for BJP is Rs. 3.24 Crores (24 MLAs), for INC is Rs. 2.59 Crores (39 MLAs), for BSP is Rs. 4.81 Crores (2 MLAs), for RJD is Rs. 93.03 Lakhs (1 MLA). And for LJP is Rs.28.06 Lakhs (1 MLA).
- Crorepati MLAs: A total of 47 (69%) out of 68 MLAs analyzed are crorepatis.
- <u>Highest Asset MLAs:</u> Bharat Singh of IND from Najafgarh constituency has declared the highest assets worth Rs 14.45 Crores, followed by Parduymn Rajput of BJP from Dwarka (bye election on 10 september 2009) with declared assets worth Rs 11.90 Crores and Sumesh of INC from Matiala constituency with assets worth Rs 11.43 Crores.
- Low Assets: Only 6 MLAs have declared assets of less than Rs 25 lakhs.
- MLAs with low assets: Sunil Kumar of BJP from Trilokpuri constituency has declared the lowest assets of Rs. 5.15 lakhs. Amrish Singh Gautam of INC from Kondli constituency has declared assets of Rs. 8.35 lakhs. Nand Kishore of INC from Vikaspuri constituency has declared assets of Rs. 15.80 lakhs.
- <u>Liabilities:</u> A total of 11 (16%) MLAs out of 68 analyzed have declared liabilities of Rs. 10 lakhs or above.
- <u>High Liability MLAs:</u> The top three MLAs with highest liabilities are <u>Prof Jagdish Mukhi</u> a <u>BJP MLA</u> from Janakpuri with declared the highest liabilities worth <u>Rs. 42.25 lakhs</u> followed by <u>Dr.S.C.L.Gupta</u> of <u>BJP</u> from Sangam Vihar constituency with liabilities of <u>Rs. 39.17 lakhs</u> and <u>Arvinder Singh</u> an <u>INC MLA</u> from Deoli constituency with liabilities worth <u>Rs 19.95 lakhs</u>.
- MLAs with no PAN: 4 (6%) out of 68 MLAs have not declared their PAN details.

Other Background Details (Education, Gender, Age)

• MLAs Education: 56% MLAs (38 of 68 analyzed) are graduates or have a higher qualification in the Delhi Legislative Assembly of 2008 while 42% of MLAs are non graduates.





- MLAs Gender: Out of 70 MLAs in Delhi Assembly Elections, only 3 (4%) MLAs are women.
- MLAs Age: A total of 2 MLAs out of the 68 analyzed, are more than 70 years of age. A total of 10 MLAs are aged 40 or less.

Analysis based on declared criminal cases – MLAs

Delhi Election Watch (DEW) has analyzed affidavits of 68 elected MLAs. Out of the 68 MLAs analyzed for Delhi Assembly election, 29 MLAs or 43% have declared criminal cases against them.

Party- wise break up of MLAs with declared criminal cases

Out of 39 MLAs of INC- 15(38%) have declared criminal cases, out of 24 MLAs of BJP- 11 (46%) have declared criminal cases. There is only 1 Independent MLA, 1 MLA from RJD and 1 MLA from LJP and all of them have declared criminal cases against themselves.
