



Analysis of Candidates of Uttar Pradesh, Punjab, Uttarakhand, Goa and Manipur (2012)

<u>Highlights</u>

- National Election Watch (NEW) have analyzed the affidavits submitted to the Election Commission of India of 3268 major political party candidates in the five states of Uttar Pradesh, Punjab, Uttarakhand, Goa and Manipur.
- 28% candidates i.e. (906 out of 3268 analyzed) have self declared criminal charges as per their affidavits in the previous Assembly Elections. 383 Candidates out of these 3268 analyzed have declared serious IPC charges like murder and attempt to murder charges against them.
- Uttar Pradesh has the maximum percentage of Candidates, 35% (759 of 2195) with declared criminal cases, followed by Goa with 23% (30 of 129), Uttarakhand 19 %(53 of 278), Punjab 15% (61 of 408) and Manipur 1 %(3 of 258).
- In Uttar Pradesh out of the 759 candidates with criminal charges, as given above, 340(15%) Candidates have declared serious criminal cases against themselves followed by Punjab with 22(5%) candidates, Uttarakhand with 14(5%) and Goa 7(5%) with candidates. Manipur has no candidates with any serious criminal charges.
- Atiq Ahmed of Apna Dal in Uttar Pradesh has the highest 44 number of criminal cases, followed by Brijesh Singh alias Arun Kumar Singh of Pragatisheel Manav Samaj Party in Uttar Pradesh with 39 cases and Mitra Sen also of Uttar Pradesh from SP with 36 cases declared against him. The charges are related to murder, attempt to murder etc.
- A total of 1525(47%) Candidates out of 3268 analyzed in the 5 states are crorepatis. 71 %(92 out of 129) candidates analyzed in Goa are crorepatis followed by 65 %(266 out of 408) in Punjab, 48 %(1046 out of 2195) in Uttar Pradesh, 32% (88 out of 278) in Uttarakhand and 13% (33 out of 258) in Manipur.
- The highest average asset increase of re-contesting MLAs from the outgoing assembly has been for Punjab with an average asset growth of Rs. 6.12 Crores(133%), followed by Goa with Rs. 5.39 Crores (200%), Uttar Pradesh with Rs. 2.35 Crores(194%), Manipur with Rs. 98.08 lakhs(414%) and Uttarakhand with Rs. 92.30 Lakhs(106%).
- A total of 1162(36%) candidates have not declared their Income Tax Returns. Manipur has 66%(170 out of 258) followed by Uttar Pradesh 36% (791 out of 2195), Punjab 23% (92 out of 408), Uttarakhand 36% (99 out of 278) and Goa 8% (10 out of 129)
- Out of 9210 Total Candidates in the 5 states only 771(8%) are women. Uttar Pradesh has 594(9%) of 6850, Punjab has 93(9%) of 1078, Uttarakhand has 63(8%) of 788, Manipur has 12(4%) of 279 and Goa has 9(4%) of 215 candidates.





Background

Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. National Election Watch (NEW) groups in the five states of Uttar Pradesh, Punjab, Uttarakhand, Goa and Manipur have analyzed the affidavits of 3268 Candidates in the 5 states.

This report is based on the analysis of these affidavits. The following pages give state- wise analysis of criminal, financial and other background information of the Candidates.

A total of 9210 candidates representing 340 political parties are in fray in 2012 Assembly Elections in Uttar Pradesh, Punjab, Uttarakhand, Manipur and Goa. In 2007 there were 8436 candidates from 236 political parties.

Analysis Based on Declared Criminal Cases

Declared Criminal Cases against Candidates

- There are 906 Candidates out of the 3268 analyzed, (i.e. about 28 %) who have criminal cases declared against them as per their self sworn affidavits given to the Election Commission.
- Out of the 906 Candidates analyzed with declared criminal cases, 383 have declared serious IPC charges like murder and attempt to murder charges against them.
- Uttar Pradesh has the maximum % of Candidates (35%) with declared criminal cases, with 759 out of 2195 Candidates charged with criminal cases. Out of the 759, 340(15%) Candidates have serious criminal cases declared against them with charges relating to murder, attempt to murder etc.

Analysis Based on Assets

A total of 1525 Candidates out of 3268 analyzed i.e. 47% of the total number of Candidates (analyzed) contesting in the 5 states are crorepatis. 71% of Candidates analyzed of Goa are crorepatis followed by 65% of Candidates of Punjab and 48% of Candidates of Uttar Pradesh.
