EXECUTIVE SUMMARY OF MPs OF RAJYA SABHA

Summary of MPs

- National Election Watch (NEW) analyzed affidavits of 225 out of 242 MPs of Rajya Sabha.
- Out of these 225 MPs analyzed, 40 MPs i.e. 18% have declared pending criminal cases against them. INC has 7 out of 69 MPs (10%) with pending criminal cases, BJP has 7 out of 47 (15%), BSP has 5 out of 17 (29%), SS has 4 out of 4 (100%), CPI has 3 out of 5 (60%), JD(U) 3 out of 6 (50%) and NCP has 2 out of 6 (33%) MPs with pending criminal cases.
- Out of these 40 MPs with pending criminal cases analyzed by NEW, 12 MPs have serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc pending against them. These include 3 from BJP, 2 from 2 from INC and 1 each from CPI(M), TDP, CPI, BJD, BSP and DMK.
- 9 out of 30 (30%) MPs analyzed from Uttar Pradesh have criminal cases pending against them while from Maharashtra, there are 8 out of 19 (42%), Bihar has 4 out of 15 (27%) MPs and Andhra Pradesh has 3 out of 18 (17%) MPs with pending criminal cases.
- There are 154 MPs analyzed from the 5 major parties (INC, BJP, BSP, CPI(M)and NCP). These include 69 from INC, 47 from BJP, 17 from BSP, 15 from CPI(M) and 6 from NCP. Out of these 154 MPs, 23 (15%) have criminal cases pending against them.
- There are 19 IPC charges of heinous nature on MPs which included murder, attempt to murder, kidnapping, extortion, etc.
- There are a total 86 criminal cases pending against MPs of Rajya Sabha.
- Out of 18 women analyzed by NEW, there were 2 women MPs with pending criminal cases.





Analysis based on pending criminal cases

A total of 225 out of 242 affidavits of MPs were analyzed by the National Election Watch (NEW). Out of these 225 MPs analyzed, 40 MPs or 18% declared criminal cases pending against them. Out of these 40 MPs with pending criminal cases, 12 have serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. pending against them.

Party-wise break up of MPs with pending criminal cases

A total of 40 MPs in Rajya Sabha have pending criminal cases against them. INC has 7 out of 69 MPs (10%) with pending criminal cases, BJP has 7 out of 47 (15%), BSP has 5 out of 17 (29%), SS has 4 out of 4 (100%), CPI has 3 out of 5 (60%), JD(U) 3 out of 6 (50%), NCP has 2 out of 6 (33%) MPs with pending criminal cases. 


Figure: Comparison of pending criminal cases and serious pending criminal cases for MPs of main parties from Rajya Sabha
