#### Analysis of criminal and financial details of Rajya Sabha MPs

#### **Executive summary**

Affidavits of 219 Rajya Sabha members furnished by them at time of their election to Rajya Sabha have been analysed for this report. An analysis of asset and liability information available for 183 members for the year 2008-2009 from the Rajya Sabha Secretariat has also been done. Executive summary is given below-

#### 1. Analysis based on pending criminal cases

- i. A total of 37 (17 %) Rajya Sabha MPs have declared pending criminal cases against them according to their self declared affidavits submitted at time of elections. On the other hand, 162 (30%) MPs in current Lok Sabha have pending criminal cases against them.
- ii. Out of these 37 MPs with pending criminal cases, 12 (5%) MPs have serious criminal cases pending against them. These serious cases include attempt to murder, kidnapping, abducting, voluntary causing hurt by dangerous weapons etc. Amongst the MPs with pending criminal cases of heinous nature, Kamal Akhtar (SP) from UP and Ram Chandra Singh (CPI) from West Bengal have attempt to murder cases pending against them and Azaj Ali (JD(U)) from Bihar has pending case of kidnapping and abduction.

On a <u>comparative note</u>, in <u>current Lok Sabha</u> there are pending serious criminal cases against 76 MPs (14%).

iii. Amongst major parties, most parties have MPs with pending criminal cases such as INC has 7 out of 67, BJP has 6 out of 45 and SP has 3 out of 12 Rajya Sabha MPs with criminal cases pending against them. Details for such MPs for major parties are given below:

iv. When analysed state wise, maximum Rajya Sabha MPs with pending criminal cases are from UP with 8 out of 31 MPs having criminal cases pending against them. This is followed by Maharashtra with 6 MPs out of 18 MPs having pending criminal cases.

#### 2. Analysis based on Assets and Liabilities

This analysis is based on annual asset & liability declaration furnished by Rajya Sabha members under sub-rule (1) of the Members of Rajya Sabha (Declaration of assets and Liabilities) Rules, to the Rajya Sabha Secretariat. These declarations were made by MPs as on March 31, 2009.

- A total of 98 Rajya Sabha MPs out of analyzed 183 (54%) Rajya Sabha MPs are crorepatis. On the other hand, in the current Lok Sabha 315 out of 543 MPs (58%) are crorepatis.
- ii. Amongst major parties, 65% of INC Rajya Sabha MPs are crorepatis, whereas 53% of BJP Rajya Sabha MPs are crorepatis.
- iii. When analyzed state wise, maximum number of crorepati Rajya Sabha MPs are from Uttar Pradesh (17 out of 26, i.e. 65%) followed by Maharashtra (13 out of 15, i.e. 87%).
- iv. Highest assets have been declared by Rahul Bajaj, IND (Rs 300 crores) from Maharashtra followed by Dr. M.A.M. Ramaswamy, JD(S) (Rs 278 crores) from Karnataka. These are followed by Subbarami Reddy of INC with 272 crores. Details of 10 crorepati Rajya Sabha MPs with highest declared assets are as given below-

#### Complete analysis based on criminal and financial background

#### Pending criminal cases against Rajya Sabha MPs

A total of 37 Rajya Sabha MPs have declared pending criminal cases against them according to their self declared affidavits submitted at time of elections. Out of these 37 MPs, 12 MPs have serious pending criminal cases against them. These serious cases include attempt to murder, kidnapping, voluntary causing hurt by dangerous weapons etc.

ADR sought annual asset & liability declaration for 2008-2009 furnished by Rajya Sabha members under sub-rule (1) of The Members of Rajya Sabha (Declaration of assets and Liabilities) Rules, 2004 as on the 31<sup>st</sup> day of March every year, by the 30<sup>th</sup> June of that year to Rajya Sabha secretariat using RTI. These were made available for 183 members for the year 2008-2009 and have been analysed as given below-

#### Crorepati Rajya Sabha MPs- Party wise

A total of 98 Rajya Sabha MPs out of analyzed 183 Rajya Sabha MPs are crorepatis. INC has 65% of its Rajya Sabha MPs as crorepatis, whereas BJP has 53% crorepati Rajya Sabha MPs.
