

Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **225** out of **227** winners in the **Municipal Corporation of Greater Mumbai (MCGM) Elections**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal background

- **Winners with criminal cases:** Out of the **225** winners analysed, **43(19%) winners** have declared criminal cases against themselves.
- **Winners with serious criminal cases:** **28(12%) winners** have declared **serious criminal cases**.
- **Winners with cases related to attempt to murder:** **1** winner namely **Umesh Subhash Mane from Shiv Sena won from ward no.115**, has declared cases related to **attempt to murder(IPC Section- 307)**.
- **Winners with cases related to crime against women:** **3** winners have declared cases such as **rape (IPC Section- 376) and Assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**.
- **Party wise Winners with criminal cases:****22(26%)** out of 84 winners from **Shiv Sena(SHS)**, **11(14%)** out of 81 winners from **Bhartiya Janta Party(BJP)**, **2(7%)** out of 31 winners from **Indian National Congress(INC)**, **1(13%)** out of 8 winners from **Nationalist Congress Party (NCP)**, **3(43%)** out of 7 winners from **Maharashtra Navnirman Sena** , **1(17%)** out of 6 winners from **Samajwadi Party (SP)**, **1 (50%)** out of 2 winners from **All India Majlis-E-Ittehadul Muslimeen (AIMIM)** **2(33%)** out of 6 **independent** winners have declared criminal cases against themselves in their affidavits.



Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Winners with serious criminal cases:** 12(14%) out of 84 winners from Shiv Sena(SHS), 8(10%) out of 81 winners from Bhartiya Janta Party(BJP), 2(7%) out of 31 winners from Indian National Congress(INC), 1(13%) out of 8 winners from Nationalist Congress Party (NCP), 1(14%) out of 7 winners from Maharashtra Navnirman Sena , 1(17%) out of 6 winners from Samajwadi Party (SP), 1 (50%) out of 2 winners from All India Majlis-E-Ittehadul Muslimeen (AIMIM) and 2(33%) out of 6 independent winners have declared serious criminal cases against themselves in their affidavits.
