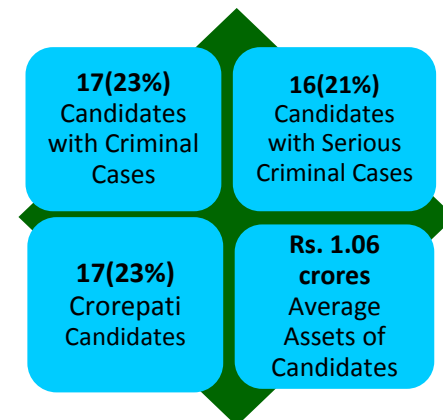

## Summary and Highlights

**Association for Democratic Reforms (ADR)** and **Maharashtra Election Watch** have analysed the self-sworn affidavits of **75** out of **80** winners who had contested in the **20 wards** for the **Akola Municipal Corporation** Elections, held on **21<sup>st</sup> February, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

## Criminal background

- **Winners with criminal cases:** Out of the **75** winners analysed, **17(23%) winners** have declared criminal cases against themselves.
- **Winners with serious criminal cases:** **16(21%)** winners have declared **serious criminal cases**.
- **Winners with cases related to attempt to murder:** **7** winners, have declared cases related to **attempt to murder (IPC Section- 307)**.
- **Party wise Winners with criminal cases:** **2(29%)** out of 7 winners from **Shiv Sena(SHS)**, **6(14%)** out of 44 winners from **Bhartiya Janta Party(BJP)**, **5(39%)** out of 13 winners from **Indian National Congress(INC)**, **1(20%)** out of 5 winners from **Nationalist Congress Party (NCP)**, **1 (100%)** out of 1 winner from **All India Majlis-E-Ittehadul Muslimeen (AIMIM)** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with serious criminal cases:** **2(29%)** out of 7 winners from **Shiv Sena(SHS)**, **5(11%)** out of 44 winners from **Bhartiya Janta Party(BJP)**, **5(39%)** out of 13 winners from **Indian National Congress(INC)**, **1(20%)** out of 5 winners from **Nationalist Congress Party (NCP)**, **1 (100%)** out of 1 winner from **All India Majlis-E-Ittehadul Muslimeen (AIMIM)** have declared serious criminal cases against themselves in their affidavits.

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
