


## **Summary and Highlights**

Maharashtra Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **19** candidates who are contesting in the Maharashtra Assembly Bye Election to be held on 11<sup>th</sup> April 2015, for assembly constituencies of Vandre (East), Mumbai suburban district & Tasgaon Kavathe Mahankal, Sangli district.

## **Criminal Background**

- <u>Candidates with Criminal Cases:</u> Out of the total 19 candidates analysed, **7 (37%) candidates** have declared criminal cases against themselves. Out of 10 candidates analysed for Vadre East seat, 5 candidates (50%) have declared criminal cases against them; whereas out of 9 candidates analysed for Tasgaon Kavathe Mahankal seat, **2 candidates (22%)** have declared crimanl cases against themselves.
- <u>Candidates with Serious Criminal Cases:</u> Out of 7 candidates who have declared criminal cases, 5 have declared serious criminal cases. Out of these 5 candidates who have declared serious criminal cases; 2 candidates both from Vandre East seat reported cases related to voluntarily causing hurt by dangerous weapons & 1 from Vadre East seat reported cases related to kidnapping or abducting with intent secretly and wrongfully to confine person.
- <u>Candidates with Charges framed:</u> Out of 7 candidates who have declared pending criminal cases against themselves, **4 (22%)** have declared that the **charges for these cases have already been framed by court of law.**
- Party wise Candidates with Criminal Cases: 2 (100%) out of 2 candidates analysed from Prabuddha Republican
  Party while 1 (100%) candidate analysed from each of INC & All India Majlis-E-Ittehadul Muslimeen have
  declared criminal cases against themselves in their affidavits.
- Party wise Candidates with Serious Criminal Cases: 1 (100%) candidate analysed from each of INC & All India Majlis-E-Ittehadul Muslimeen have declared serious criminal cases against themselves in their affidavits.
- <u>Red Alert Constituencies\*:</u> The constituency of Vandre (East) has **5 candidates** with declared criminal cases.



#### Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.

\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases standing up for elections. This analysis excludes independent candidates with criminal cases.





## **Financial Background**

- Crorepati Candidates: Out of the 19 candidates analysed, 8 (42%) are crorepatis.
- *Party-wise Crorepati Candidates:* Out of **7** candidates fielded by all political parties combined, **6 (86%)** candidates are crorepatis. **2** candidates are fielded by Prabuddha Republican Party & **1** each are fighting on tickets of All India Majlis-E-Ittehadul Muslimeen, Shiv Sena, INC and NCP.
- Average Assets: The average asset per candidate contesting in this bye election is **Rs 5.62 Crores** with one candidate having assets worth **Rs 72 crores**.
- High Liability Candidates: Only 1 of the 19 analyzed candidate has declared liabilities of Rs.1 Crore and above.
- High Income Candidates: Only 1 of the 19 analyzed candidate has declared a total income of more than Rs 1 crore.
- Undeclared PAN: 3 (16%) out of 19 candidates analysed have not declared their PAN details.
- Candidates who have not declared ITR: 7 (37%) out of 19 candidates have not declared their Income Tax Returns.





## **Other Background Details**

- <u>Education Details of Candidates</u>: Out of 19 analysed candidates, **8** (**42%**) candidates have declared that have an education qualification of **12**<sup>th</sup> **pass or below** while **11** candidates (**58%**) have declared having an educational qualification of **graduate or above**.
- Age Details of Candidates: 14 (74%) candidates have declared their age to be between 25 to 50 years while 5 (26%) candidates have declared their age to be between 51 to 70 years.
- <u>Gender Details of Candidates:</u> 3 (16%) female candidates out of 19 candidates analysed are contesting in the Maharashtra bye elections to be held on 11<sup>th</sup> April 2015. It is interesting to note that from major parties, NCP & Shiv Sena have given their tickets to one woman each and the third woman candidate is an independent.
