

Summary and Highlights

The Gujarat Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **158 out of 182 MLAs**. **24** MLAs have not been analysed because either they are no longer member of Gujarat assembly or due to badly scanned affidavits.

Criminal Background

- **MLAs with Criminal Cases:** Out of the 158 MLAs analysed, **49(31%) MLAs** had declared criminal cases against themselves.
- **MLAs with Serious Criminal Cases:** **21 (13%)** MLAs had declared serious criminal against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise MLAs with Criminal Cases:** 15(36%) out of 42 MLAs from **Indian National Congress (INC)**, 30(27%) out of 112MLAs from **Bhartiya Janta Party (BJP)**, 2 (100%) out of 2 MLAs from **NCP**, 1(100%) out of 1 MLA from**GPP** and1(100%) out of 1 MLA from**JD (U)** had declared criminal cases against themselves in their affidavits.
- **Party wise MLAs with Serious Criminal Cases:** 4(10%) out of 42 MLAs from **Indian National Congress (INC)**, 15(13%) out of 112MLAs from **Bhartiya Janta Party (BJP)**, 1(100%) out of 1 MLA from**JD (U)**, 1(50%) out of 2 MLAs from **NCP**had declared serious criminal cases against themselves in their affidavits.

Party Wise MLAs with Criminal Cases




Figure: Party Wise MLAs with Criminal Cases




Figure: Share of Wealth among MLAs

- **Cronepati MLAs**: Out of the 158 MLAs analysed, **108 (68%)** were crorepati.
- **Party wise Cronepati MLAs**: **23 (55%)** out of 42 fielded by INC, **82(73%)** out of 112 MLAs from BJP, **2 (100%)** out of 2 MLAs from NCP and **1 (100%)** out of 1 MLA from JD(U) had declared assets worth more than Rs. 1 crore.




Figure: Party Wise Cronepati MLAs

- **Average assets:** The average of assets per MLA in the Gujarat Assembly Elections 2012 was **Rs 6.23 Crores**.
- **Party wise average assets:** Among major parties, the average assets per MLA for **42 INC MLAs** is **Rs 7.72 Crores**, **102 BJP MLAs** have average assets of **Rs 5.59 Crores**, and **2 NCP MLAs** had an average assets of **Rs. 15.61 crores**.

Other Background Details

- **Education details of MLAs:** 81 (51%) MLAs had declared their educational qualification to be between 5th pass and 12th pass, while 67 (42%) MLAs had declared having an educational qualification of graduate and above. 6 MLAs had declared themselves as just literates.
- **Age details of MLAs:** 18 (12%) MLAs had declared their age to be between 25 and 40 years while 108(68%) MLAs had declared their age to be between 41 and 60 years. 32(20%) MLAs had declared their age to be between 61 and 80 years.
- **Gender details of MLAs:** There are 13 (8%) women MLAs out of 158 MLAs analysed.




Figure: Overall PAN Report




Figure: Analysis of MLAs on the basis of education




Figure: Analysis of MLAs on the basis of age groups




Figure: Analysis on the basis of gender
