


Figure: Final Party Position

CRIMINAL BACKGROUND

- **MLAs with criminal cases:** Out of the 182 MLAs analysed, 47(26%) MLAs have declared criminal cases against themselves. Out of 182 MLAs analysed during Gujarat Assembly elections in 2012, 57 (31%) MLAs had declared criminal cases against themselves.
- **MLAs with serious criminal cases:** 33(18%) MLAs have declared serious criminal cases including cases related to murder, attempt to murder, dacoity, robbery etc. Out of 182 MLAs analysed during Gujarat Assembly elections in 2012, 24 (13%) MLAs had declared serious criminal cases against themselves.





Figure: Comparison of MLAs with declared criminal cases in 2012 and 2017



Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- MLAs with declared cases related to murder:** 2 MLAs namely **Maheshbhai Chottubhai Vasava (Bhartiya Tribal Party)** and **Katara Bhaveshbhai Babubhai (INC)** have declared cases related to murder (IPC section 302).
- MLAs with declared cases related to attempt to murder:** 6 MLAs have declared cases related to attempt to murder (IPC Section 307).
- MLA with declared case related to rape:** 1 MLA namely **Ahir (Bharwad) Jethabhai Ghelabhai (BJP)** from **Shehra constituency** has declared case related to rape (IPC Section 376) against himself.
- Party wise MLAs with criminal cases:** 18(18%) out of 99 MLAs from **BJP**, 25 (32%) out of 77 MLAs from **INC**, 1 (50%) out of 2 MLAs from **Bhartiya Tribal Party**, 1(100%) MLA from **NCP** and 2(67%) out of 3 **Independent** MLAs have declared criminal cases against themselves in their affidavits.
- Party wise MLAs with serious criminal cases:** 12(12%) out of 99 MLAs from **BJP**, 17 (22%) out of 77 MLAs from **INC**, 1 (50%) out of 2 MLAs from **Bhartiya Tribal Party**, 1(100%) MLA from **NCP** and 2(67%) out of 3 **Independent** MLAs have declared serious criminal cases against themselves in their affidavits.




Figure: Party wise percentage of MLAs with declared criminal cases




Figure: Share of wealth among MLAs

- **Share of wealth among MLAs :** The share of wealth amongst MLAs in Gujarat assembly elections 2017 as follows:

- **Crorepatis MLAs:** Out of the **182** newly elected MLAs, **141 (77%)** are crorepatis. Out of **182** MLAs analysed during **Gujarat 2012 assembly elections**, **134 (74%)** MLAs were crorepatis.




Figure: Comparision of crorepati MLAs: 2012 Vs 2017

- **Partywise crorepati MLAs:** **84 (85%)** out of 99 MLAs from **BJP**, **54 (70%)** out of 77 MLAs from **INC**, **2(100%)** MLAs from **Bhartiya Tribal Party** and **1(100%)** MLA from **NCP** have declared assets valued more than **Rs 1 crore**.




Figure: Party Wise Percentage of Crorepatis MLAs

- Average assets:** The average of assets per MLA in the Gujarat 2017 assembly elections is **Rs. 8.46 crores**, In 2012, the average assets MLAs analyzed was **Rs 8.03 crores**.
- Party wise average assets:** The average assets per MLA for **99 BJP** MLAs analysed is **Rs 10.64 crores**, **77 INC** MLAs have average assets of **Rs 5.85 crores** , **2 Bhartiya Tribal Party** MLAs have average assets worth **Rs. 2.71 crores** and **3 Independent** MLAs have average assets of **Rs. 53.86 lakhs**.

COMPARATIVE ANALYSIS OF ASSETS OF RE-ELECTED MLAS

- **Number of re-elected MLAs:** Number of re-elected MLAs analysed in the assembly elections of 2017 is 81.
- **Average assets of re-elected MLAs in 2012:** The average assets of re-elected MLAs in 2012 was **Rs 7.41 crores**
- **Average assets of re-elected MLAs in 2017:** The average assets of re-elected MLAs in 2017 is **Rs 10.71 crores**.
- **Average growth in assets of re-elected MLAs from 2012 to 2017:** The growth in average assets of re-elected MLAs is **Rs 3.30 crores i.e. by 45%**.

OTHER BACKGROUND DETAILS

- **Education Details of MLAs:** 96 (53%) MLAs have declared their education qualification to be between **5th pass and 12th pass** while 69 (38%) MLAs have declared having an educational qualification of **graduate or above**. There are 7 MLAs who have declared themselves as just **literates** while there is 1 MLA who is **illiterate**.
- **Age details of MLAs:** 21 (12%) MLAs have declared their age to be between **25 and 40 years** while 121 (66%) MLAs have declared their age to be between **41 and 60 years**. There are 40(22%) MLAs who have declared their age to be between **61 to 80 years**.
- **Gender details of MLAs:** Out of 182 MLAs, 13 (7%) MLAs are women. In 2012, out of 182 MLAs, 16 (9%) MLAs were women.




Figure: MLAs who have/have not declared sources of self-income




Figure: Party wise MLAs who have not declared their source of self-income






Figure: Party Wise – Women MLAs
