## पृष्ठभूमि

कानून आयोग की मार्च 2017<sup>1</sup> की रिपोर्ट संख्या 267 के अनुसार भारत में किसी भी कानून में भड़काऊ भाषण को परिभाषित नहीं किया गया है। हालांकि, कुछ कानूनों में कानूनी प्रावधान भाषण की स्वतंत्रता के अपवाद के रूप में भाषण के चयन रूपों को प्रतिबंधित करते हैं। भड़काऊ भाषण का प्रयोग हमेशा अभिव्यक्ति के लिए किया जाता है जो अपमानजनक है, जो किसी की जाति, धर्म, जन्म स्थान, निवास, क्षेत्र, भाषा, जाति या समुदाय, यौन अभिविन्यास या व्यक्तिगत दृढ़ विश्वास जैसी विशेषताओं द्वारा पहचाने गए समूहों के खिलाफ हिंसा, घृणा या भेदभाव को उत्तेजित करता है

राजनीतिक दल भड़काऊ भाषण से सम्बन्धित मामलों में आरोपी उम्मीदवारों को टिकट देकर विशेष रूप ऐसी परिस्थितियों को बढ़ावा देते हैं जो धार्मिक समूहों के बीच शत्रुता को बढ़ावा देना और धार्मिक भावनाओं को अपमानित करने के इरादे से कार्य करने वाली घटनाओं को जन्म देते हैं। राजनीतिक दलों ने ऐसी परिस्थितियों को बढ़ावा दिया है जो सांप्रदायिक दंगों और लोगों के विभिन्न समूहों के बीच हिंसा जैसी घटनाओं का कारण बनती हैं। एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और नेशनल इलेक्शन वॉच ने सभी मौजूदा सांसदों और विधायकों के स्वयं घोषित शपथपत्रों का विश्लेषण किया है। विश्लेषण से पता चलता है कि हमारे कई सांसदों और विधायकों ने अपने खिलाफ भड़काऊ भाषण से सम्बन्धित मामलों की घोषणा की है। यह विश्लेषण उम्मीदवारों और सांसदों/विधायकों द्वारा घोषित हलफनामों पर आधारित है जो कि उनके द्वारा पिछले चुनाव में भाग लेने से पहले जमा किये गये थे।

कानून आयोग की रिपोर्ट संख्या 267 भड़काऊ भाषण के अनुसार निम्नलिखित आईपीसी और आरपीए अनुभाग भड़काऊ भाषण से सम्बन्धित हैं:

### आईपीसी के तहत प्रावधान

- धारा 153A : धर्म, मूलवंश, जन्म-स्थान, निवासस्थान, भाषा इत्यादि के आधारों पर विभिन्न समूहों के बीच शत्रुता का संप्रवर्तन और सौहार्द्र बने रहने पर प्रतिकूल प्रभाव डालने वाले कार्य करना।
- धारा 153B : राष्ट्रीय अखण्डता पर प्रतिकूल प्रभाव डालने वाले लांछन, प्राख्यान।
- धारा 295A : विमर्शित और विद्वेषपूर्ण कार्य जो किसी वर्ग के धर्म या धार्मिक विश्वासों का अपमान करके उसकी धार्मिक भावनाओं को आहत करने के आशय से किये गये हों।
- धारा 298 : धार्मिक भावनाओं को ठेस पहुँचाने के विमर्शित आशय से शब्द उच्चारित करना आदि।
- धारा 505(1) और (2) : किसी भी बयान, अफवाह या रिपोर्ट के प्रकाशन के कारण विभिन्न समुदायों के बीच शत्रुता और घृणा उत्पन्न होना।

### जन प्रतिनिधित्व अधिनियम, 1951 के तहत प्रावधान

- धारा 8 : अगर कोई व्यक्ति भाषण और अभिव्यक्ति की स्वतंत्रता के अवैध उपयोग के लिए कृत्यों में शामिल होने के लिए दोषी ठहराया जाता है, तो उसके चुनाव लड़ने पर रोक लगाना।
- धारा 123(3A) और धारा 125 : चुनावी प्रक्रिया में विभिन्न धर्म, जाति, समुदाय या भाषा के आधार पर आपसी मनमुटाव या शत्रुता को प्रतिबंधित करना।

## सिफारिशें

1. एडीआर कानून आयोग की रिपोर्ट की निम्नलिखित सिफारिशों का समर्थन करता है:
  - a. राजनीतिक दलों और उम्मीदवारों के मार्गदर्शन के लिए भारत के निर्वाचन आयोग द्वारा दिए गए आचार संहिता को आरपीए, 1951 की धारा 123 के उपधारा (3A) के संदर्भ में संशोधित किया जाना चाहिए। संहिता यानी सामान्य आचरण को स्पष्ट रूप से एक प्रावधान प्रदान करना चाहिए जो किसी उम्मीदवारों या उसके एजेंट या किसी अन्य व्यक्ति द्वारा दिया गया भाषण पर प्रतिबंध लगाता है जो धर्म, जाति, समुदाय या भाषा के आधार पर भारत के नागरिकों के विभिन्न वर्गों के बीच शत्रुता या घृणा की भावनाओं को बढ़ावा देता है और किसी उम्मीदवार के चुनाव को प्रतिकूल रूप से प्रभावित करता है।
  - b. भड़काऊ भाषण, अभिव्यक्ति की स्वतंत्रता के लिए जटिल चुनौतियों खड़ी करता है। इसलिए इस मुद्दे को हल करने के लिए आईपीसी में नए प्रावधानों को शामिल करने की आवश्यकता है। आईपीसीए 1860 और आपराधिक प्रक्रिया संहिता, 1973 में धारा 505 आईपीसी के कुछ मामलों में हिंसा को उत्तेजित करने पर नए प्रावधानों को जोड़कर और सीआरपीसी पहली अनुसूची में संशोधन करके नए प्रावधानों को जोड़कर संशोधन किया जाना चाहिए।
2. एडीआर का मानना है कि उम्मीदवारों के खिलाफ चुनाव से पहले और दौरान भड़काऊ भाषण देने वाले उम्मीदवारों के खिलाफ सख्त कारवाई की जानी चाहिए। निर्वाचित विधायकों के खिलाफ चुनाव के बाद भी कारवाई की जानी चाहिए, यदि उन्हें भड़काऊ भाषण देने का दोषी पाया जाता है।
3. इंटरनेट जानकारी और राय प्रसारित करने के लिए एक महत्वपूर्ण उपकरण है, हालांकि यह गैरकानूनी भाषण प्रसारित करने के लिए एक मंच के रूप में भी कार्य करता है। राजनीतिक दल गैरकानूनी वक्तव्य के लिए इस माध्यम का दुरुपयोग कर रहे हैं। इसलिए, यह अनुशंसा की जाती है कि ऑनलाइन प्लेटफार्मों पर ऐसे गैरकानूनी बयानों पर निगरानी की जानी चाहिए और यदि व्यक्ति दोषी पाया जाता है, तो उन्हें दंडित किया जाना चाहिए।
4. राजनीतिक दलों को अपने ऊपर गंभीर आपराधिक मामले घोषित करने वाले उम्मीदवारों को टिकट नहीं देना चाहिए।
5. सांसदों और विधायकों के खिलाफ मामलों को फास्ट ट्रैक और समयबद्ध तरीके से किया जाना चाहिए।

- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले सांसदः—** 15 लोक सभा सांसदों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं। किसी भी राज्य सभा सांसद ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित नहीं किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले सांसद—दलवारः—** **BJP** से 10 और **AIUDF, TRS, PMK, AIMIM** और **SHS** प्रत्येक से 1 लोक सभा सांसदों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले विधायकः—** 43 विधायकों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले विधायक—दलवारः—** **BJP** से 17, **TRS** और **AIMIM** प्रत्येक से 5, **TDP** से 3, **INC, AITC, JD(U)** और **SHS** प्रत्येक से 2, **DMK, BSP, SP** प्रत्येक से 1 और 2 निर्दलीय विधायकों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले विधायक—राज्यवारः—** तेलंगाना के 11 विधायकों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं, बिहार के 4, उत्तर प्रदेश के 9, महाराष्ट्र के 4, आन्ध्र प्रदेश और कर्नाटक प्रत्येक से 3, उत्तराखण्ड और पश्चिम बंगाल प्रत्येक से 2 और गुजरात, मध्य प्रदेश, तमिलनाडु, राजस्थान और झारखण्ड प्रत्येक से 1 विधायक ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले राजनीतिक दलों के अध्यक्षः—** राजनीतिक दलों के अध्यक्ष **AIMIM** के असदुद्दीन ओवैसी और **AIUDF** के बदरुद्दीन अजमल ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।
- **भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले केन्द्रीय मंत्रीः—** केन्द्रीय कैबिनेट मंत्री उमा भारती ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।

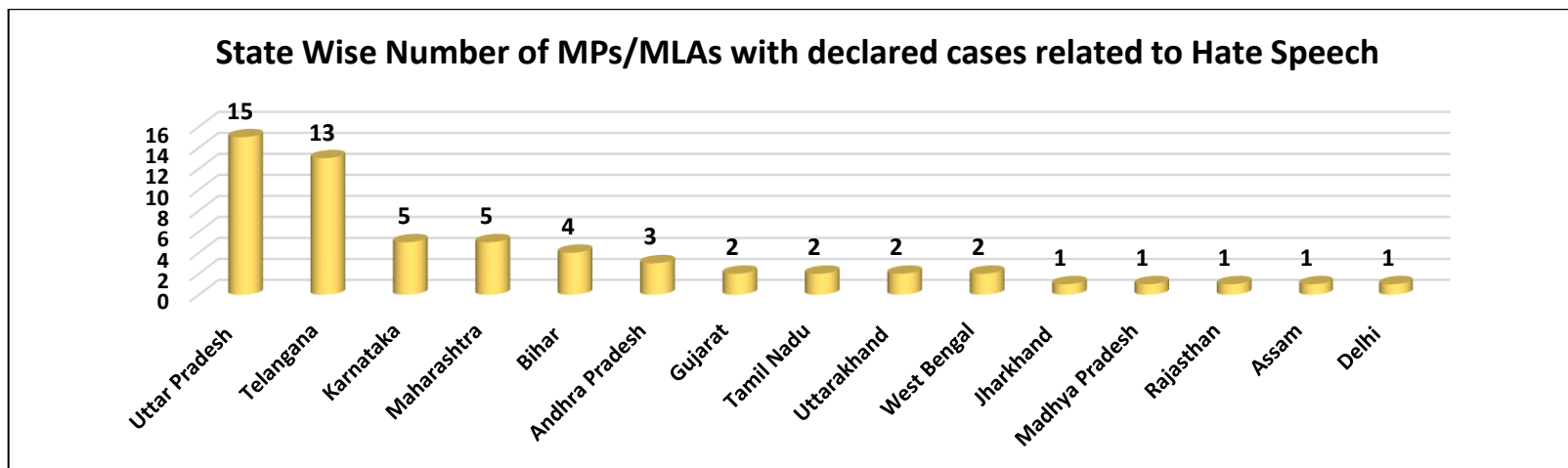

- मान्यता प्राप्त/अमान्यता प्राप्त दलों ने भड़काऊ भाषण से सम्बन्धित मामले घोषित करने वाले उम्मीदवारों को टिकट दिए हैं:- पिछले 5 वर्षों में, 198 उम्मीदवारों ने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं, जिन्होंने विधानसभा, लोक सभा/राज्य सभा के चुनाव लड़े हैं। पिछले 5 वर्षों में, मान्यता प्राप्त दलों ने 141 और अमान्यता प्राप्त दलों ने 29 ऐसे उम्मीदवारों को टिकट दिए हैं, जिन्होंने अपने ऊपर भड़काऊ भाषण से सम्बन्धित मामले घोषित किये हैं।

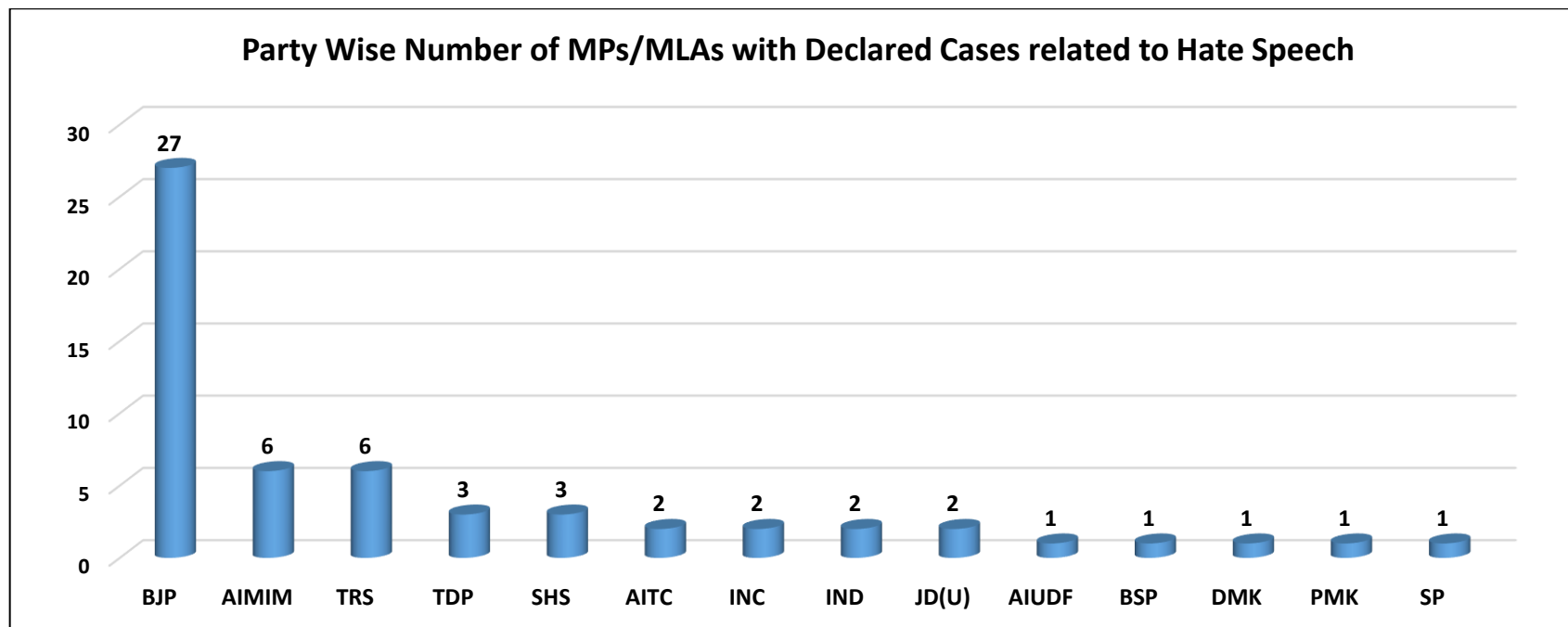
