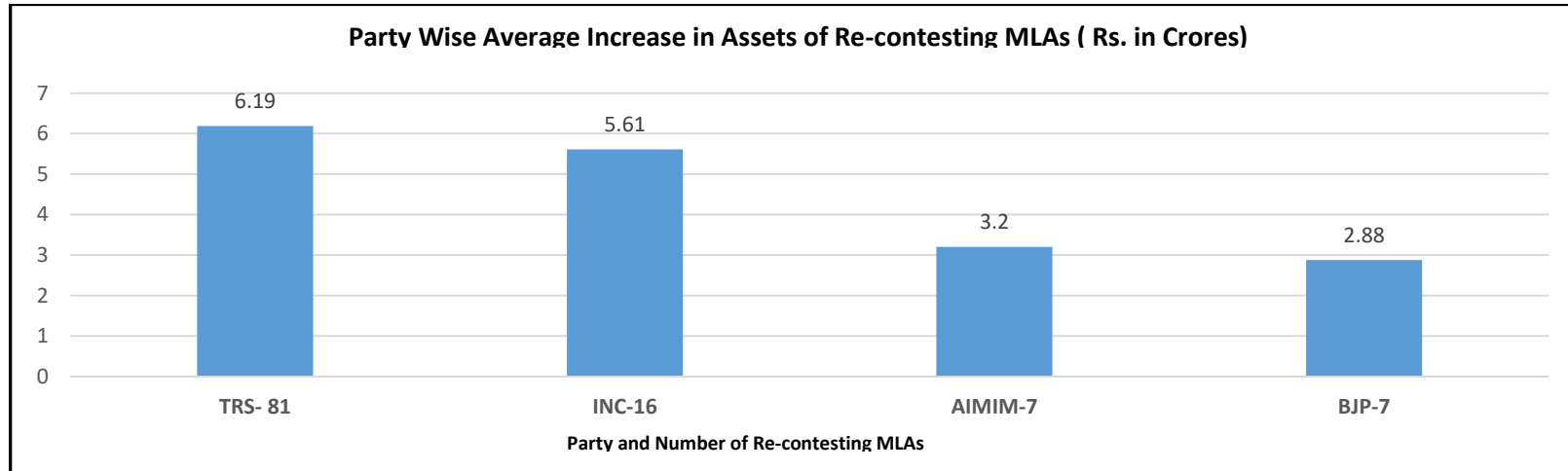


Figure 1: Party Wise Average Increase in Assets of Re-contesting MLAs (Rs.in Crores)
