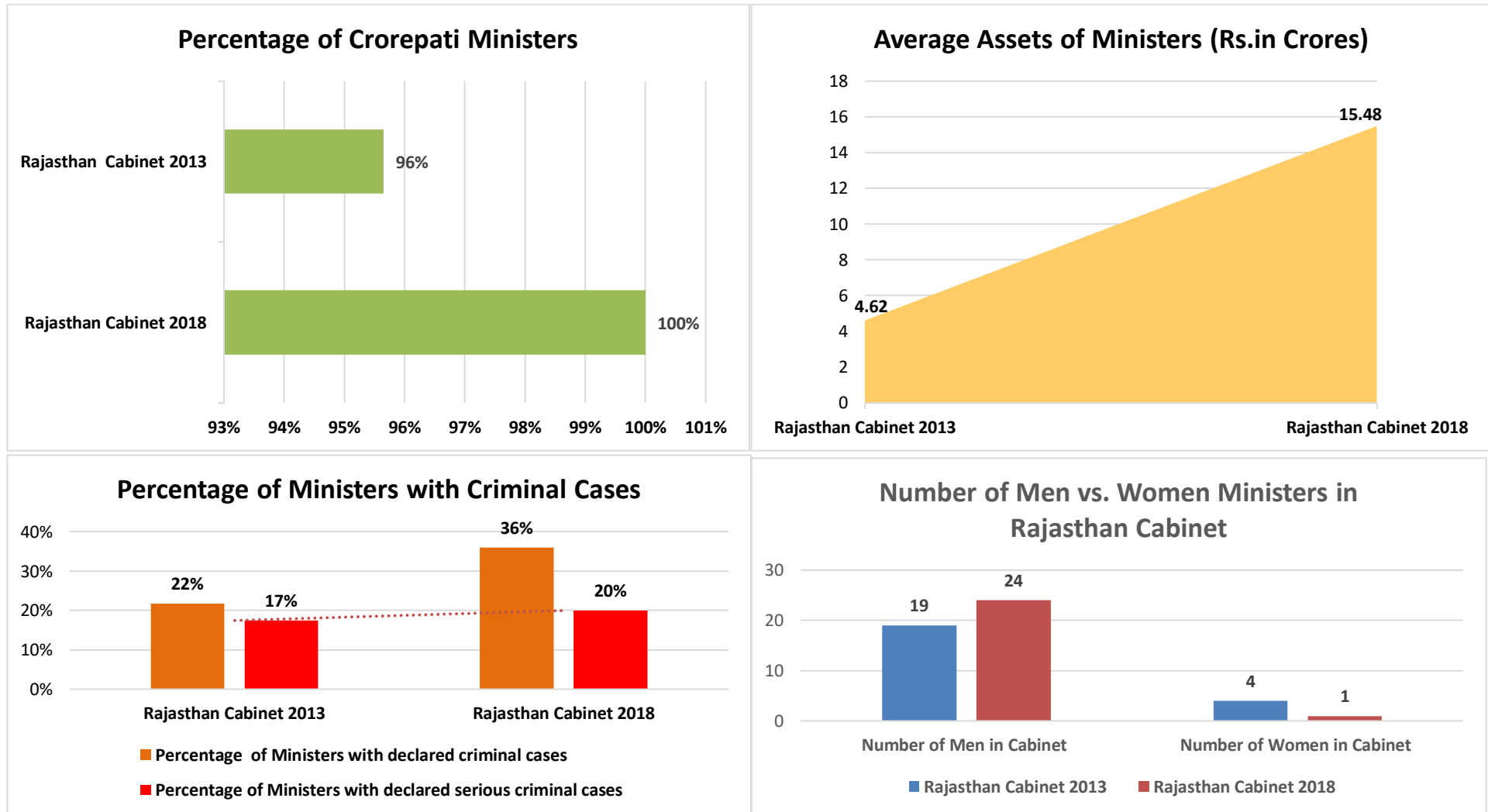

- **Ministers with declared cases related to attempt to murder:** 1 Minister, Ashok of INC who contested from Hindoli Constituency of Bundi district, declared 2 charge related to **attempt to murder** (IPC Section 307).
