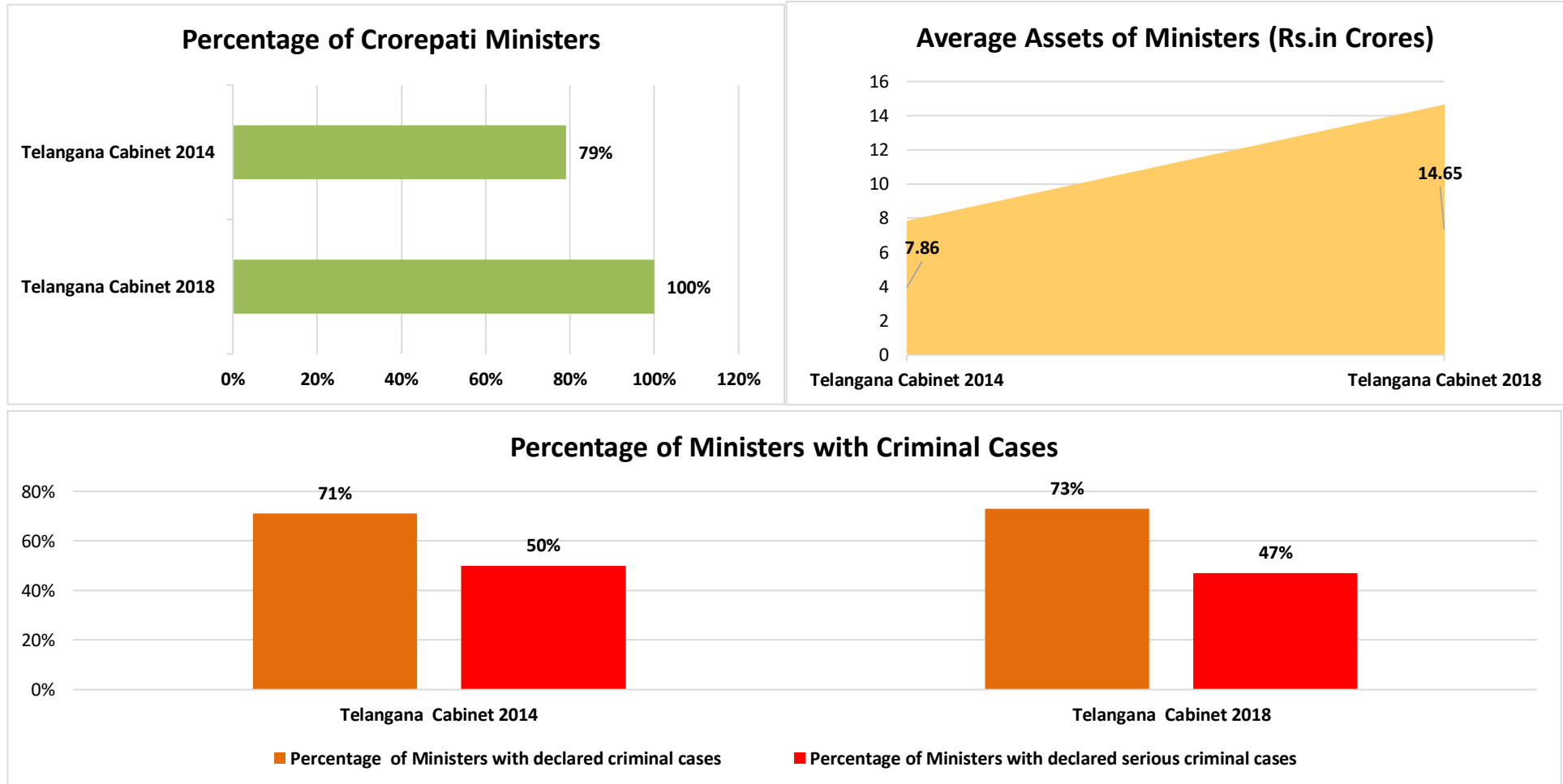

- **Average Assets:** The average assets of 15 ministers analysed is Rs 14.65 crores.
