Lok Sabha 2019 Phase II - Puducherry

The Puducherry Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **17 out of 18** candidates.

One candidate has not been analysed due to the unavailability of his complete affidavit on the ECI website. The details of candidate are given below:

Criminal Background, Financial, Education, Gender and other details of Candidates

- There are 3 (18%) candidates who have declared criminal cases against themselves. Out of these, 2 have declared serious criminal cases against themselves.
- 4(24%) candidates are crorepati.
- The average asset per candidate contesting in the Lok Sabha 2019 from Puducherry is Rs. 3.66 crores.
- There are candidates 9 candidates who have declared liabilities.
- There is only 1 woman candidate contesting in Lok Sabha phase II from Puducherry.
