Summary and Highlights

The Maharashtra Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **320** out of 323 candidates, who are contesting in the **Maharashtra Parliamentary Elections for Phase IV**, being held on 29th April 2019. The 17 parliamentary constituencies for which these candidates are contesting are **Nandurbar**, **Dhule**, **Dindori**, **Nashik**, **Palghar**, **Bhiwandi**, **Kalyan**, **Thane**, **Mumbai North**, **Mumbai North West**, **Mumbai North East**, **Mumbai North Central**, **Mumbai South**, **Maval**, **Shirur** and **Shirdi**. Affidavit of **3** candidates are not analysed due to unavailability of same at the time of making this report.

89(28%) Candidates with Criminal Cases 109 (34%) Crorepati Candidates Average Assets of Candidates

Criminal Background

- <u>Candidates with Criminal Cases:</u> Out of **320** candidates analyzed, **89 (28%)** candidates have declared criminal cases against themselves.
- <u>Candidates with Serious Criminal Cases:</u> Out of **320** candidates analysed, **64 (20%)** have declared serious criminal cases against themselves.
- <u>Candidates with Declared Convicted Cases:</u> 2 candidates have declared convicted cases against themselves.
- <u>Candidate with case related to Murder:</u> Pavan Chandrakant Pawar contesting on Vanchit Bahujan Aaghadi ticket from Nashik has declared case related to murder against him.
- <u>Candidates with cases related to Attempt to Murder:</u> 3 candidates have declared cases related to attempt to murder against themselves.
- <u>Candidates with cases related to Crime against Women:</u> 10 candidates have declared cases related to crime against women against themselves.

Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- Offences under Prevention of Corruption Act





- Candidates with cases related to Kidnapping: 2candidates have declared cases related to kidnapping against themselves.
- Candidates with cases related to Robbery & dacoity 6 candidates have declared cases related to robbery & dacoity against themselves.
- <u>Candidates with cases related to Communal Disharmony & Hate Speech:</u> 4 candidate have declared cases related to communal disharmony & hate speech against themselves.
- <u>Party wise Candidates with Criminal Cases:</u> 7 (41%) out of 17 candidates from Vanchit Bahujan Aaghadi, 4 (27%) out of 15 candidates from BSP, 7 (70%) out of 10 candidates from Shivsena, 4 (44%) out of 9 candidates from INC, 4 (57%) out of 7 candidates from BJP and 5 (71%) out of 7 candidates from NCP have declared criminal cases against themselves in their affidavits.
- Party wise Candidates with Serious Criminal Cases: 5 (29%) out of 17 candidates from Vanchit Bahujan Aaghadi, 4 (27%) out of 15 candidates from BSP, 4 (40%) out of 10 candidates from Shivsena, 1 (11%) out of 9 candidates from INC, 3 (43%) out of 7 candidates from BJP and 2 (29%) out of 7 candidates from NCP have declared serious criminal cases against themselves in their affidavit.

- Crorepati Candidates: Out of the 320 analyzed candidates, 109 (34%) are crorepatis.
- <u>Party wise Crorepati Candidates:</u> Among the major parties, **10 (100%)** out of 10 candidates from **Shivsena**, 9 **(100%)** out of 9 candidates from **INC**, 7 **(100%)** out of 7 candidates from **BJP**, **6 (35%)** out of 17 candidates from **Vanchit Bahujan Aaghadi** and **6 (40%)** out of 15 candidates from **BSP** have declared assets worth more than Rs. 1 crore.

- <u>Party wise average assets:</u> Among major parties, the average assets per candidate for **15 BSP** candidates is **Rs 1.22 crores, 17 Vanchit Bahujan Aaghadi** candidates is **Rs. 9.87 crores,** 7 **BJP** candidates is **Rs 17.23 crores, 7 NCP** candidates is **Rs. 21.09 crores, 10 Shivsena** candidates is **Rs 20.14 crores** and 9 **INC** candidates have average assets worth **Rs 40.02 crores**.

- Low asset candidates: There are 44 candidates (excluding zero asset candidates) who declated their total assets below Rs. 2 lakhs in this election.
- Average Liabilities: The average of liabilities per candidate contesting in the Maharashra Parliamentary Elections-Phase IV is Rs. 61 lakhs.





- <u>Party wise average liabilities:</u> Among major parties, the average liability per candidate for **7 BJP** candidates is **Rs. 66 lakhs**, **9 INC** candidates is **Rs 7.92** crores, **7 NCP** candidates is **Rs 4.19 crores** and **10 Shivsena** candidates is **Rs 1.88 crores**.
