## Summary and Highlights

The **Odisha Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **all 21** winners in the Lok Sabha elections 2019 for Odisha.

### Criminal Background

- **Winners with Criminal Cases:** Out of **21** winners analyzed, **6 (29%)** winners have declared criminal cases against themselves. Out of **21** winners analysed during **Lok Sabha 2014 elections**, **4 (19%)** winners had declared criminal cases against themselves
- **Winners with Serious Criminal Cases:** **4(19%)** winners have declared serious criminal cases. Out of **21** winners analysed during **Lok Sabha 2014 elections**, **2 (10%)** winners had declared serious criminal cases against themselves.

#### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
