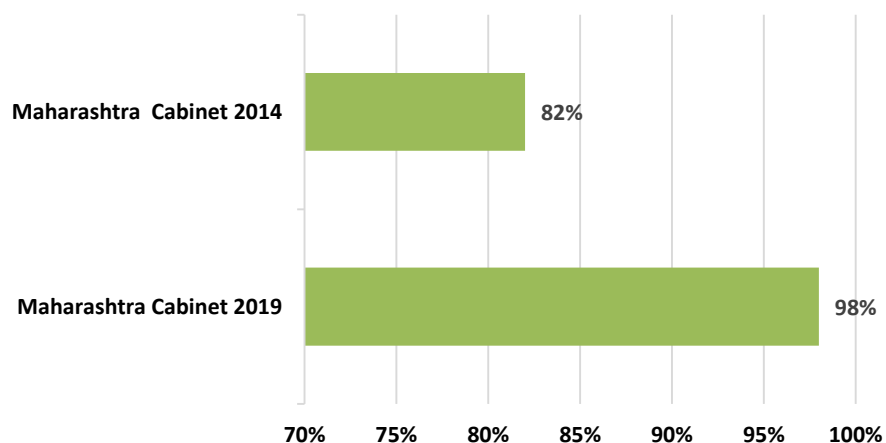

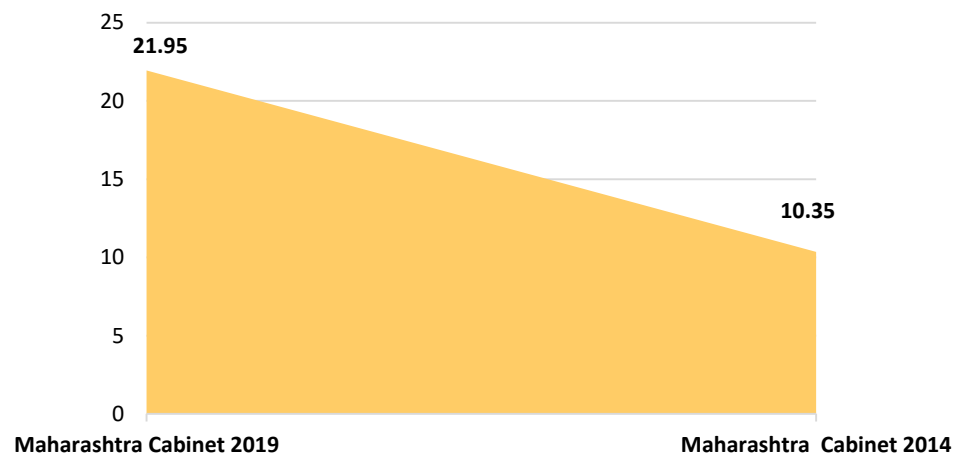

Maharashtra's Cabinets 2014 vs. 2019

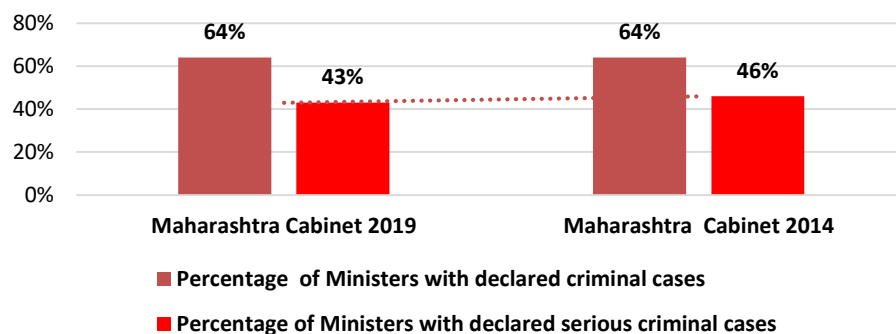
Percentage of Crorepati Ministers



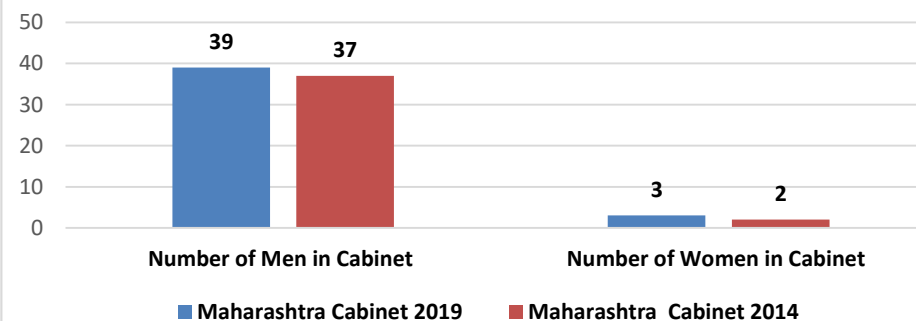
Average Assets of Ministers (Rs.in Crores)

- **Ministers' Education:** 18(43%) ministers have declared their educational qualification to be between 8th- 12th pass while 22 (52%) ministers have declared having an educational qualification of **graduate or above**.
- **Ministers' Age:** A total of 17(40%) ministers have declared their age to be between 25-50 years while 25(60%) ministers have declared their age to be between 51-80 years.
- **Women Ministers:** Out of 42 ministers, only 3 are women.
