**सर्वोच्च न्यायालय के आदेशों के अनुपालन में चुनाव आयोग के निर्देशों (दिनांक 6 मार्च, 2020 और 10 अक्टूबर, 2018 के पत्रों में) में दिनांक 25 सितंबर, 2018 और 13 फरवरी, 2020 को उम्मीदवारों और राजनीतिक दलों द्वारा आपराधिक मामलों का प्रकाशन और रिकॉर्डिंग सहित चयन करने का कारण बताना होगा।**

**13 फरवरी, 2020 को सर्वोच्च न्यायालय के निर्देश के अनुपालन में भारत निर्वाचन आयोग के पत्र दिनांक 6 मार्च, 2020:**

1. केन्द्र और राज्य के चुनाव स्तर पर राजनीतिक दलों के लिए अनिवार्य है कि वे अपनी वेबसाइट पर लंबित आपराधिक मामलों वाले उम्मीदवारों सहित अपराधों की प्रकृति, सम्बन्धित विवरण जैसे क्या आरोप तथ किए गए हैं, सम्बन्धित न्यायालय, मामला संख्या आदि के बारे में विस्तृत जानकारी प्रदान करें।
2. राजनीतिक दलों को भी ऐसे चयन का कारण देना होगा और आपराधिक छवि के बिना अन्य व्यक्तियों को उम्मीदवारों के रूप में क्यों नहीं चुना जा सकता है।
3. चयन सम्बन्धित कारण उम्मीदवारों की योग्यता, उपलब्धियों और योग्यता के संदर्भ में होंगे, ना कि केवल चुनाव में जीतने की क्षमता।
4. यह जानकारी भी इसमें प्रकाशित की जाएगी: (a) एक स्थानीय समाचार पत्र और एक राष्ट्रीय समाचार पत्र; (b) फेसबुक और ट्विटर सहित राजनीतिक दलों के आधिकारिक सोशल मीडिया प्लेटफार्म पर।
5. ये विवरण उम्मीदवार के चयन के 48 घंटे के भीतर या नामांकन दाखिल करने की पहली तारीख से कम से कम दो सप्ताह पहले प्रकाशित किए जाएंगे, जो भी पहले हो।
6. सम्बन्धित राजनीतिक दल उक्त उम्मीदवार के चयन के 72 घंटे के भीतर चुनाव आयोग के साथ इन निर्देशों के अनुपालन की एक रिपोर्ट प्रस्तुत करेगा।
7. यदि कोई राजनीतिक दल चुनाव आयोग के साथ ऐसी अनुपालन रिपोर्ट प्रस्तुत करने में विफल रहता है, तो चुनाव आयोग सर्वोच्च न्यायालय के नोटिस से सम्बन्धित राजनीतिक दल द्वारा इस तरह के गैर-अनुपालन को अदालत के आदेशों/निर्देशों की अवमानना के रूप में लाएगा।

**25 सितंबर, 2018 को सर्वोच्च न्यायालय के निर्देश के अनुपालन में भारत निर्वाचन आयोग के पत्र दिनांक 10 अक्टूबर, 2018:**

## उम्मीदवारों के लिए:

1. चुनाव लड़ने वाले प्रत्येक उम्मीदवार को चुनाव आयोग द्वारा उपलब्ध कराए गए फॉर्म को भरना होगा और इस फॉर्म में आवश्यक रूप से सभी विवरण शामिल होने चाहिए।
2. यह उम्मीदवार के खिलाफ लंबित आपराधिक मामलों के संबंध में, मोटे अक्षरों में बताएगा।
3. यदि कोई उम्मीदवार किसी विशेष दल के टिकट पर चुनाव लड़ रहा है, तो उसे अपने खिलाफ चल रहे आपराधिक मामलों के बारे में पार्टी को सूचित करना आवश्यक है।

## राजनीतिक दलों के लिए:


1. सम्बन्धित राजनीतिक दल को अपनी वेबसाइट पर आपराधिक छवि रखने वाले उम्मीदवारों से सम्बन्धित उपरोक्त जानकारी देने के लिए बाध्य किया जाएगा।

## राजनीतिक दल और उम्मीदवार दोनों के लिए:

1. राजनीतिक दल और उम्मीदवार दोनों के लिए आपराधिक छवि वाले उम्मीदवारों के शपथपत्र वापस लेने की अंतिम तारीख और मतदान की तारीख से दो दिन पहले तक तीन अलग-अलग तिथियों पर घोषणा पत्र प्रकाशित करना अनिवार्य है। इस मामले को कम से कम 12 के अक्षर आकार में प्रकाशित किया जाना चाहिए और समाचार पत्रों में उपयुक्त रूप से रखा जाना चाहिए। टीवी चैनलों में घोषणा के मामले में, मतदान के समापन के लिए निर्धारित घंटे के समाप्त होने से 48 घंटे पहले पूरा किया जाना चाहिए। उम्मीदवारों और राजनीतिक दलों द्वारा इस तरह की घोषणा के लिए भारत के निर्वाचन आयोग द्वारा प्रदान किया गया एक प्रारूप है।
2. उम्मीदवार/राजनीतिक दलों द्वारा निर्देश का पालन नहीं करने की स्थिति में, निर्वाचन अधिकारी उन्हें एक लिखित अनुस्मारक देंगे और चुनाव के अंत तक अनुपालन न करने की स्थिति में, निर्वाचन अधिकारी राज्य के मुख्य चुनाव अधिकारी को रिपोर्ट करेंगे जो भारत के निर्वाचन आयोग को सूचित करेगा। भारत निर्वाचन आयोग मामले में अंतिम निर्णय लेगा। उम्मीदवारों और राजनीतिक दलों को इस तरह के अनुस्मारक के मानक प्रारूप को भी पत्र में संलग्न किया गया है।
3. सभी राजनीतिक दल; मान्यता प्राप्त दल और गैर-मान्यता प्राप्त दल यह कहते हुए सम्बन्धित राज्य के मुख्य निर्वाचन अधिकारी को एक रिपोर्ट प्रस्तुत करेंगे कि उन्होंने निर्देशों से युक्त पेपर कटिंग के साथ निर्देशों और संलग्न की आवश्यकताओं को पूरा किया है। यह चुनाव पूरा होने के 30 दिनों के भीतर किया जाएगा। इसके बाद, अगले 15 दिनों के भीतर, मुख्य निर्वाचन अधिकारी को भारत के चुनाव निर्वाचन आयोग को एक रिपोर्ट प्रस्तुत करनी चाहिए, जिसमें अनुपालन की पुष्टि की जाए और बकायेदारों के मामलों को इंगित किया जाए।

## रिपोर्ट के मुख्य अंश

असम इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने असम विधानसभा चुनाव 2021 के तीसरे चरण में चुनाव लड़ने वाले सभी 337 उम्मीदवारों के शपथपत्रों का विश्लेषण किया है जो निम्नलिखित 40 निर्वाचन क्षेत्रों से चुनाव लड़ रहे हैं।



## आपराधिक पृष्ठभूमि

- ☞ **उम्मीदवारों द्वारा घोषित आपराधिक मामले**:- 337 में से 60 (18 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ **उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले**:- 45 (13 प्रतिशत) उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।


1. पांच साल या उससे अधिक सजा वाले अपराध
2. गैर ज़मानती अपराध
3. चुनाव से सम्बन्धित अपराध (धारा 171 अथवा रिश्वतखोरी)
4. सरकारी खजाने को नुकसान पहुंचाने से सम्बन्धित अपराध
5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)

- ☞ **उम्मीदवारों द्वारा घोषित आपराधिक मामले—दलवार:** INC के 24 में से 14 (58 प्रतिशत), AIUDF के 12 में से 5 (42 प्रतिशत), BJP के 20 में से 5 (25 प्रतिशत), Bodoland Peoples Front के 8 में से 2 (25 प्रतिशत), JD(U) के 19 में से 2 (11 प्रतिशत) और AGP और Assam Jatiya Parishad प्रत्येक से एक उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ **उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले—दलवार:** INC के 24 में से 13 (54 प्रतिशत), AIUDF के 12 में से 5 (42 प्रतिशत), BJP के 20 में से 4 (20 प्रतिशत) और AGP और Assam Jatiya Parishad प्रत्येक से एक उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।

- ☞ **महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले उम्मीदवार:** 6 उम्मीदवारों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं।
- ☞ **हत्या से सम्बन्धित मामले घोषित करने वाले उम्मीदवार:** 3 उम्मीदवारों ने अपने ऊपर हत्या (आईपीसी-302) से सम्बन्धित मामले घोषित किये हैं।
- ☞ **हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले उम्मीदवार:** 5 उम्मीदवारों ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामले घोषित किये हैं।
- ☞ **\*संवेदनशील निर्वाचन क्षेत्र:** असम विधानसभा चुनाव 2021 के तीसरे चरण में 40 में से 8 (20 प्रतिशत) संवेदनशील निर्वाचन क्षेत्र हैं, जहाँ 3 या उससे अधिक उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।  
(\*संवेदनशील निर्वाचन क्षेत्र वे हैं जहाँ 3 या 3 से अधिक ऐसे उम्मीदवार हैं जिन्होंने अपने ऊपर आपराधिक मामले घोषित किये हैं।)
- ☞ असम विधानसभा चुनाव के तीसरे चरण में उम्मीदवारों के चयन में राजनीतिक दलों पर सर्वोच्च न्यायालय के निर्देशों का कोई प्रभाव नहीं पड़ा है क्योंकि उन्होंने फिर से आपराधिक मामलों वाले लगभग 18 प्रतिशत उम्मीदवारों को टिकट देने की अपनी पुरानी प्रथा का पालन किया है। असम के तीसरे चरण में चुनाव लड़ने वाले सभी प्रमुख दलों ने अपने ऊपर आपराधिक मामले घोषित करने वाले 25 प्रतिशत से 58 प्रतिशत उम्मीदवारों को टिकट दिए हैं। सर्वोच्च न्यायालय ने 13 फरवरी, 2020 के अपने निर्देशों में विशेष रूप से राजनीतिक दलों को आपराधिक छवि वाले उम्मीदवारों को चुनने व साफ छवि वाले उम्मीदवारों को टिकट नहीं देने के कारण बताने का निर्देश दिया था। इन अनिवार्य दिशानिर्देशों के अनुसार, ऐसे चयन का कारण सम्बन्धित उम्मीदवार की योग्यता, उपलब्धियों और योग्यता के संदर्भ में होना चाहिए। हाल ही में अक्टूबर, 2020 में हुए बिहार विधानसभा चुनावों के दौरान, यह देखा गया कि राजनीतिक दलों द्वारा दिए गए ऐसे निराधार और आधारहीन कारण, जैसे व्यक्ति की लोकप्रियता, अच्छे सामाजिक कार्य, राजनीति से प्रेरित मामले आदि। यह दागी पृष्ठभूमि वाले उम्मीदवारों को टिकट देने के लिए ठोस कारण नहीं हैं। यह आंकड़े स्पष्ट रूप से दिखाते हैं कि राजनीतिक दलों को चुनाव प्रणाली में सुधार करने में कोई दिलचस्पी नहीं है और हमारे लोकतंत्र में कानून तोड़ने वाले उम्मीदवार जीतने के बाद कानून बनाने वाले विधायक बन जाते हैं।



- ☞ **औसतन संपत्ति–दलवार:** मुख्य दलों में **BJP** के 20 उम्मीदवारों की औसतन संपत्ति ₹ 4.07 करोड़ है। **Bodoland Peoples Front** के 8 उम्मीदवारों की औसतन संपत्ति ₹ 4.05 करोड़, **INC** के 24 उम्मीदवारों की औसतन संपत्ति ₹ 3.92 करोड़, **Assam Jatiya Parishad** के 22 उम्मीदवारों की औसतन संपत्ति ₹ 3.58 करोड़, **AIUDF** के 12 उम्मीदवारों की औसतन संपत्ति ₹ 3.40 करोड़, **AGP** के 13 उम्मीदवारों की औसतन संपत्ति ₹ 2.90 करोड़ और **SUCI(C)** के 8 उम्मीदवारों की औसतन संपत्ति ₹ 16.75 लाख हैं।

- ☞ शैक्षिक योग्यता: 132 (39 प्रतिशत) उम्मीदवारों ने अपनी शैक्षिक योग्यता 5वीं और 12वीं के बीच घोषित की हैं, जबकि 199 (59 प्रतिशत) उम्मीदवारों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज्यादा घोषित की हैं। 4 उम्मीदवारों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की हैं। 1 उम्मीदवार ने अपनी शैक्षिक योग्यता साक्षर और 1 उम्मीदवार ने अपनी शैक्षिक योग्यता असाक्षर घोषित की हैं।
- ☞ उम्मीदवारों को आयु: 104 (31 प्रतिशत) उम्मीदवारों ने अपनी आयु 25 से 40 वर्ष के बीच घोषित की हैं, जबकि 191 (57 प्रतिशत) उम्मीदवारों ने अपनी आयु 41 से 60 वर्ष के बीच घोषित की हैं। 42 (12 प्रतिशत) उम्मीदवारों ने अपनी आयु 61 से 80 वर्ष के बीच घोषित की हैं।
- ☞ महिला प्रतिनिधित्व: असम विधानसभा चुनाव 2021 के तीसरे चरण में 25 (7 प्रतिशत) महिला उम्मीदवार चुनाव लड़ रही हैं।

## एडीआर की सिफारिशें

- अपराधीकरण की मौजूदा समस्या को दूर करने के लिए विभिन्न समितियों, नागरिक समाज और नागरिकों द्वारा प्रस्तावित समाधानों पर तुरंत अमल करने की आवश्यकता है। भारत के सर्वोच्च न्यायालय को “न्याय और कानून के नियम” का परम संरक्षक होने के नाते राजनीतिक दलों और राजनेताओं को उनकी इच्छाशक्ति, निंदनीय पूर्वनिर्धारण और आवश्यक कानूनों की अनुपस्थिति के लिए निर्देश देने की आवश्यकता है।
- हत्या, बलात्कार, तस्करी, डकैती, अपहरण आदि जैसे जघन्य अपराधों के लिए दोषी उम्मीदवारों को स्थायी रूप से अयोग्य घोषित कर देना चाहिए।
- चुनाव लड़ने वाले उम्मीदवार जिनके खिलाफ कम से कम 5 वर्ष के कारावास के साथ गंभीर अपराधों के आरोप लगे हैं और जो मामला चुनाव से कम से कम 6 महीने पहले दायर किया गया है, उन्हें अयोग्य घोषित करना चाहिए।
- दागी उम्मीदवारों को मैदान में उतारने वाले राजनीतिक दलों को दी जाने वाली कर में छूट को रद्द कर देना चाहिए।
- तमाम राजनीतिक दलों को सूचना का अधिकार अधिनियम के तहत लाना चाहिए।
- यदि कोई राजनीतिक दल जानबूझकर दागी पृष्ठभूमि वाले उम्मीदवारों को खड़ा करता है तब उसको अपंजीकृत और अमान्य घोषित करना चाहिए।
- राजनीतिक दलों को प्रतिवर्ष अपने पदाधिकारियों के आपराधिक मामलों की जानकारी दर्ज करनी चाहिए और ऐसे रिकॉर्ड जनता के लिए उपलब्ध कराने चाहिए।
- चुनावी शपथपत्रों (फॉर्म 26) में गलत जानकारी देने वाले उम्मीदवारों को अयोग्य घोषित कर देना चाहिए।
- आपराधिक मामलों में आरोपी राजनेताओं के मामलों की सुनवाई सुनिश्चित कर समयबद्ध तरीके से निष्कर्ष निकाला जाना चाहिए।
- 23 सितंबर, 2013 को सर्वोच्च न्यायालय के नोटा के फैसले पर अगला कदम उठाना आवश्यक है। (a) यदि नोटा को किसी भी उम्मीदवार की तुलना में अधिक वोट मिलते हैं, तो किसी भी उम्मीदवार को निर्वाचित घोषित नहीं किया जाना चाहिए, और दुबारा चुनाव होने चाहिए; (b) यदि किसी निर्वाचन क्षेत्र में सभी उम्मीदवारों को नोटा से कम वोट मिलते हैं तो उन्हें दुबारा चुनाव लड़ने की अनुमति नहीं दी जानी चाहिए।




