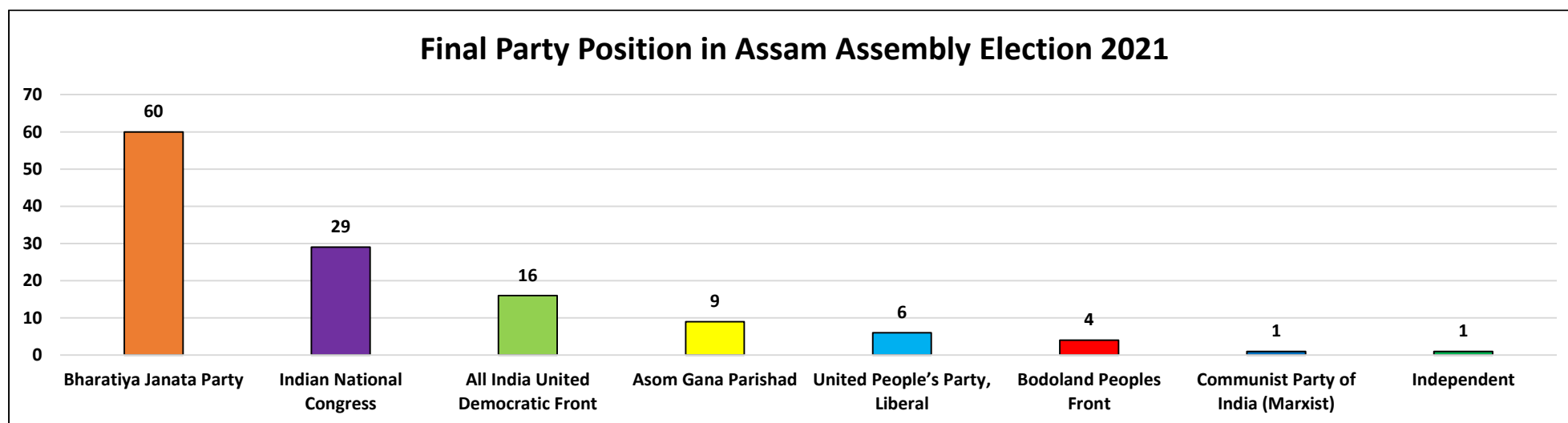

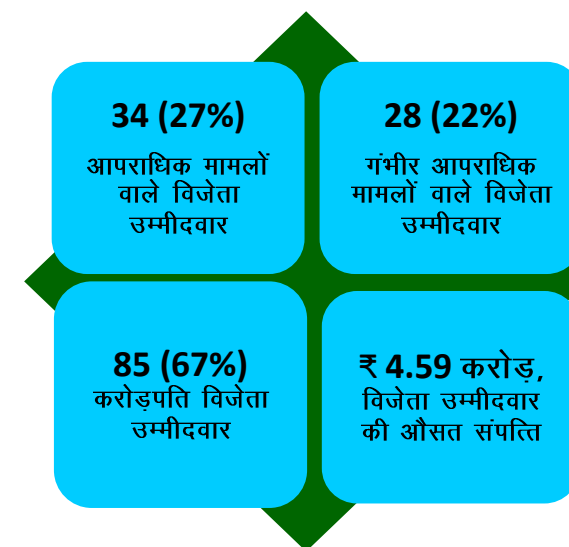

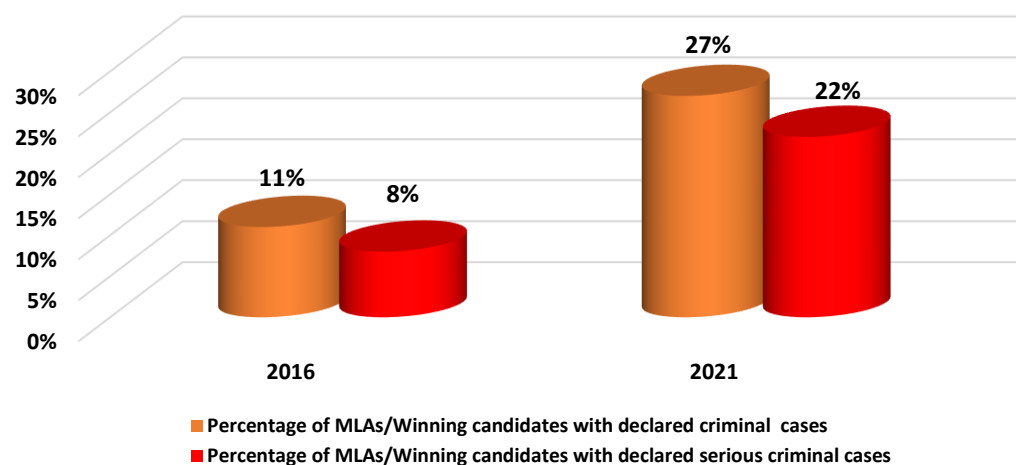

आपराधिक पृष्ठभूमि

- विजेता उम्मीदवारों द्वारा घोषित आपराधिक मामले:— 126 में से 34 (27 प्रतिशत) विजेता उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। असम विधानसभा चुनाव 2016 में 126 में से 14 (11 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- विजेता उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले:— 28 (22 प्रतिशत) विजेता उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं, जिनमें हत्या, हत्या का प्रयास, महिलाओं के ऊपर अत्याचार इत्यादि से सम्बन्धित अपराध शामिल हैं।

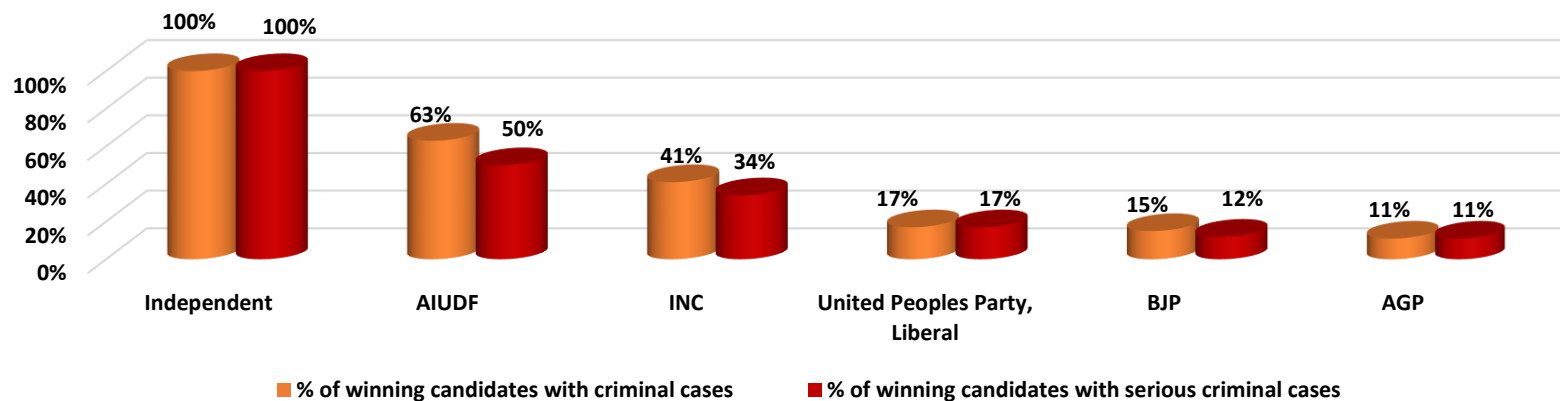

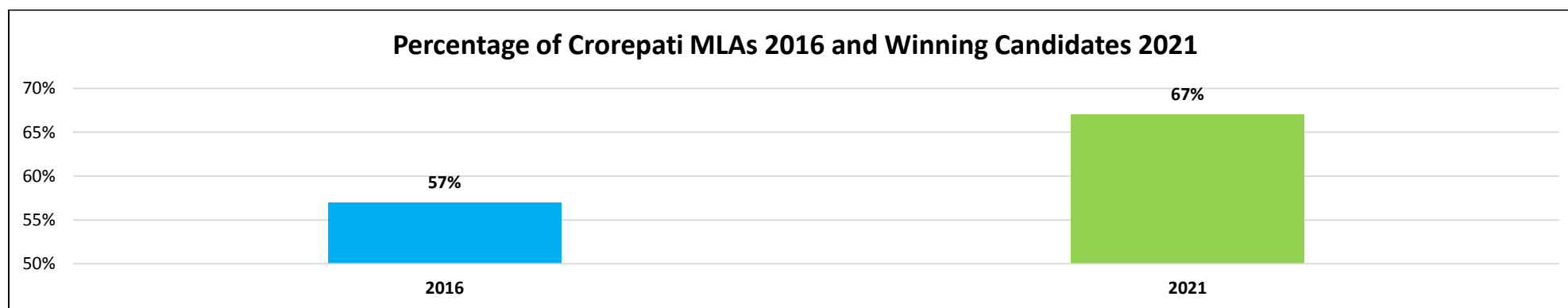
Party Wise Percentage of Winning Candidates with Criminal Cases

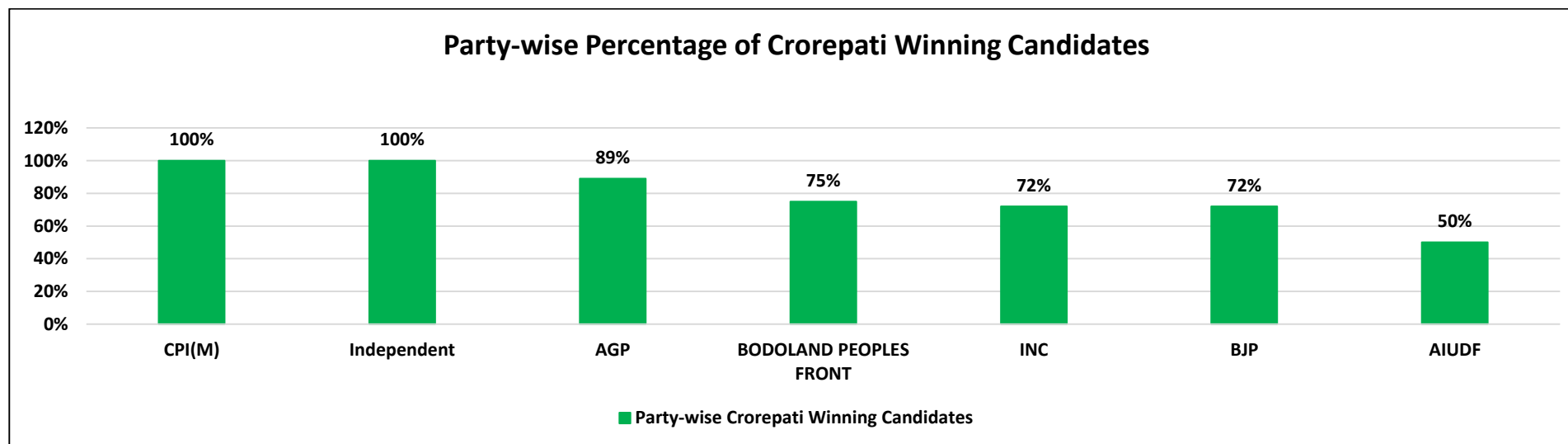

Share of Wealth Among Winning Candidates



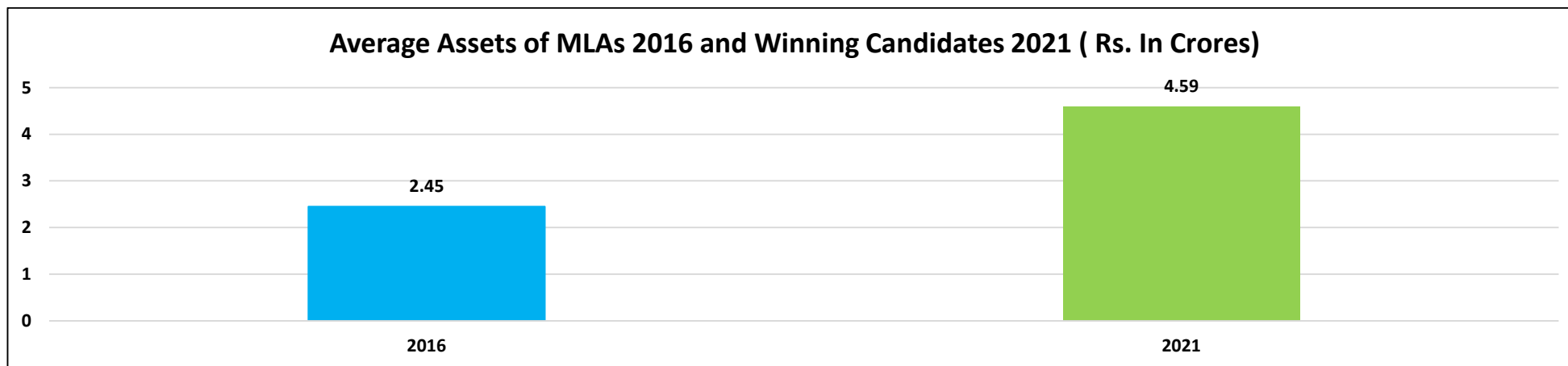

- ☞ शैक्षिक योग्यता: 34 (27 प्रतिशत) विजेता उम्मीदवारों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की है, जबकि 91 (72 प्रतिशत) विजेता उम्मीदवारों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की है। 1 विजेता उम्मीदवार ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की है।
- ☞ विजेता उम्मीदवारों की आयु: 54 (43 प्रतिशत) विजेता उम्मीदवारों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की है, जबकि 72 (57 प्रतिशत) विजेता उम्मीदवारों ने अपनी आयु 51 से 70 वर्ष के बीच घोषित की है।

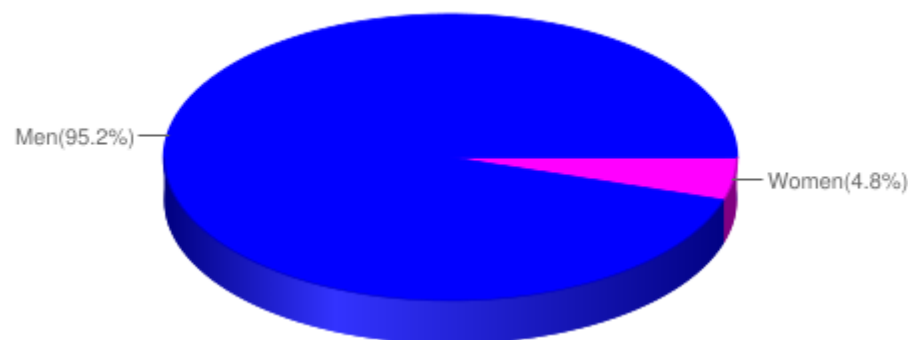
