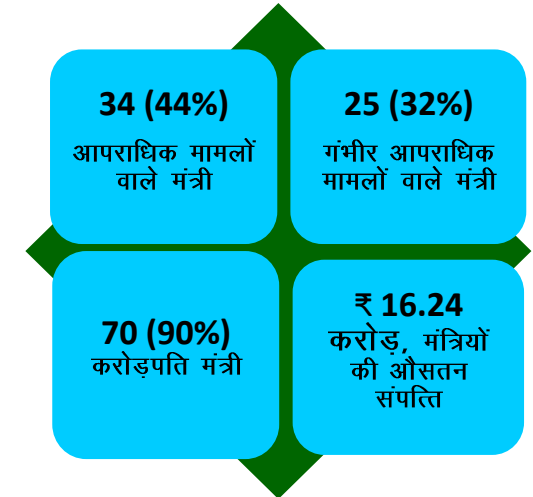

रिपोर्ट के मुख्य अंश

नेशनल इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने लोक सभा 2019, वर्तमान राज्य सभा और विधानसभा चुनाव से प्रधान मंत्री सहित सभी 78 मंत्रियों के शपथपत्रों का विश्लेषण किया।

हाल ही में मंत्रिमंडल विस्तार में, 43 नए मंत्रियों को मंत्रिमंडल में शामिल किया गया। यह रिपोर्ट मंत्रिमंडल के आपराधिक, वित्तीय और शिक्षा पृष्ठभूमि विवरण पर केंद्रित है। नए मंत्रियों की सूची इस प्रकार है;
