Summary and Highlights

Association for Democratic Reforms (ADR) and Uttarakhand Election Watch have analyzed the criminal, financial and other background details of **65** out of **70** sitting MLAs. In current assembly 5 seats are vacant. This analysis is based on the affidavits submitted by the candidates prior to the 2017 Assembly elections and bye elections conducted thereafter.


Recently two BJP MLAs namely Yashpal Arya and Sanjeev Arya, resigned from BJP and joined INC. Now the following five MLAs seats are vacant in the current assembly:

CRIMINAL BACKGROUND

- MLAs with criminal cases: Out of 65 sitting MLAs analysed, 20 (31%) MLAs have declared criminal cases against themselves.
- MLAs with serious criminal cases: 14 (22%) MLAs have declared serious criminal cases.
- MLAs with declared cases related to murder: 2 MLAs have declared cases related to murder (IPC section 302).
- <u>MLAs with declared cases related to attempt to murder:</u> 1 MLA has declared case related to attempt to murder (IPC section 307).



Criteria for serious criminal cases

- Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the

People Act (Section 8)

- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.

- MLAs with cases related to Crimes against Women: 3 MLAs have declared cases related to crimes against women.
- Party wise sitting MLAs with criminal cases: 16 (30%) out of 54 MLAs from BJP, 3 (33%) out of 9 MLAs from INC and 1 (50%) out of the 2 Independent MLAs have declared criminal cases against themselves in their affidavits.
- Party wise sitting MLAs with serious criminal cases: 10 (19%) out of 54 MLAs from BJP, 3 (33%) out of 9 MLAs from INC and 1 (50%) out of the 2 Independent MLAs have declared serious criminal cases against themselves in their affidavits.




Figure: Party wise percentage of MLAs with declared criminal cases





FINANCIAL BACKGROUND

- Crorepati MLAs: Out of 65 sitting MLAs analysed , 46 (71%) are crorepatis.
- <u>Party wise crorepati MLAs:</u> 37 (69%) out of 54 MLAs from BJP, 8 (89%) out of 9 MLAs from INC and 1 (50%) out of 2 Independent MLAs have declared assets valued more than Rs 1 crore.




Figure: Party Wise Percentage of Crorepati MLAs

- Average assets: The average of assets per sitting MLA is Rs.4.09 crore.
- <u>Party wise average assets:</u> The average assets per MLA for **54 BJP** MLAs analysed is **Rs.4.04 crores**, **9 INC** MLAs analysed is **Rs.5.02 crores** and **2** Independent MLAs have average assets of **Rs.1.40 crores**.




