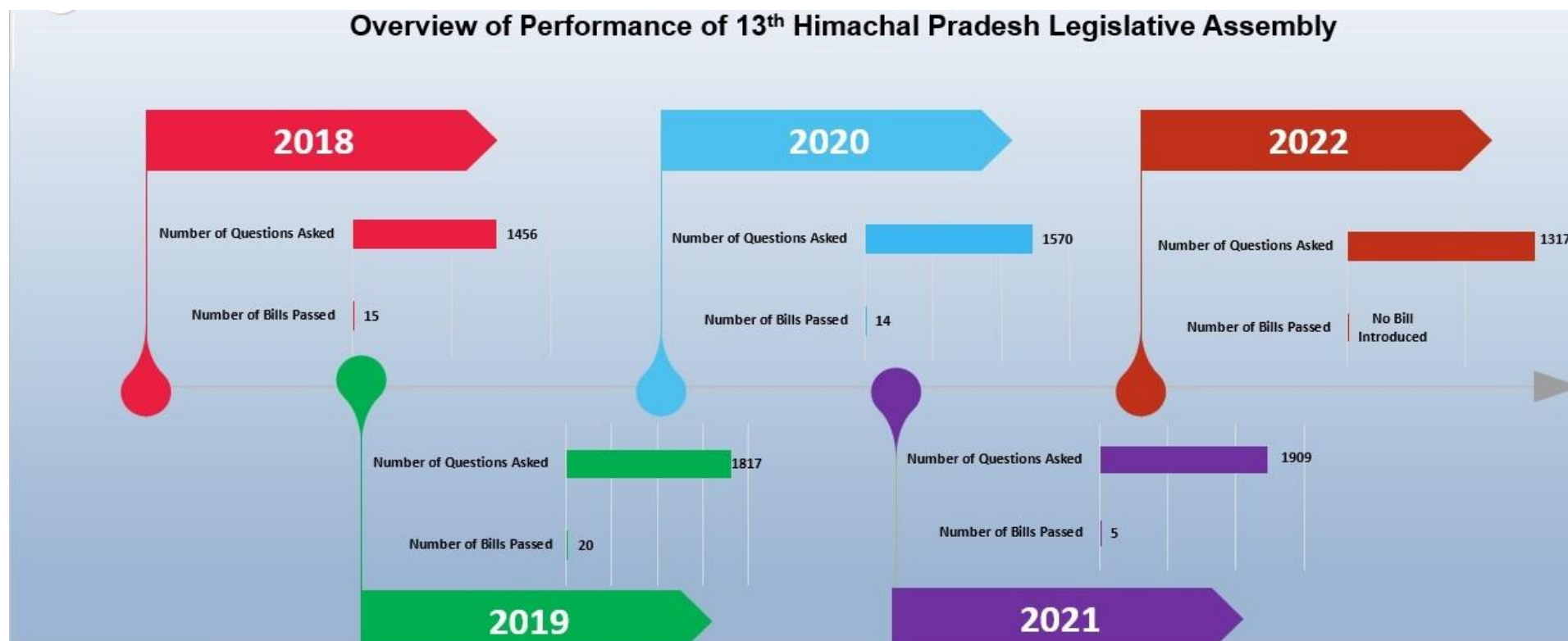

Association for Democratic Reforms (ADR) and Himachal Pradesh Election Watch had filed RTI applications with the Himachal Pradesh Assembly Secretariat requesting for information pertaining to the performance of the Himachal Pradesh MLAs and the Legislative Assembly. This report has been generated from the information received **up to August 2022**. Whereas from **2018 to 2021** the report covers the complete calendar years, for the year **2022** the report covers data available from January to August **2022**.

There are 68 seats in Himachal Pradesh Assembly, however this report also includes the analysis for the MLAs who have resigned or got elected through bye-elections.

- ❖ Only **60** MLAs have asked questions. These MLAs asked total **8,069** questions.

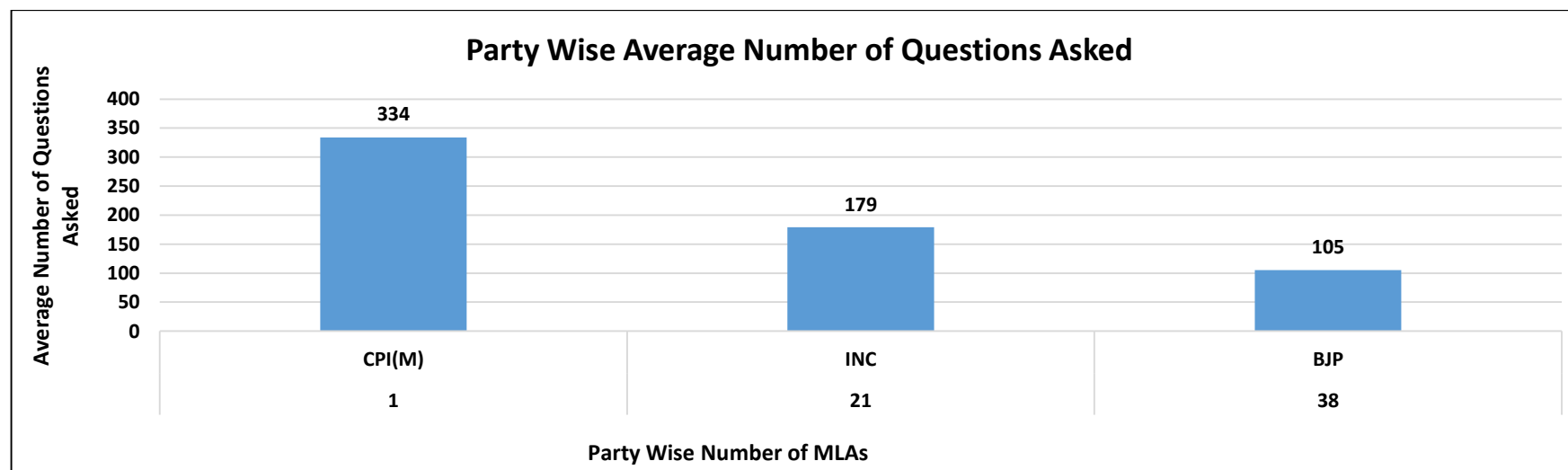


Figure: Party Wise Average Number of Questions Asked

- Highest number of Questions were related to Public Works, Jal Shakti Vibhag, Health and Family Welfare and Higher Education.

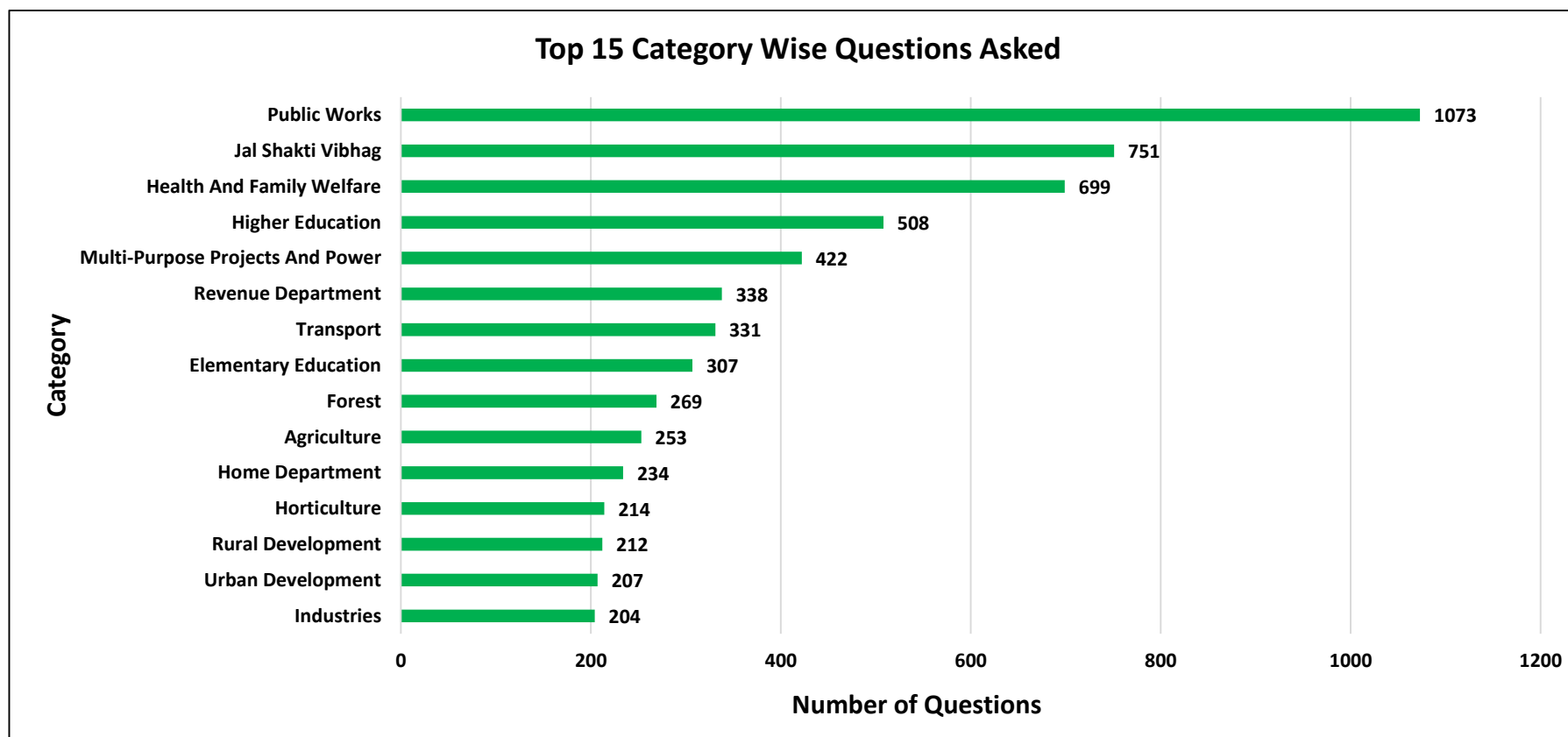


Figure: Top 15 - Category Wise Questions Asked

- There were total **54** Bills tabled in the **13th** Himachal Pradesh Legislative Assembly and all of them were passed.

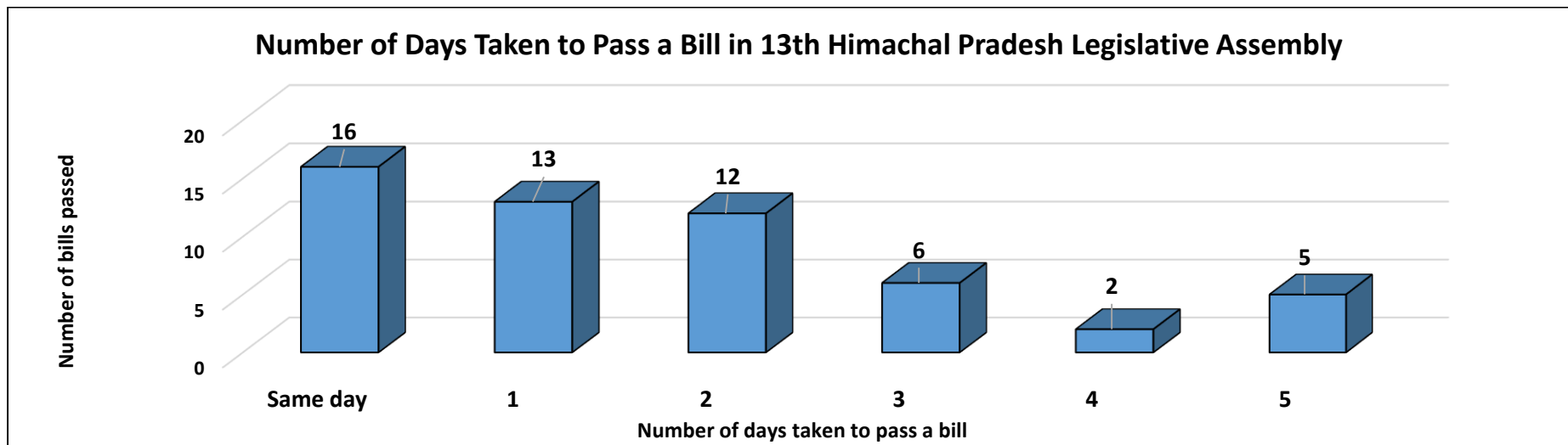


Figure: Time taken to pass a Bill in 13th Himachal Pradesh Legislative Assembly

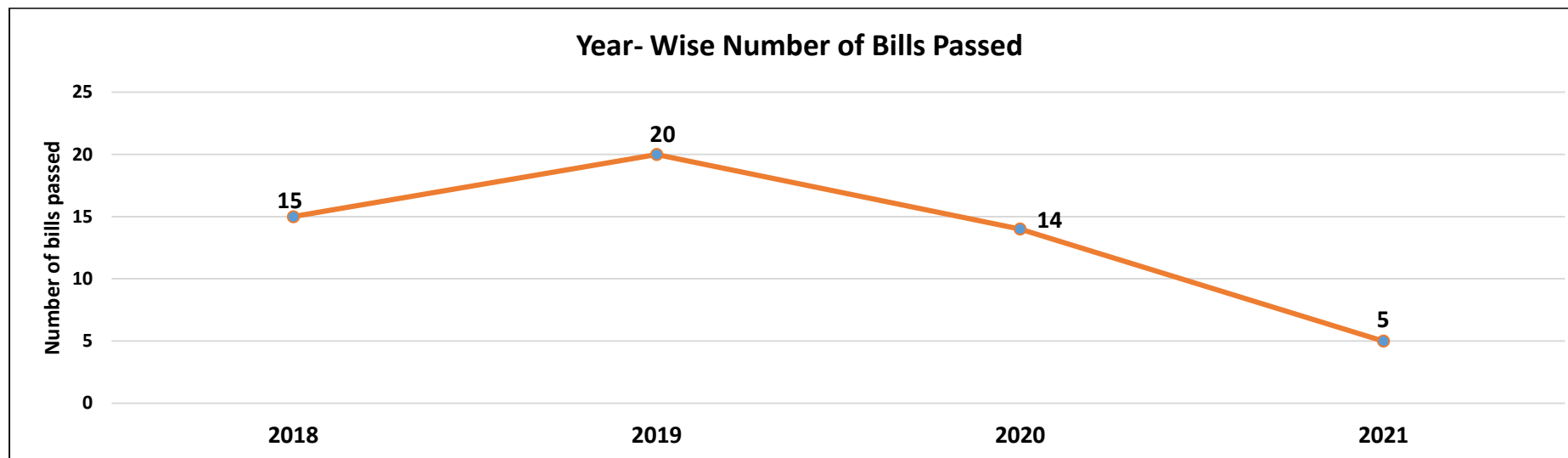


Figure: Number of Bills Passed in 13th Himachal Pradesh Legislative Assembly
