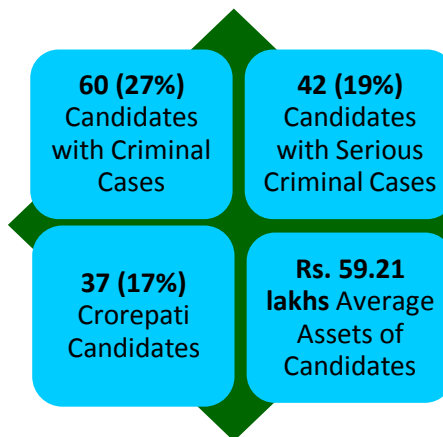

## Summary and Highlights

Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **223 candidates from 20 constituencies** who are contesting in the second phase of Jharkhand 2014 elections.



### Criminal Background

- **Candidates with Criminal Cases:** Out of the **223** candidates, **60 (27%) candidates** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **42 (19%)** candidates have declared serious criminal cases including cases related to **murder, attempt to murder, rape, communal disharmony, kidnapping, crimes against women** etc.
- **Candidates with cases related to murder:** **5** candidates have declared cases related to **murder**. **Dinesh Oraon** of **BJP** from **Sisai** constituency, **Manoj Nagesiya** of **BJP** from **Koleibera** constituency, **John Miran Minda** an Independent candidate from **Chaibasa** constituency, **Ramlal Munda** an Independent candidate from **Chakradharpur** constituency and **Paulus Surin** of **JMM** from **Torpa** constituency have declared cases related to murder.
- **Candidates with cases related to Attempt to Murder:** **10** candidates have declared cases of attempt to murder. **Out of these 10 candidates, 2** are fielded by **BJP**, **2** from **JMM**, **1** from **JVM(P)**, **1** from **AITC**, **1** from **INC** and **3** are **Independents**.
- **Candidates with cases related to Crimes against Women:** **3** candidates have declared cases related to crimes against women. **Ramlal Munda** an **Independent** candidate from **Chakradharpur** constituency has declared a case of rape (**IPC Section-376**), **Shishir Kumar Singh Munda** an **Independent** candidate from **Tamra** constituency has declared an

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

offence of **Husband or relative of husband of a woman subjecting her to cruelty (IPC Section-498A)** and **Bandhu Tirkey of AITC from Mandar constituency** has declared an offence of **Word, gesture or act intended to insult the modesty of a woman (IPC Section-509)**.

- **Candidate with cases related to causing Communal Disharmony:** Banna Gupta of **INC** from **Jamshedpur West** constituency has declared a case related to **Injuring or defiling place of worship with intent to insult the religion of any class (IPC Section-295)**.
- **Candidate with cases related to Robbery and Dacoity:** Pardesi Lal Munda of **BSP** from **Manoharpur** constituency has declared a charge related to **making preparation to commit dacoity (IPC Section-399)** and **Assembling for purpose of committing dacoity (IPC Section - 402)**.
- **Candidate with cases related to Kidnapping:** Dulal Bhuiyan of **INC** from **Jugsalai** constituency has declared a case related to **Kidnapping or abducting with intent secretly and wrongfully to confine person (IPC Section-365)**.
- **Party wise Candidates with Criminal Cases:** **12 (67%)** out of 18 candidates from **BJP**, **10 (50%)** out of 20 candidates from **JMM**, **5 (28%)** out of **18** candidates fielded by **JVM (P)**, **4(20%)** out of 20 candidates from **INC** and **13 (23%)** out of 56 **Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **8 (44%)** out of 18 candidates from **BJP**, **8 (40%)** out of 20 candidates from **JMM**, **3 (17%)** out of **18** candidates fielded by **JVM (P)**, **8(40%)** out of 20 candidates from **INC** and **12 (21%)** out of 56 **Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Red Alert Constituencies\*:** 13 constituencies have at least 3 candidates with declared criminal cases.  
\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.

### Financial Background

- **Crorepati Candidates:** Out of the **223** candidates, **37 (17%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **8 (44%)** out of 18 candidates from **BJP**, **11 (55%)** out of 20 candidates from **INC**, **5 (25%)** out of 20 candidates from **JMM**, **2 (11%)** out of 18 candidates from **JVM (P)** and **5 (9%)** out of 56 **Independent** candidates have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the second phase of Jharkhand elections is **Rs.59.21 lakhs**.
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **18 BJP** candidates is **Rs 1.18 crores**, **20 JMM** candidates have average assets of **Rs.1 crore**, **18 JVM (P)** candidates have average assets worth **Rs. 78.68 lakhs**, **20 INC** candidates have average assets worth of **Rs. 1.57 crores** and **56 Independent** candidates have average assets of **Rs. 34.02 lakhs**.

### Other Background Details

- **Education Details of Candidates:** 127 (57%) candidates have declared that they have an education qualification of 12<sup>th</sup> pass or below while 92 (41%) candidates have declared having an educational qualification of graduate or above.
- **Age Details of Candidates:** 168 (75%) candidates have declared their age to be between 25 to 50 years while 52 (23%) candidates have declared their age to be between 51 to 80 years. Three candidates have not given their age details.
- **Gender Details of Candidates:** 34 (15%) female candidates are contesting in the Jharkhand 2014 Phase-II elections.
- **Profession Details of Candidates:** 77 candidates have declared agriculture as their main profession. 31 candidates have declared their main profession to be business. 45 candidates have declared their profession to be Social Service. 16 candidates have declared that they have retired. 11 candidates have declared their main occupation to be a politics.

### EXECUTIVE SUMMARY – Upto Phase – 2

- **Total candidates analysed:** 422 candidates.
- **Candidates with declared criminal cases so far:** 115 (27%) out of 422 candidates.
- **Candidates with declared serious criminal cases so far:** 79(19%) out of 422 candidates.

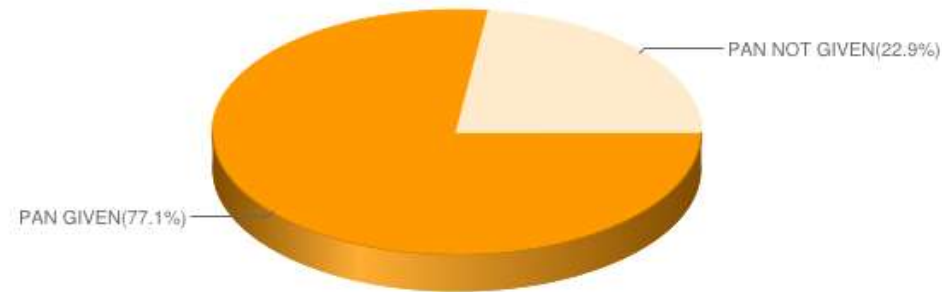
