

कानून निर्माताओं पर भ्रष्टाचार निरोधक अधिनियम के तहत भ्रष्टाचार के आरोप: राजनैतिक दलों की भूमिका

प्रेस विज्ञप्ति : – 7 सांसदों तथा 29 विधायकों पर भ्रष्टाचार निवारण अधिनियम के तहत मुकदमे दर्ज किये गये हैं। गत पाँच सालों में राजनैतिक दलों ने 98 ऐसे प्रत्याशीयों को टिकट दिए जिन्होंने अपने विरुद्ध भ्रष्टाचार निवारण अधिनियम के तहत मामले घोषित किए हैं। नेशनल इलेक्शन वॉच यह मांग करता है कि सभी सांसदों/विधायकों के विरुद्ध आपराधिक मामलों को फास्ट ट्रैक किया जाये तथा राजनैतिक दलों से अनुरोध है कि ऐसे प्रत्याशीयों को टिकट न दिया जाए।

ADR ने पूरे देश से चुनावों के दौरान 4835 सांसदों तथा विधायकों के स्वघोषित हल्फनामों का विश्लेषण किया है, जो कि चुनावों के समय निर्वाचन आयोग को प्रस्तुत किए गए थे। इन 4835 निर्वाचित प्रतिनिधियों में से 1448 (31%) ने अपने विरुद्ध आपराधिक मामले घोषित किए हैं। 1448 में से 641 ने गंभीर आपराधिक मामले जैसे कि बालात्कार, हत्या, हत्या का प्रयास, अपहरण, डकैती, जबरन वसूली आदि घोषित किए हैं।

यह रिपोर्ट उन निर्वाचित प्रतिनिधियों पर केन्द्रित है, जिन्होंने अपने हल्फनामों में भ्रष्टाचार निवारण अधिनियम के तहत मामले घोषित किए हैं।

कार्यकारी सारांश

- गत पाँच सालों में राजनीतिक दलों ने 98 ऐसे प्रत्याशीयों को टिकट दिए हैं जिनके विरुद्ध भ्रष्टाचार निवारण अधिनियम के तहत मामले दर्ज हैं। (इस विश्लेषण में लोक सभा 2009 चुनाव तथा 2008 के बाद के राज्य विधान सभा सम्मिलित हैं।
- प्रमुख राजनैतिक दलों ने ऐसे उम्मीदवारों को टिकट दिये हैं जिनके विरुद्ध भ्रष्टाचार विरोधी मामले दर्ज हैं इनमें कांग्रेस के 24, बसपा के 9, AIADK के 7, SAD के 6, DMK के 5, भाजपा के 5, INLD के 4 तथा RJD के 4 उम्मीदवार शामिल हैं। (पिछले पांच वर्षों में हुए लोकसभा और विधानसभा चुनाव के विश्लेषण पर आधारित)

- इन 98 प्रत्याशीयों में से 36 प्रत्याशी निर्वाचित हुए। इनमें 4 लोक सभा सांसद, 3 राज्य सभा सांसद तथा विभिन्न राज्यों के 29 विधायक सम्मिलित हैं।

लोक सभा 2009 तथा राज्य सभा

- लोक सभा 2009 चुनावों में, राजनीतिक दलों ने 15 ऐसे प्रत्याशीयों को टिकट दिए हैं जिनपर भ्रष्टाचार विरोधी मामले दर्ज हैं।
- भ्रष्टाचार विरोधी मामलों वाले इन 15 प्रत्याशीयों में से 4 कांग्रेस से, बसपा तथा भाजपा से 2 तथा 1 प्रत्याशी AIADMK, SAD, DMK, RJD, INLD, JD(U) तथा SP से।
- इन 15 प्रत्याशीयों में से 4 लोक सभा के लिए निर्वाचित हुए। वे हैं— जेडीयू से जगदीश शर्मा, जहानाबाद निर्वाचन क्षेत्र, Rajanah Sircilla (कांग्रेस, Warangal निर्वाचन क्षेत्र) तथा लालू प्रसाद यादव (RJD Saran निर्वाचन क्षेत्र)।
- वर्तमान राज्य सभा में 3 सांसदों ने अपने विरुद्ध भ्रष्टाचार विरोधी मामले घोषित किए हैं। इनमें T.M. Seluanganopattin DMK से, Faggan Singh Kulast, BJP से तथा Rashid Masood INC से सम्मिलित हैं।

वर्तमान राज्य विधान सभाएँ

- गत पाँच वर्षों में, विभिन्न राजनीतिक दलों ने 80 ऐसे प्रत्याशीयों को टिकट दी है, जिनपर भ्रष्टाचार निवारण अधिनियम के तहत मामले दर्ज हैं।
- इन 80 में से 29 विजयी हुए तथा वर्तमान विधायक हैं।
- भ्रष्टाचार विरोधी मामलों वाले 29 विधायकों में से तमिलनाडू से 7, हरियाणा, झारखंड तथा पंजाब से 3 विधायक हैं।
- हिमाचल प्रदेश, मध्य प्रदेश तथा उड़ीसा विधान सभाओं में 2-2 विधायक ऐसे हैं जिनपर भ्रष्टाचार विरोधी मामले दर्ज हैं।

ADR की सिफारिशें

- सभी राजनितिक दलों को ऐसे उम्मीदवारों को टिकट नहीं देना चाहिए, जिनपर भ्रष्टाचार विरोधी मामले दर्ज हैं।
- जिन सांसदों तथा विधायकों पर भ्रष्टाचार निवारण अधिनियम के तहत मामले दर्ज हैं, उन सभी मामलों को फास्ट ट्रैक कर देना चाहिए।
