Section 8 (j) provides that there shall be no obligation to give any citizen information which relates to personal information disclosure of which has no relationship to any public activity or interest unless the CPIO is satisfied that the larger public interest warrants the disclosure of such information.  
In the present case, the information sought for, is under fiduciary relationship and also, the undersigned, being the CPIO, is not satisfied that the larger public interest warrants the disclosure of this information.
