Income Tax Returns of All Jharkhnad Students' Union (AJSU) Party (For Assessment Years 2002-03, 2003-04, 2004-05, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12 and 2012-13) Whether the political party <b>All Jharkhand Students' Union (AJSU) Party</b> , registered at the address Saket Vihar, Harmu, Ranchi – 834002, Jharkhand, has filed their complete Income Tax Returns for the above mentioned assessment years?	The details of filing of returns are as under: 1. From A.Y.2002-03 to A.Y.2008-09, as per AST, there is no return filed by the political party. Further, it is also relevant that the political party has furnished the <b>date of incorporation as 24.10.2002, but become recognized party on 18.03.2010 (from Election Commission of India)</b> . It is further intimated to the applicant that the jurisdiction of this case as per PAN lies with ACIT/DCIT, Circle-1, Ranchi from 03.08.2010 and earlier, the jurisdiction over this PAN was with ITO, Ward-1(4), Ranchi. 2. The return has been filed for A.Ys.2009-10, 2010-11 & 2011-12. For A.Y.2012-13, the assessee has time to file return till 31.03.2013 (if the taxes are duly paid), however, in case of non filing of Income-tax return, notice u/s 142(1) of the I.T. Act, 1961 shall be issued accordingly.
