

Kerala Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 140 newly elected MLAs in the Kerala 2016 Assembly Elections.

Criminal background

- <u>MLAs with criminal cases:</u> Out of the **140** MLAs analysed, **87 (62%) MLAs** have declared criminal cases against themselves. Out of 140 MLAs analysed during **Kerala Assembly elections in 2011**, **67 (48%)** MLAs had **declared criminal cases** against themselves.
- MLAs with serious criminal cases: 27 (19%) MLAs have declared serious criminal cases including cases related to murder, attempt to murder, kidnapping etc. Out of 140 MLAs analysed during Kerala Assembly elections in 2011, 12 (9%) MLAs had declared serious criminal cases against themselves.

Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.








Figure: Comparison of MLAs with declared criminal cases in 2011 and 2016

- <u>MLAs with cases related to murder and attempt to murder</u>: 7 MLAs have declared cases related to murder. All of them belong to Communist Party of India (CPI-M). 2 of them are charged with murder and 5 have declared cases of attempt to murder.
- Party wise MLAs with criminal cases: 53 (91%) out of 58 MLAs from CPI(M), 12 (63%) out of 19 MLAs from CPI, 9 (41%) out of 22 MLAs from INC, 4 (22%) out of 18 MLAs from IUML, 4 (67%) out of 6 IND MLAs, 1 (33%) out of 3 MLAs of JD(S), 1 (50%) out of 2 MLAs from NCP have declared criminal cases against themselves in their affidavits.
- Party wise MLAs with serious criminal cases: 17 (29%) out of 58 MLAs from CPI(M), 5 (23%) out of 22 MLAs from INC, 3 (16%) out of 19 MLAs from CPI, 1 (6%) out of 18 MLAs from IUML, 1 (17%) out of 6 IND MLAs have declared serious criminal cases against themselves in their affidavits.




Figure: Share of wealth among MLAs




Figure: Comparison of crorepati MLAs in 2011 & 2016

- Party wise crorepati MLAs: 15 (26%) out of 58 MLAs from CPI(M), 14 (78%) out of 18 MLAs from IUML, 13 (60%) out of 22 MLAs from INC, 5 (83%) out of 6 MLAs from Kerala Congress (M), 3 (50%) out of 6 IND MLAs, 3 (16%) out of 19 MLAs from CPI have declared assets valued more than Rs 1 crore.
- **Average assets**: The average of assets per MLA who won in the Kerala 2016 assembly elections is **Rs. 2.82 crores** whereas the average asset for each candidate who contested in the 2016 assembly elections was **Rs 1.29 crores**. In 2011, the average assets per 140 MLAs analyzed was **Rs 1.42 crores**.

<u>Party wise average assets</u>: Among major parties, the average assets per MLA for **58 CPI(M)** MLAs analysed is **Rs 1.48 crores**, **22 INC** MLAs have average assets of **Rs 2.14 crores**, **19 CPI** MLAs have average assets worth of **Rs 64.56 lakhs**, **18 IUML** MLAs have average assets of **Rs 3.83 crores**, **6 IND** MLAs have average assets worth of **Rs 3.18 crores**.

- Number of re-elected MLAs: Number of re-elected MLAs analysed in the assembly elections of 2016 is 74
- Average assets of re-elected MLAs in 2011: The average assets of re-elected MLAs in 2011 was Rs. Rs 1.79 crores
- Average assets of re-elected MLAs in 2016: The average assets of re-elected MLAs in 2016 is Rs 3.38 crores
- Average growth in assets of re-elected MLAs from 2011 to 2016: The growth in average assets of re-elected MLAs is Rs 1.58 crores i.e. by 88%.

Other background details

- <u>Education Details of MLAs:</u> 32 (23%) MLAs have declared themselves as graduate professionals, followed by 24 (17%) which are post graduate and 24 (17%) others which are graduate. 55(39%) MLAs have had education till 5th to 12th standard. Only 2 (1%) MLAs are literate.
- <u>Age details of MLAs:</u> 45 (32%) candidates have declared their age to be between 25 and 50 years while 92 (66%) candidates have declared their age to be between 51 and 80 years. 3 candidates above 80 year.
- Gender details of MLAs: Out of 140 MLAs, 8(6%) MLAs are women. In 2011, out of 140 MLAs, 7 (5%) MLAs were women.


