

## **Analysis of Criminal, Financial and Other Background details of Candidates from Madhya Pradesh for Lok Sabha 2014**

Association for Democratic Reforms (ADR) and Madhya Pradesh Election Watch have analyzed the self-sworn affidavits of 370 out of the 378 candidates contesting from Madhya Pradesh in the Lok Sabha Elections 2014 as given by the ECI.

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 370 candidates analysed, **65 candidates (18%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 370 candidates, **35 (9%) candidates** have declared serious criminal cases including murder, attempt to murder, kidnapping etc.
- **Party wise Candidates with Criminal Cases:** INC has **10 (36 %) out of 28**, AAP has **8 (30 %) out of 27**, BJP has **8 (28 %) out of 29** and BSP has **10 (36%) out of 28** candidates with declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** AAP has **6 out of 10 (22%)**, INC has **2 out of 28 (7%)**, BSP has **6 out of 28 (21%)** candidates who declared serious criminal cases against themselves.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Candidate with cases related to murder:** Girraj Yadav, Independent candidate from Guna constituency had declared a case of murder (IPC Section – 302) against himself.
- **Candidates with cases related to attempt to murder:** Sanat Kumar Tripathy of Bhartiya Shakti Chetna Party from Sidhi constituency and Brindawan Singh Sikarwar of BSP from Morena constituency have declared charges of attempt to murder (IPC Section-307) against themselves.
- **Candidate with cases related to Kidnapping:** Ramesh Chensingh, INC candidate from Khargone has a charge of Kidnapping, abducting or inducing woman to compel her marriage, etc. (IPC Section-366)
- **Candidate with cases related to robbery and dacoity:** Jaibhansingh Pawaiya of BJP from Guna constituency had declared a charge of dacoity (IPC Section – 395) against himself.
- **Candidate with cases of crimes against women:** Ramesh Chensingh, INC candidate from Khargone has a charge related to assault or criminal force to woman with intent to outrage her modesty (IPC section-354)
- **Red Alert Constituencies\***: 11 constituencies in Madhya Pradesh have at least 3 candidates with declared criminal cases. Khandwa constituency has the most number of candidates i.e. 6 candidates with criminal cases.

\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections (including independents)

### Financial Background

- **Crorepati Candidates:** Out of the 370 candidates analysed, **75 (20%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **24 out of 28 (86%) INC** candidates are crorepatis, **24 out 29 (83%) BJP** candidates, **6 out of 28 (21%) BSP** candidates and **7 out of 27 (26%) of AAP** candidates are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Madhya Pradesh in Lok Sabha 2014 elections is **Rs. 2.24 crores**.

- **Party-wise Average Assets:** Among major parties, the average assets per candidate for 29 **BJP** candidates was **Rs. 3.79 Crores**, for 28 **INC** candidates was **Rs. 21.17 Crores**, for 28 **BSP** candidates was **Rs. 85.66 lakhs**, for 27 **AAP** candidates was **Rs. 1.06 crores**.
- **High Asset Candidates:** 12 candidates have declared more than **Rs. 10 crore worth of assets**. Total assets include assets of self, spouse and dependents. Top 3 candidates with highest assets are:

- **Candidates with zero assets:** 5 candidates have declared zero assets in their affidavits.
- **Low Asset Candidates:** Out of 370 candidates analysed, a total of **67** candidates have declared assets less than **Rs 2 lakh** (excluding 5 candidates with zero assets). The candidates with lowest assets are as follows:

- **Candidates who have not declared Income Tax Details\*:** 232 (63%) candidates out of 370 analyzed have not declared income tax details. \* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 9 candidates out of 370 analysed have declared assets of more than Rs 1 crore but have not declared Income Tax Details.
- **Undeclared PAN:** 149 (40%) out 370 candidates analysed have not declared their PAN details.

### Other Background details (Education, Gender, Age)

- **Candidates' Education:** 178 (48%) candidates have educational qualification of 12<sup>th</sup> pass or below while 179(48%) candidates are graduates or above.
  - **Candidates' Age:** 255 (69%) candidates have declared their age to be between 25 and 50 years while 105 (28%) candidates are in the age group of 51-70 years. 7 candidates are aged above 70 years.
- Gender representation:** Of the 370 candidates analyzed, only 34 (9%) are women. In 2009, there were 29 (7%) women candidates out of 429 candidates.

### Detailed Analysis based on declared criminal cases

Out of the 370 candidates analysed, 65 candidates (or 18%) have declared a criminal cases against themselves.

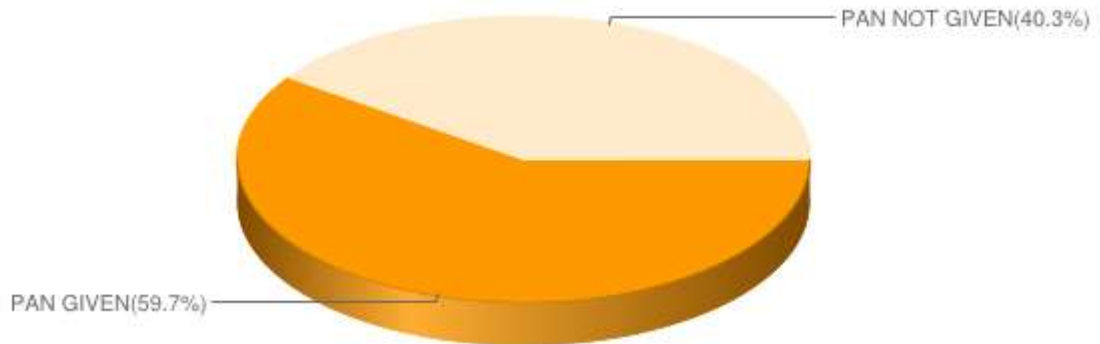

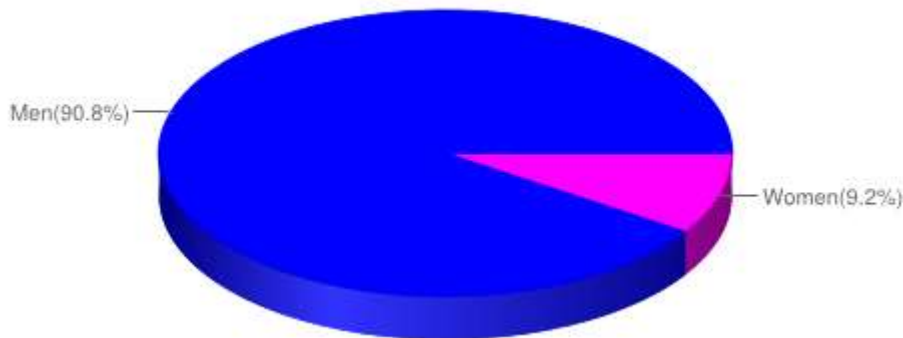
