


एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और नेशनल इलेक्शन वॉच ने देश की सभी राज्य विधानसभाओं और केंद्र शासित प्रदेशों के सभी 30 वर्तमान मुख्यमंत्रियों के शपथपत्रों का विश्लेषण किया। यह विश्लेषण मुख्यमंत्रियों द्वारा उनके पिछले चुनाव लड़ने से पहले प्रस्तुत किए गए शपथपत्रों पर आधारित है।

आपराधिक पृष्ठभूमि

आलेख— आपराधिक मामले घोषित करने वाले बनाम साफ पृष्ठभूमि वाले मुख्यमंत्री








मुख्यमंत्रियों द्वारा घोषित गंभीर आपराधिक मामले:— 13 (43 प्रतिशत) मुख्यमंत्रियों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। जिनमें हत्या, हत्या का प्रयास, अपहरण, आपराधिक धमकी से सम्बन्धित अपराध इत्यादि शामिल हैं।

गंभीर आपराधिक मामलों के लिए मापदंड

- 1. पांच साल या उससे अधिक सजा वाले अपराध
- 2. गैर जमानती अपराध
- 3. चुनाव से सम्बन्धित अपराध (धारा 171 अथवा रिश्वतखोरी)
- 4. सरकारी खज़ाने को नुकसान पहुंचाने से सम्बन्धित अपराध
- 5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
- 6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
- 7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
- 8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध










