

Analysis of Donations Received by Political Parties in Himachal Pradesh

Political parties rely heavily on donations for fighting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals.

Section 29C of the Representation of People Act, 1951 says that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. This section has been interpreted by political parties, to include every single donation made above Rs 20,000 by any person at one time. This section however, would also include in it multiple donations made by the same person, entity or company aggregating Rs 20,000 or above during the year.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Moreover, these are cash donations and it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus it becomes all the more important to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

Share of Donations from Total Income

- The total Income of political parties considered have been calculated from the income to the parties from various sources all over India as submitted in their Income Tax Returns. INC (Rs 2,00,871.74 lakhs) tops the list followed by BJP (99,476.67 lakhs) and CPM (Rs 41,726.15 lakhs)
- Of the 5 National Parties in Himachal Pradesh, the BJP leads the table with Rs 82,000.50 lakhs collected from donations over a period of 7 years, between FY 2004-05 and 2010-11; followed by the INC with Rs 27,250.48 lakhs collected from donations during the same period from all over India
- BSP has declared a total income from donations to be Rs 30,731 lakhs (data for FY 2006-07 is awaited), followed by CPM (Rs 17,546.15 lakhs) and CPI (Rs 458.96 lakhs) between FYs 2004-05 and 2010-11
- BJP has declared that 82.43% of its income has come from donations received between FY 2004-05 and 2010-11 while INC has only 13.57% of its total income derived from donations between the same period.
- 54.40% of total income of CPI; 42.05% of total income of CPM and 28.93% of total income of BSP have come from donations to their parties from all over India

Share of Donations received in excess of Rs 20,000 from Total Income

- The National Party, Bahujan Samaj Party (BSP) has declared that it has not received any donation above Rs 20,000 from a single donor in 7 years between FY 2004-05 and 2010-11. It should be noted that the total donations of Rs 30,731 lakhs was declared by the party in its Income Tax Returns statement.
- In spite of a total income of Rs 2,00,871.74 lakhs between FY 2004-05 and 2010-11, INC has declared that only 8.85% of its total income is covered by donations above Rs 20,000
- BJP, with a total income of Rs 99,476.67 lakhs, has only 19.46% coming from donations above Rs 20,000 collected during the same period
- 37.98% of the total income of CPI has been declared to come from its donations from named donors (Rs 320.38 lakhs) whereas CPM's income from donations above Rs 20,000 is only a mere 0.79% (Rs 332.71 lakhs)

Top Donors of Parties for FY 2003-2004 to FY 2010-11

- General Electoral Trust is a major donor for INC (Rs 3641 lacs) and BJP (Rs 2607 lacs) for the Financial Years 2003-04 to 2010-11
- Other major donors include Torrent Power donating Rs 1415 lacs to INC and Rs 1300 lacs to BJP
- Southern Engineering Works (SEW) is a major contributor to the CPM (Rs 35 lacs by SEW and Rs 25 lacs by SEW Infrastructure) followed by Rs 10 lacs donated by Nuziveedu seeds private ltd
- Individual collection by members of CPI holds the top position in the donor table with Mr A.B.Bardhan collecting Rs 65.13 lacs followed by Rs 30 lacs collected by Mr Aziz Pasha and Rs 27.47 collected by Mr D.Raja.
