

हिमाचल प्रदेश में राजनीतिक दलों द्वारा प्राप्त दान (Donation) का विश्लेषण

राजनीतिक दल चुनाव लड़ने एवं अपने दैनिक कार्य चलाने के लिए दान पर पूर्णतया आश्रित होते हैं। उन्हें कॉर्पोरेट जगत, ट्रस्टों एवं व्यक्तियों से दान के रूप में भारी रकम मिलती है।

जन प्रतिनिधि अधिनियम 1951 (Representation of People Act) के अनुभाग 29सी के अनुसार राजनीतिक दलों को किसी व्यक्ति अथवा कंपनी से मिले 20,000 ₹ से अधिक के दान का विवरण देना होता है। इस अनुभाग का अर्थ राजनीतिक दलों के अनुसार यह है कि इसमें वे सारे दान शामिल किए जाएं जो कि एक स्रोत द्वारा एक समय पर दिए गए हैं और जो 20,000 ₹ से अधिक हैं। तथापि, इस अनुभाग में वे सभी विभिन्न दान भी शामिल किए जाने चाहिए जो किसी एक व्यक्ति, संस्था अथवा कंपनी ने पूरे वर्ष के दौरान दिए हैं, और जिनका औसत 20,000 ₹ या उस से अधिक है।

इसके अलावा राजनीतिक दलों ने नकद दान के लिए दानकर्ता को प्राप्ति (Receipt) के बदले कूपन जारी करने की प्रणाली अपना ली है। इन नकद दानों से दानकर्ता की पहचान करना मुश्किल हो जाता है इसका तात्पर्य यह है कि बहुत से नकद में लिए गए दान बेहिसाब रह जाते हैं क्योंकि खातों में वही राशि दर्ज होती है जिसकी प्राप्ति (Receipt) जारी की गई हो।

इसलिए यह बहुत आवश्यक हो जाता है कि एक सख्त नियामक प्रणाली बनाई जाए जिसके तहत राजनीतिक दलों को अपने लिए गए दान के सूत्र तथा उनकी सही मात्रा का विवरण देना आवश्यक हो।

कुल आय (Total Income) में से दान (Donation) का भाग

- पूरे भारत में विभिन्न स्रोतों से राजनीतिक दलों की कुल आय की गणना उनके द्वारा प्रस्तुत आयकर रिटर्न से की गई है।
- हिमाचल प्रदेश में पाँच प्रमुख राष्ट्रीय दलों में से भाजपा को पिछले 7 सालों में यानि कि वित्तीय वर्ष 2004-2005 से 2010-2011 तक सर्वाधिक दान ₹ 82,000.50 लाख मिला है, इसके बाद कांग्रेस ने भी इसी अवधि के दौरान ₹ 27,250.48 लाख दान के रूप में प्राप्त किये हैं। (पूरे भारत में दे दे 1 से)
- बसपा ने दान से प्राप्त कुल आय ₹ 30,731 लाख घोषित की है (वित्तीय वर्ष 2006-07 की जानकारी प्रतिक्रियित है)। इसके बाद वित्तीय वर्ष 2004-05 और 2010-11 के बीच सी.पी.एम. की दान से प्राप्त कुल आय ₹ 17,546.15 लाख और सी.पी.आई की दान से प्राप्त कुल आय ₹ 458.96 लाख रही है।

- दोनो राष्ट्रीय दलों में से भाजपा ने घोषित किया है कि उसकी कुल आय का 82.43 प्रतिशत वित्तीय वर्ष 2004–2005 से 2010–2011 तक प्राप्त किए गया दान है। जबकि कांग्रेस को उसी अवधि के दौरान मिला हुआ दान उसकी कुल आय का केवल 13.57 प्रतिशत है।
- सी.पी.आई की कुल आय का 54.40 प्रतिशत, सी.पी.एम की कुल आय का 42.05 प्रतिशत और बसपा की कुल आय का 28.93 प्रतिशत दान से प्राप्त किया गया है। (पूरे भारत देश से)

कुल आय में से 20,000 रुपये की अधिक प्राप्त दान के भोयर

- राष्ट्रीय दल बहुजन समाज पार्टी (बसपा) ने घोषित किया है कि उसने 7 सालों में वित्तीय वर्ष 2004–05 और 2010–11 के बीच ₹ 20,000 से अधिक किसी भी एकल दानकर्ता से कोई दान प्राप्त नहीं किया है। यहाँ ध्यान दिया जाये कि ₹ 30,731 लाख दान पार्टी द्वारा अपने आयकर रिटर्न बयान में घोषित किया गया था।
- वित्तीय वर्ष 2004–05 और 2010–11 के बीच 2,008,71.74 लाख रुपये की कुल आय के बावजूद, कांग्रेस ने घोषणा की है कि उसने कुल आय 20,000 रुपये से ऊपर 8.85 प्रतिशत दान के द्वारा प्राप्त की है।
- भाजपा ने 99,476.67 लाख, यानि 19.46 प्रतिशत 20,000 से ऊपर चन्दे में प्राप्त किया है।
- सी.पी.आई ने अपनी कुल आय 37.98 प्रतिशत (₹ 320.38 लाख) दान अपने नाम दानदाताओं से घोषित की है जबकि सी.पी.एम की आय ₹ 20,000 हजार से अधिक यानि 0.79 प्रतिशत (₹ 332.71 लाख) दान से घोषित की है।

वित्तीय वर्ष 2003-04 से 2010-11 के दलों के भीर दानदाता

- जनरल इलेक्टोरल ट्रस्ट, कांग्रेस (रू0 3641 लाख) और भाजपा (रू0 2607 लाख) के लिए वित्तीय वर्ष 2003-04 से 2010-11 तक का सबसे बड़ा दान दाता है।
- अन्य प्रमुख दान दाताओं में टोरंट पॉवर भागिल है जिन्होंने कांग्रेस को 1415 लाख रू0 और भाजपा को 1300 लाख रूपये दान किये हैं।
- साउथ इंजीनियरिंग वर्क्स (एस.ई.डब्ल्यू) सी.पी.एम. के लिए मुख्य योगदानकर्ता है (35 लाख एस.ई.डब्ल्यू. और 25 लाख एस.ई.डब्ल्यू इन्फ्रास्ट्रक्चर द्वारा)। इसके बाद 10 लाख रूपये Nuziveedu seeds private ltd द्वारा दान किये गये हैं।
- दानदाता तालिका मे सदस्यों द्वारा व्यक्तिगत संग्रह करने में सी.पी.आई. का प्रथम स्थान है। श्री ए. बी. बरधन ने 65.13 लाख, अजीज़ पा ा ने 30 लाख रूपये तथा श्री डी. राजा ने 27.47 लाख रूपये संग्रहित किए हैं।
