## **Analysis of Donations Received by Tamil Nadu's Major Political Parties (Financial Year 2004-05 to 2011-12) – An All India Report**

### **Executive Summary**

#### **• Income of Political parties:**

- Major political parties from Tamil Nadu considered for the report are INC, BJP, CPI, CPM, AIADMK, DMK, DMDK, VCK
- INC (Rs 2,36,502.95 lakhs) tops the list of highest total income collected between FY 2004-05 and 2011-12 followed by the total income of BJP: Rs 1,30,422.23; CPM (Rs 52,110.99 lakhs) and CPI (Rs 1001.07 lakhs)
- Out of the four State Parties, the **total income of AIADMK tops the list with Rs 8,195.72 lakhs followed by DMK – Rs 4,428.26 lakhs**

#### **• Share of Donations (as per the Income Tax Returns of the party):**

- **BJP tops the list** of maximum donation collected between FY 2004-05 and 2011-2012 **with Rs 1,09,600.38 lakhs which forms 84.03% of its total income** while INC has showed a total donation of Rs 30,694.95 lakhs which is only 12.98% of its total income
- CPM has shown a total donation of Rs 22,795.18 lakhs which is 43.74% of its total income
- **AIADMK, in its IT returns has not specified the amount of donation received by the party between FY 2004-05 and 2011-12 although the total donations above Rs 20,000 was declared to be Rs 355.87 lakhs by the party in its statement to the Election Commission**
- Only 0.47% of the total income of DMK comes from donations (Rs 11.58 lakhs) to the party while DMDK has declared a total donation of Rs 347.85 lakhs which is 17.68% of the party's total income

#### **• Share of donations above Rs 20,000:**

- In spite of a total income of Rs 2,36,502.95 lakhs between FY 2004-05 and 2011-12, INC has declared that only 7.93% of its total income is covered by donations above Rs 20,000
- **DMDK, with a total income of Rs 1,967.72 lakhs, has only 3.09% coming from donations above Rs 20,000 collected during the same period**
- Share of donation above Rs 20,000 in total income of DMK is 26.26% (Rs 651.03 lakhs)

#### **• Donations to Political Parties from Tamil Nadu (FY 2004-05 to 2011-12):**

- A total of Rs 54 lakhs contributed to Indian National Congress as voluntary donations above Rs 20,000 from Tamil Nadu. A total of 6 donors made the contribution.
- A total of Rs 14.34 lakhs donated by 6 donors from Tamil Nadu to the Communist Party of India between FY 2004-05 and 2011-12
- **A total of Rs 355 lakhs donated by 28 donors to AIADMK was voluntary contribution from tamil Nadu between FY 2004-05 and 2011-12**
- A total of Rs 1,121 lakhs donated by 321 donors from Tamil Nadu to DMK party between FY 2004-05 and 2011-12
- A total of Rs 58.83 lakhs donated by 42 donors from Tamil Nadu to DMDK between FY 2005-06 and 2011-12 (as the party was founded only in 2005)

- A total of Rs 23,290,000 (Rs 232 lakhs) was donated to BJP by donors from Tamil Nadu between FY 2004-05 and 2011-12. The total of 15 donors made the contribution
- **Details of donations collected above Rs 20,000:**
  - DMK is the only party whose donations above Rs 20,000 is more than the total donations declared in the party's IT Returns. Total donations of DMK above Rs 20,000 is Rs 651.03 lakhs while the total donations of the party as per the IT Returns is only Rs 11.58 lakhs
  - There have been no donations to CPM from Tamil Nadu between FYs 2004-05 & 2011-12
  - According to the report submitted by AIADMK, **the party received no donations above Rs 20,000 from Tamil Nadu for the FY 2005-06 and 2007-08**
  - DMK, in its contribution reports, states that the party received no donations above Rs 20,000 between the FY 2004-05 and 2007-08
  - Of the State parties, **maximum donations was collected by DMK (Rs 1,121 lakhs) followed by AIADMK (Rs 355 lakhs) and DMDK (Rs 59 lakhs)**
- **Year-wise donations to political parties from Tamil Nadu**
  - 3 donors from Tamil Nadu contributed a total of Rs 32 lakhs to BJP in FY 2004-05 while 1 donor donated a total of 1 lakh to INC in the same period
  - Similarly, a total of 3 donors contributed Rs 137 lakhs to BJP in FY 2009-10 while 1 donor contributed Rs 23,400 to INC in the same period
  - Of the national parties, BJP collected the maximum donation of Rs 232.9 lakhs followed by INC (Rs 54.71 lakhs)
  - Of the State parties, maximum donations was collected by DMK (Rs 1,121 lakhs) followed by AIADMK (Rs 355 lakhs) and DMDK (Rs 59 lakhs)
- **Major Donors of Political Parties:**
  - Shri Prabhakar of Chennai contributed the maximum amount to INC (Rs 49.50 lakhs) followed by Cavinkare (Rs 3 lakhs) and Vasanth & Co (Rs 1 lakh)
  - Maximum contribution to AIADMK was from Anna Thozhir Sanga Perovval (Rs 200 lakhs) followed by Thiru Saidai Duraisamy Avt (Rs 52 lakhs) and Dr V Nedumaran (Rs 27 lakhs)
  - The top donor to DMK was Ponagalur Palanisamy (Rs 105 lakhs) followed by S S Palani Manickam (Rs 50 lakhs)
- **Modes of payment to political parties**
  - It is to be noted that while 90.47% of the donations to INC from Tamil Nadu was made as demand draft by 1 donor, only one donor contributed by cash which constitutes 0.42% of the total donations from the state
  - 99.89% of the contribution to BJP from Tamil Nadu was made in cheque amounting to Rs 232.65 lakhs by 19 donors while the **mode of payment of donations of a single donor of Rs 25,000 was not specified**
  - Major contribution to **DMK was made by cash by 231 donors from Tamil Nadu who contributed 63.23% of the total income to the party**

- While 29 donors (contributing a total of 56.54 lakhs amounting to 15.89% of the total donations to the party) from Tamil Nadu made contributions in cash to AIADMK, 4 donors made contributions by cheques (Rs 247.13 lakhs amounting to 69.44% of the total donations to the party from Tamil Nadu)
- **Details of mode of payment of 5 Tamil Nadu donors to DMDK amounting to Rs 4.58 lakhs was not specified by the party**
  
- **Foreign Funds to BJP & INC:**
  - Both INC and BJP amounting to Rs 983.50 lakhs and 1,942.50 lakhs respectively received **foreign funding between FY 2003-04 and 2011-12**. Such donors include the Vedanta group (Sesa Goa, The Madras Aluminium Co. Ltd, Sterlite Industries), Public and Political Awareness Trust of Vedanta, Hyatt Regency (an American International company) and Dow Chemicals (headquartered in Michigan, USA)
  - Vedanta group is the top donor to both the parties with its subsidiary, Sterlite Industries donating Rs 600 lakhs followed by Sesa Goa Ltd donating Rs 2,78.50 lakhs to INC while the Public and Political Awareness Trust of Vedanta donated Rs 1450.00 lakhs to BJP followed by Vedanta The Madras Aluminium Co. Ltd donating Rs 350.00 lakhs between FY 2003-04 and 2011-12.

#### **RECOMMENDATIONS OF ADR**

- Political Parties to be declared Public Authorities and brought under the RTI Act
- Recommendations of the ECI, including
  - that extensive audits of all donations should be conducted by **CAG approved auditors** and
  - details of all donations to be declared irrespective of the amount of donation received, should be implemented at the earliest
- Exhaustive scrutiny of the IT Returns of the political parties should be conducted by the Income Tax Department
- A comprehensive law should be implemented to govern the functioning of political parties

## Analysis of Donations Received by Tamil Nadu's Major Political Parties (FY 2004-05 to 2011-12) – An All India Report

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals.

Section 29C of the Representation of People Act, 1951 says that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. Named contributions seem to be very small i.e. single contributions above Rs 20,000 seem to be very few in numbers for all the parties.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Moreover, these are cash donations and it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus, it becomes all the more important to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

### Total Income of Tamil Nadu's Major political parties – from all over India

- **The total income of political parties considered have been calculated from the income to the parties from various sources all over India as submitted in their Income Tax Returns.**
- Major political parties from Tamil Nadu considered for the report are INC, BJP, CPI, CPM, AIADMK, DMK, DMDK, VCK
- INC (Rs 2,36,502.95 lakhs) tops the list of highest total income collected between FY 2004-05 and 2011-12 followed by the total income of BJP: Rs 1,30,422.23; CPM (Rs 52,110.99 lakhs) and CPI (Rs 1001.07 lakhs)
- Out of the four State Parties, the total income of AIADMK tops the list with Rs 8,195.72 lakhs followed by DMK – Rs 4,428.26 lakhs
- DMDK was formed in 2005 hence IT Returns not available for the FY 2004-05
- The IT Returns of DMK for the FY 2009-10 and 2011-12 and that of VCK for the FYs 2004-05, 2010-11 and 2011-12 were denied by the Income Tax authorities via RTI and the appeals are pending

## Total Number of Contributors from Tamil Nadu Contributing Above Rs 20,000

In 8 years, the donation reports of CPM show no donations from Tamil Nadu while VCK has not submitted its donations details to the ECI even once. DMK has stated that the party has received no contribution above Rs 20,000 between 2004-05 and 2007-08. All the parties have given a remarkably low number of donors from Tamil Nadu who made donations above Rs 20,000.

If a donor has made multiple contributions in any one financial year, each contribution has been individually counted. Hence, if a donor has donated twice, the number of contributors would be counted as 2.

- There have been no donations to CPM from Tamil Nadu between FYs 2004-05 & 2011-12
- According to the report submitted by AIADMK, the party received no donations above Rs 20,000 from Tamil Nadu for the FY 2005-06 and 2007-08
- DMK, in its contribution reports, states that the party received no donations above Rs 20,000 between the FY 2004-05 and 2007-08
- 3 donors from Tamil Nadu contributed a total of Rs 32 lakhs to BJP in FY 2004-05 while 1 donor donated a total of 1 lakh to INC in the same period
- Similarly, a total of 3 donors contributed Rs 137 lakhs to BJP in FY 2009-10 while 1 donor contributed Rs 23,400 to INC in the same period
- Of the national parties, BJP collected the maximum donation of Rs 232.9 lakhs followed by INC (Rs 54.71 lakhs)
- Of the State parties, maximum donations was collected by DMK (Rs 1,121 lakhs) followed by AIADMK (Rs 355 lakhs) and DMDK (Rs 59 lakhs)

- It is to be noted that while 90.47% of the donations to INC from Tamil Nadu was made as demand draft by 1 donor, only one donor contributed by cash which constitutes 0.42% of the total donations from the state
- 99.89% of the contribution to BJP from Tamil Nadu was made in cheque amounting to Rs 232.65 lakhs by 19 donors while the mode of payment of donations of a single donor of Rs 25,000 was not specified
- Major contribution to DMK was made by cash by 231 donors from Tamil Nadu who contributed 63.23% of the total income to the party
- While 29 donors (contributing a total of 56.54 lakhs amounting to 15.89% of the total donations to the party) from Tamil Nadu made contributions in cash to AIADMK, 4 donors made contributions by cheques (Rs 247.13 lakhs amounting to 69.44% of the total donations to the party from Tamil Nadu)
- Details of mode of payment of 5 Tamil Nadu donors to DMDK amounting to Rs 4.58 lakhs was not specified by the party
