

### Analysis of Assets Comparison of Re-Contesting MLAs in the Haryana Assembly Election 2019

Haryana Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 62 re-contesting MLAs out of a total of 63 re-contesting MLAs contesting in the Haryana Assembly Election 2019. 1 MLA was not analysed due to unclear/incomplete affidavit uploaded on the ECI website at the time of making of this report.

#### Summary of comparison for re-contesting MLAs

- **Average Assets in 2014:** The average assets of these 62 re-contesting MLAs fielded by various parties including independents in 2014 was **Rs 11.32 Crores**.
- **Average Assets in 2019 Elections:** The average asset of these 62 re-contesting MLAs in 2019 is **Rs 14.94 Crores**.
- **Average Asset growth in 5 years (2014-2019):** The average asset growth for these 62 re-contesting MLAs, between the Haryana Assembly Elections of 2014 and 2019 is **Rs 3.62 Crores**.
- **Percentage growth in 5 years (2014-2019):** Average percentage growth in assets for these 62 re-contesting MLAs is **32%**.






Figure: Party Wise Assets Comparison of Re-Contesting MLAs

### Top 5 Re-contesting MLAs with highest asset increase (Rupees- wise) \*

- **Captain Abhimanyu** of BJP from Narnaund constituency has declared maximum increase in assets with an increase of **Rs 93.04 Crores** i.e from Rs 77.40 Crores in 2014 to Rs. 170.45 Crores in 2019.
- Assets of **Naina Singh** of INLD from Badhra constituency has increased by **Rs 31.52 Crores**, from Rs 60.26 Crores in 2014 to Rs 91.78 Crores in 2019.
- Assets of **Kuldeep Bishnoi** of INC from Adampur constituency have risen by **Rs 25.41 Crores**, from Rs 80.12 Crores in 2014 to Rs 105.54 Crores in 2019.

## Asset Comparison of Re-Contesting MLAs in Haryana Assembly Election 2019

### Average asset increase of re-contesting MLAs: Party-Wise

The table below provides the party-wise categorization of average asset increase of re-contesting MLAs. Financial details of 62 re-contesting MLAs fielded by various political parties have been taken from the recently filed affidavits by these MLAs and the values of these financial assets have been compared to the corresponding values of the assets that the MLAs showed in their affidavits from the previous elections.

The average asset growth for these 62 re-contesting MLAs, between the Haryana Assembly Elections of 2014 and 2019 is **Rs 3.62 Crores**.
