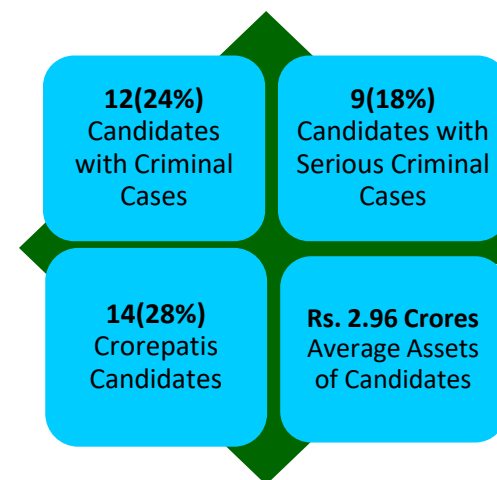

## Criminal Background

- Candidates with Criminal Cases:** Out of 50 candidates analyzed, **12 (24%)** candidates have declared criminal cases against themselves.

### Criteria for serious criminal cases

- Offence for which maximum punishment is of 5 years or more.
- If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- Offences under Prevention of Corruption Act
- Crimes against women.
