Executive Summary – Phase 3

Criminal Background

- **Candidates with Criminal Cases:** Out of the 108 candidates analysed, **38 candidates (35%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of these 38 candidates with criminal cases, **30 candidates** have declared serious criminal cases including cases related to **murder, attempt to murder, crimes against women, theft** etc.
- **Party wise Candidates with Criminal Cases:** All **3** candidates from **INC**, **4 (57%)** out of **7** candidates fielded by **BJP**, **2 (29%)** out of **7** candidates from **BSP**, **1(14%)** out of **7** candidates fielded by **AAP** and **5 (83%)** out of **6** of **JD(U)** have declared criminal cases against themselves in their affidavits. **3(10%)** out of **29** independent candidates has declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** **1(33%)** out of **3** candidates from **INC**, **3 (43%)** out of **7** candidates fielded by **BJP**, **1 (14%)** out of **7** candidates from **BSP**, **1(14%)** out of **7** candidates fielded by **AAP** and **4 (67%)** out of **6** of **JD(U)** have declared criminal cases against themselves in their affidavits. **2(7%)** out of **29** independent candidates has declared criminal cases.
- **Candidates with cases related to Murder:** **5** candidates have declared cases related to murder. **Mehboob Alam** of **CPI(ML)(L)** from Katihar constituency, **Dr. Ram Prakash Mahto** of **JD(U)** from Katihar constituency, **Naushaba Khanam** of **BSP** from Bhagalpur constituency, **Mahadev Kumar** an Independent candidate from **Bhagalpur** constituency and **Md Shamsheer Alam** of **JMM** from Purnia constituency have declared cases related to murder.
- **Candidates with cases related to Attempt to Murder:** **9** candidates have declared cases related to attempt to murder.
- **Red Alert Constituencies*:** 7 constituencies have at least 3 candidates with declared criminal cases.
**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.*

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the 108 candidates contesting, **26 (24%)** are crorepati.
- **Party-wise Crorepati Candidates:** **2 (67%)** out of **3** candidates from **INC**, **6 (86%)** out of **7** candidates from **BJP**, all 3 candidates from **RJD**, **3 (43%)** out of **7** candidates from **AAP** and **4 (67%)** out of **6** candidates from **JD(U)** are crorepati.

- **Average Assets:** The average assets per candidate contesting in the 2014 Lok Sabha Elections from Bihar (Phase 3) is **Rs. 3.39 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets for 3 **INC** candidates is **Rs. 4.30 crores**, 7 **BJP** candidates have average assets of **Rs. 23.93 crores** while the average assets of 7 **AAP** candidates is **Rs. 87.16 lakhs**. The average assets of 6 **JD(U)** candidates is **Rs. 1.77 crores**, while the average assets of 7 **BSP** candidates is **Rs. 28.91 lakhs**.
- **High Asset Candidates:** **11** candidates have more than **Rs. 4 crores** worth of assets. Total Assets include assets of self, spouse and dependents. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of 108 candidates, a total of **25** candidates have declared assets **less than Rs. 5 lakhs**. The three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of **49** candidates out of 108 have declared liabilities out of which 8 candidates have declared liabilities of more than **Rs 50 lakhs**. **Uday Singh Urf Pappu Singh** of BJP from Purnia constituency has the highest liabilities of **Rs. 12.31 crores** followed by **Shah Tariq Anwar** of NCP from Katihar constituency with **Rs. 2.04 crores** and **Purushottam Choubey** of SP from Bhagalpur constituency with **Rs. 2.03 crores** worth of liabilities.
- **Candidates with High Income*:** **11** candidates have declared total annual income of more than 10 lakhs. **Purushottam Choubey** of SP from Bhagalpur constituency has declared the highest income of **Rs. 62.37 lakhs**, while **Uday Singh Urf Pappu Singh** of BJP from Purnia constituency has declared an income of **Rs. 54.17 lakhs** and **Dr Dilip Kumar Jaiswal** of BJP from Kishanganj constituency has declared an income of **Rs. 48.81 lakhs**. *Total income includes income of self, spouse and dependants
- **Candidates who have not declared Income Tax Details*:** **59 (55%)** candidates out of 108 have not declared their income tax details. *Some candidates may be exempted from filing Income Tax Returns.
- **Candidates with High Assets who have not declared Income Tax Details:** 9 candidate with assets worth more than Rs. 50 lakhs have not declared Income Tax details.
- **Undeclared PAN:** **41 (38%)** out of 108 candidates have not declared their PAN details.

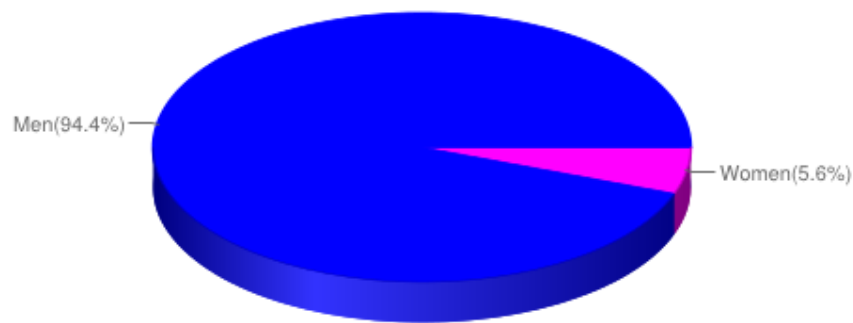

Out of the 108 candidates analysed, **38 candidates (35%)** have declared criminal cases against themselves. **30** candidates have **declared serious criminal cases** including cases related to **murder, attempt to murder, crimes against women, theft** etc.
