## Analysis of Criminal, Financial and Other Background Details of Candidates from Bihar (Phase – 4) for Lok Sabha 2014

Association of Democratic Reforms (ADR) and Bihar Election Watch have analyzed the self-sworn affidavits of all 94 candidates (as given by the ECI) who are contesting the 4<sup>th</sup> Phase of elections in Bihar for Lok Sabha 2014.

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of 94 candidates, **31 candidates (33%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 94 candidates analyzed, **19 candidates (20%)** have declared serious criminal cases including cases related to murder, attempt to murder, theft, kidnapping etc.
- **Party wise Candidates with Criminal Cases:** **2 (29%)** out of **7** candidates fielded by **BSP**, **1 (17%)** out of **6** candidates from **JD(U)**, **5 (83%)** out of **6** candidates of **RJD**, and **2 (40%)** out of **5** candidates from **BJP**, **2 (100%)** out of **2** candidates from **LJP**, **2(29%)** out of **7** candidates fielded by **AAP**, **2(67%)** out of **3** candidates from **CPI(M)** and **3 (13%)** out of **24 Independent candidates** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **1 (14%)** out of **7** candidates fielded by **BSP**, **1 (17%)** out of **6** candidates from **JD(U)**, **3 (50%)** out of **6** candidates from **RJD**, **1(20%)** out of **5** candidates from **BJP**, **2(67%)** out of **3** candidates from **CPI(M)** and **2 (8%)** out of **24 Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder:** **1 candidate** namely **Rajesh Ranjan urf Pappu Yadav** of **RJD** from **Madhepura** constituency has declared 1 charge related to **Murder(IPC Section-302)**
- **Candidates with cases related to Attempt to Murder:** **5 candidates** have declared charges related to **Attempt to murder(IPC Section-307)**
- **Candidate with Crimes Against Women:** **2 candidates** have declared charges related to crimes against women. **Mangni Lal Mandal** of **RJD** from **Jhanjharpur** has declared 1 charge related to **Husband or relative of husband of a woman subjecting her to cruelty(IPC section-498A)** and **Ganesh Mukhiya Nishad** of **Sarvajan Kalyan Loktantrik Party** from **Khagaria** constituency has declared a charge related to **Assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**
- **Red Alert Constituencies\*:** **7 constituencies** have atleast 3 candidates from these political parties with declared criminal cases. **Khagaria** Constituency has the highest number of candidates with criminal cases, i.e. **7** candidates.

*\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases standing up for elections*

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepati Candidates:** Out of the 94 candidates analysed, **31 (33%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All **6 candidates** from **RJD**, **5 (83%)** out of **6** candidates from **JD(U)**, **4(80%)** out of **5** candidates from **BJP**, **3(43%)** out of **7** candidates from **AAP**, **1(100%)** out of **1** candidate from **INC** and **3(43%)** of **7** candidates from **BSP** have declared assets worth more than Rs. 1 crore.

- **Average Assets:** The average assets per candidate contesting in the fourth phase of elections from Bihar for Lok Sabha 2014 is **Rs.1.90 Crores**.
- **Party-wise Average Assets:** Among major parties, the average assets for 6 **JD(U)** candidates is **Rs 4.89 crores**, 5 **BJP** candidates have average assets of **Rs.3.80 crores**, 1 **INC** candidate has average assets of **Rs. 1.45 crores**, 6 **RJD** candidates have average assets of **Rs. 4.66 crores** while 7 **AAP** candidates have average assets of **Rs. 5.89 crores**.
- **High Asset Candidates:** **11** candidates out of the 94 analyzed have more than **Rs 4 crores worth of assets**. Total Assets includes assets of self, spouse and dependents. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of the 94 candidates analyzed, a total of **8** candidates have declared assets less than **Rs.1 Lakh**. The three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of 4 candidates out of the 94 contesting candidates analyzed have declared liabilities above **Rs. 20 lakhs**. **Maheshwar Hazari** of **JD(U)** from **Samastipur** constituency has declared liabilities worth **Rs. 69.41 Lakhs** followed by **Chandra Shekhar Yadav** of **Bahujan Mukti Party** from **Madhepura** constituency with liabilities worth **Rs. 34 Lakhs** and **Abdul Bari Siddiqui** of **RJD** from **Madhubani** constituency with liabilities worth **Rs. 27.18 Lakhs**.
- **Candidates with High Income as declared in ITR:** **8** candidates have declared total annual Income of over **15 Lakhs**. **Kirti Azad** of **BJP** from **Darbhangha** constituency has declared the highest total income of **Rs. 1.10 crores** followed by **Sanjay Kumar Jha** a **JD(U)** candidate from **Darbhangha** constituency with **Rs. 59.73 Lakhs** and **Sunil Kumar** of **AAP** from **Begusarai** constituency with **Rs. 26.15 Lakhs** of total income.  
*\*Total income includes income of self, spouse and dependants*
- **Candidates who have not declared Income Tax Details\*:** **51 (54%)** candidates out of the 94 contesting candidates analyzed have not declared income tax details. *\* Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** **12** candidates with assets worth more than **Rs. 50 Lakhs**, have not declared Income Tax Details.

- **Undeclared PAN: 30(32%)** out of the 94 contesting candidates analyzed have not declared their PAN details. **Prabhat Ranjan Das** of AAP from Darbhanga constituency and **Mina Devi**, Independent candidate from Madhepura constituency have declared assets more than Rs. 1 crore but have not declared their PAN details.

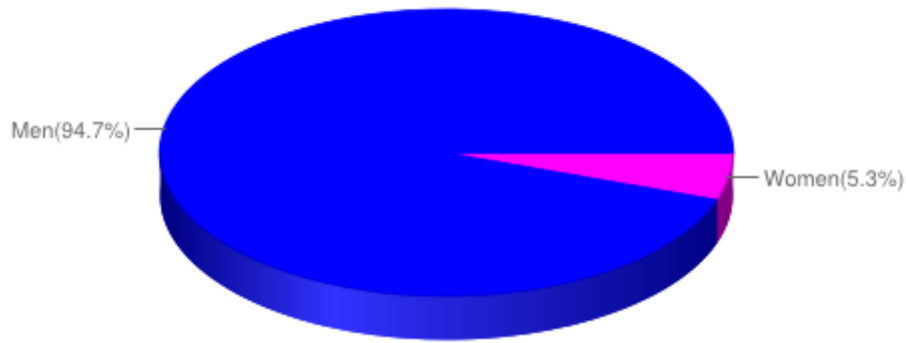

## **Executive Summary – Phase 1 to 4**

In total, affidavits of 398 candidates who contested the Lok Sabha elections from Bihar (Phase 1 to 4) have been analyzed. The overall highlights are also below.

- **Total candidates analyzed: 398** candidates
- **Candidates with declared Criminal Cases so far: 120 (30%)** candidates
- **Candidates with declared Serious Criminal Cases: 115 (29%)** candidates
