Association for Democratic Reforms (ADR) and Bihar Election Watch have analyzed the self-sworn affidavits of all 118 contesting candidates from Bihar (Phase-5) for Lok Sabha Elections 2014 as given by the ECI. **This phase will be going to polls on 7th May.**

Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of the 118 candidates analysed, **37 candidates (31%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **25 candidates (21%)** have declared serious criminal cases relating murder, to attempt to murder, crimes against women etc.
- **Party wise Candidates with Criminal Cases:** **1 (50%)** out of **2** candidates fielded by **INC**, **4 (80%)** out of **5** candidates from **BJP**, **4 (57%)** out of **7** candidates from **JD(U)**, **4 (57%)** out of **7** candidates from **BSP**, **4 (80%)** of **5** candidates from **RJD** and **2 (29%)** out of **7** from **AAP** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **3 (60%)** out of **5** candidates from **BJP**, **3 (43%)** out of **7** candidates from **JD(U)**, **4 (57%)** out of **7** candidates from **BSP** and **4 (80%)** out of **5** candidates from **RJD** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder:** **2 candidates**, **Manoranjan Singh** of **JD(U)** and **Prabhu Nath Singh** of **RJD**, both from Maharajganj constituency have declared **cases related to murder (IPC Section 302)**
- **Candidates with cases related to Attempt to Murder:** **6 candidates** contesting from Bihar (Phase-5) in the Lok Sabha elections, 2014 have declared **cases related to attempt to murder**.
- **Candidates with Crimes against Women:** **1 candidate**, **Amrendra Kumar Yadav** of **Rashtriya Krantikari Samajwadi Party** from **Ujjarpur** constituency has declared a case of **husband or relative of husband of a woman subjecting her to cruelty (IPC Section-498A)**.
- **Red Alert Constituencies*:** **All 7 constituencies** in Bihar (Phase-5) have at least 3 candidates with declared criminal cases.

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the 118 candidates, **36 (31%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **Both** candidates from **INC**, **4 candidates (80%)** out of **5** from **BJP**, **5 (71%)** out of **7** candidates of **JD(U)**, **all 5** candidates from **RJD** and **3 (43%)** out of **7** candidates from **AAP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting from Bihar (Phase-5) in Lok Sabha 2014 elections is **Rs. 1.90 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **2 INC** candidates is **Rs 14.57 crores**, **7 JD(U)** candidates have average asset of **Rs. 2.82 crores**, **5 BJP** candidates have average assets of **Rs 13.36 crores**, **5 RJD** candidates have average asset of **Rs 4.82 crores** and **7 AAP** candidates have **Rs 77.62 lakhs**
- **High Asset Candidates:** **5** candidates have declared more than **Rs. 10 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Candidates with Zero Assets:** 1 candidate, **Satya Narayan Paswan** of **AIFB** from Hajipur constituency has declared his total assets as worth zero.
- **Low Asset Candidates:** Out of 118 candidates analysed, a total of **35** candidates have declared assets **less than Rs 10 lakhs** (excluding candidates with zero assets). The top three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of **59** candidates out of 118 have declared liabilities **out of which 3** candidates have declared liabilities **above Rs 50 lakhs**. **Akshay Verma** of **Sarvajan Kalyan Loktantrik Party** from Muzaffarpur constituency has declared liabilities of **Rs. 1.49 crores** followed by **Rabri Devi** of **RJD** from Saran constituency with liabilities of **Rs 1.30 crores** and **Angesh Kumar** of **BSP** from Sheohar constituency declaring total liabilities of **Rs 57.50 lakhs**
- **Candidates with High Income as declared in ITR:** A total of 49 candidates have declared their income tax details **out of which 5** candidates have declared a total income of more than **Rs 25 lakhs**. **Akhilesh Prasad Singh** of **INC** from Muzaffarpur constituency has declared the highest total income of **Rs 1.04 crores** followed by **Angesh Kumar** of **BSP** from Sheohar constituency with a total income of **Rs 43.19 lakhs** and **Janardhan Singh Sigriwal** of **BJP** from Maharajganj constituency declared a total income of **Rs 31.86 lakhs**.
- **Candidates who have not declared Income Tax Details*:** **69 (58%)** candidates out of 118 analyzed have not declared income tax details. *Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** **11** candidates out of 118 candidates have declared total assets worth more than Rs 1 crore but have not declared Income Tax Details. The top three candidates with high assests who have not declared income tax details are as following:

- **Undeclared PAN:** **46 (39%)** out of 118 candidates analysed have not declared their PAN details.

- **Crorepati Candidates who have not declared PAN details:** 6 candidates with total assets worth more than Rs. 1 crore have not declared their PAN details.

Other Background details (Education, Gender, Age)

- **Candidates Education:** 53 (45%) out of 118 candidates have educational qualification of 12th pass or below. 63 (53%) out of 118 candidates are graduates or above.
- **Candidates' Age:** 85 (72%) out of 118 candidates have declared their age to be between 25 to 50 years of age. 32 (27%) out of 118 candidates have declared their age to be between 51 to 80 years of age. 1 candidate has declared to be more than 80 years of age
- **Women Candidates:** 9 (8%) out of 118 candidates are women.

Out of the 118 candidates analysed, 37 candidates (31%) have declared criminal cases against themselves. 25 candidates (21%) have declared serious criminal cases relating to murder, attempt to murder, crimes against women etc

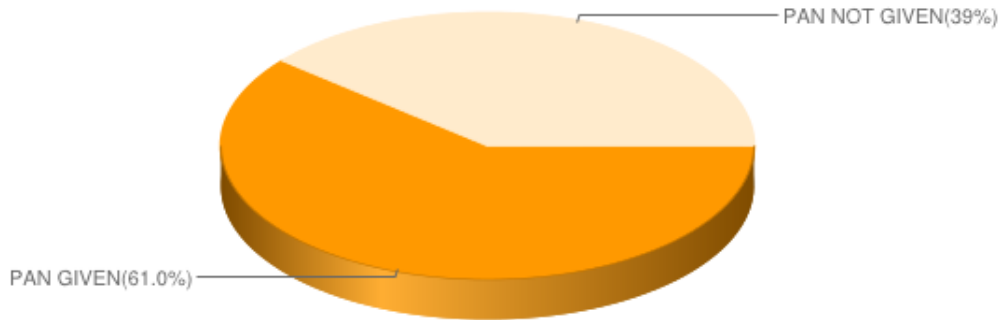

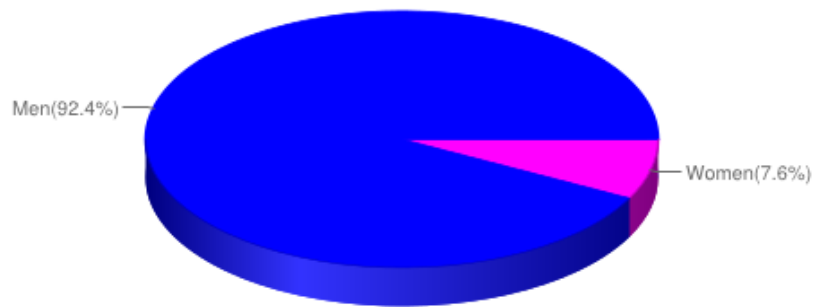
