Summary and Highlights

Association for Democratic Reforms (ADR) and Uttar Pradesh Election Watch have analysed the self-sworn affidavits of all 19 candidates contesting for the position of Mayor in the Lucknow Municipal Corporation Election, 2017, scheduled to be held on 26th November, 2017.

Criminal Background

- **Candidates with declared criminal cases:** None of the candidates have declared criminal cases against themselves in their self-sworn affidavits.

Financial Background

- **Crorepati Candidates:** Out of the 19 candidates analyzed, 10 (53%) are crorepatis.
- **Average Assets:** The average assets per candidate analyzed for this election is Rs. 2.45 crores.
- **High Assets:** The top five candidates with highest declared assets are given below.

Other Background Details

- **Age Details of Candidates:** 5 (26%) candidates have declared their age to be between 31 to 40 years. 12(63%) candidates have declared their age to be between 41-60 years while 2(11%) candidates have declared their age to be between 61-70 years.

- **Educational Qualification Details of the Candidates:** There are **4(21%)** candidates who have declared their educational qualification to be between **8th pass and 12th pass** while **11(58%)** candidates have declared their educational qualification as graduate and above. There are **3(16%)** candidates who have declared their educational qualification as **doctorate** while **1 (5%)** has not given her educational qualification in her affidavit.
