## Summary and Highlights

**Association for Democratic Reforms (ADR) and Maharashtra Election Watch** have analysed the self-sworn affidavits of **593** candidates out of **868** who are contesting for the fourth phase of **11** Municipal Councils in **Nagpur and Gondiya districts, 2016**, scheduled to be held on **8<sup>th</sup> January, 2017**.

Local bodies' elections are being held for **244** seats in above **2** districts, details of which are as follows –

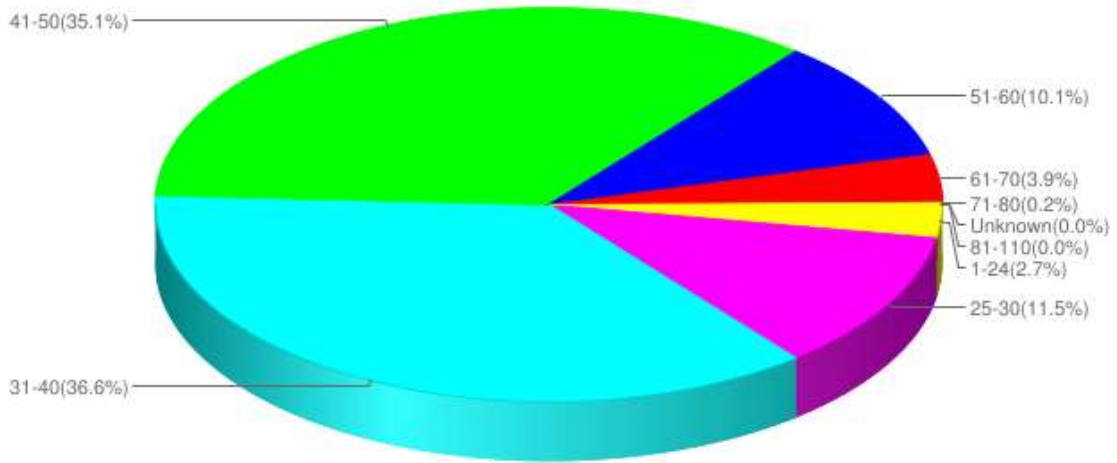
## Other Background Details

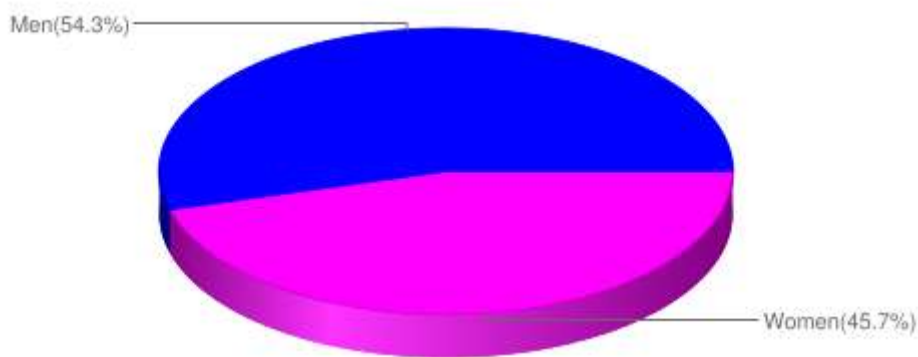
