ORDER UNDER SECTION 7(1) OF THE RIGHT TO INFORMATION ACT, 2005.

1. Sh. Anil Bairwal, Association for Democratic Reforms Table No. 4 "Kiwani Centre", 4th Floor, B-35, Qutub Institutional Area, New Delhi-110016 Landmark: Near Rockland Hospital., vide his application No. ADR04/RTI/CHARANJIT/01 dated 24-12-2012 received in this office on 31-12-2012 has sought information under the Right to Information Act 2005. The applicant has requested in his application to supply the information/documents as mentioned on column No. 3. above relating to third party Smt. Charanjit Kaur Bajwa M.L.A. W/o Sh. Partap Singh Bajwa R/o old Railway Road, Qadian, Tehsil Batala, Distt. Gurdaspur.

I have considered the applicant's request for providing information as enumerated above and found that the information sought by the applicant is of a personal in nature and belongs to third party and the same is not in a public domain being records in secret in nature. After taking into consideration the facts referred supra, information sought by the applicant cannot be provided to the applicant which is of personal in nature. So the same cannot be supplied under clause (d) & (j) of sub (1) of section 8 of the Income-tax Act 1961. In view of the facts mentioned supra, the information sought by the applicant cannot be provided and the request of the applicant is, hereby rejected. However, it is informed to you that the assessee has filed her return of Income for the Assessment Year 2012-13 through e. filing and she was allotted P.A.N. on 30-09-2010.
