Analysis of Election Expenses of MLAs from the Chhattisgarh, 2013 Assembly Elections

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Election Expense limit for the Chhattisgarh 2013 Assembly Elections by the Election Commission of India is 16 Lakh Rupees, which is revised from time to time.

Chhattisgarh Election Watch (CEW) and Association for Democratic Reforms (ADR) have analyzed the election expenditure affidavits of 83 out of the 90 newly elected MLAs in the Chhattisgarh 2013 Assembly Elections. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

Summary and Highlights of Election Expenses of MLAs from the Chhattisgarh 2013 Assembly Elections

1. ***Less than 50% of the Limit:*** Candidates have constantly claimed that the election expenditure limit set by the ECI is very low. However, based on the election expense declarations of 83 out of 90 newly elected MLAs of Chhattisgarh to the ECI, **32 MLAs (39%) have declared election expenses of less than 50% of the expense limit** i.e. Rs 16 Lakhs.
2. ***Average Election Expenses:*** Based on the election expense declarations of 83 out of the 90 newly elected MLAs of Chhattisgarh to the ECI, the **average amount of money spent** by them in the elections is only about **Rs 8.46 Lakhs, which is 53% of the expense limit** (16 Lakhs).
3. ***Party wise Average Election Expenses:*** The Party wise average election expenses shows that the average spending for **45 MLAs of BJP is Rs 8.94 lakhs** (56% of the expense limit), for **INC's 37 MLAs is Rs 7.96 lakhs** (49% of the expense limit and **1 Independent MLA** has declared expense of **Rs 5.81 Lakhs** (36% of the expense limit)).
4. ***Election expense of Chief Minister:*** Raman Singh has declared election expense of **Rs 8.16 Lakhs** (51% of expense limit).
5. ***Election expense of Ministers:*** The average election expense declared by 9 Ministers including Chief Minister is **Rs 8.33 Lakhs**. **Ramsevak Paikra** has declared highest election expense of **Rs 11.09 Lakhs** (69% of expense limit) among ministers while **Brijmohan Agrawal** declared lowest election expense of **Rs 5.35 Lakhs** (33% of expense limit). 3 Ministers have declared election expenses less than 50% of expense limit.
6. ***Top 3 MLAs with highest Election Expenses:*** The maximum expense of about **Rs 13.17 Lakhs** (82% of the expense limit) has been declared by **Rupkumari Choudhary** of **BJP** from

Basna constituency followed by **Rajsharan Bhagat** of **BJP** from Jashpur constituency with an expense of **Rs 12.42 lakhs** (or 78% of the expense limit) and **Amit Aishwary Jogi** of **INC** from Marwahi constituency with an expense of **Rs 11.94 Lakhs** (or 75% of the expense limit)

7. **MLAs with lowest Election Expenses:** The minimum expense of about **Rs 3.76 Lakhs** (or 24% of the expense limit) has been declared by **Shyam Lal Kanwar** of **INC** from Rampur constituency. He is followed by **Brihaspat Singh** of **INC** from Ramanujganj constituency with election expenses of about **Rs. 4.32 lakhs** (or 27% of the expense limit) and **Chintamani Kanwar** of **INC** from Lundra constituency with expenses of **Rs. 4.42 lakhs** (or 28% of the expense limit).
8. **Expense on Public Meetings and Processions:** Out of the 83 MLAs analyzed, **7** have declared that they have not spent ANY amount on public meetings, processions etc.
9. **Expense on Campaigning through electronic/print media:** **44 (53%)** MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media.
10. **Expense on Campaign Workers:** **12 (14%)** MLAs have declared that they have not spent ANY amount on campaign workers.
11. **Expense on Vehicles Used:** Jaysingh Agrawal of **INC** from Korba constituency has declared the lowest amount of **Rs 41,006** spent on vehicle use.
12. **Expense on Campaign Materials and Erection of gates, arches, banners etc.:** All 83 MLAs analysed have declared that they have incurred some expense on campaign materials and erection of gates, arches, banners etc. **Shyam Lal Kanwar** of **INC** from Rampur constituency has declared lowest amount of **Rs 42000** spent on campaign Materials, banners, gates, etc.

Analysis of the Election Expenses – MLAs

Election expenses declared by Ministers

The average election expense declared by 9 Ministers including Chief Minister is **Rs 8.33 Lakhs**. **Ramsevak Paikra** has declared highest election expense of **Rs 11.09 Lakhs** (69% of expense limit) among ministers while **Brijmohan Agrawal** declared lowest election expense of **Rs 5.35 Lakhs** (33% of expense limit). 3 Ministers have declared election expenses less than 50% of expense limit.

The minimum expense of about **Rs 3.76 Lakhs** (or 24% of the expense limit) has been declared by **Shyam Lal Kanwar of INC** from Rampur constituency. He is followed by **Brihaspat Singh of INC** from Ramanujganj constituency with election expenses of about **Rs. 4.32 lakhs** (or 27% of the expense limit) and **Chintamani Kanwar of INC** from Lundra constituency with expenses of **Rs. 4.42 lakhs** (or 28% of the expense limit).

MLAs who declared NO expenses on Public Meetings, Processions etc.

According to the ECI's document of Election Expenditure Monitoring 2011, (5.5.1) *Any candidate or his representative, who applies for permission for a public meeting or a rally shall also submit an expenditure plan in a prescribed format along with the application for permission.* (5.6.2) *In the event of public rally or meeting by the star campaigner, if the candidate or his election agent shares the dias with the star campaigner/another dignitary or banners and posters with his name or photograph are displayed at the site of the rally or his name is mentioned by the Star Campaigner, then the entire expenditure on that rally other than the travel expenses on that star campaigner shuld be added to the candidate's expenses.*

Out of the 83 MLAs analyzed, **7 declared that they have not spent ANY amount on public meetings, processions etc.** as per their election expenses. The names of these MLAs are listed below:

MLAs who declared NO expense on campaigning through electronic/print media

This category for monitoring election expenses is mainly to combat instances of “paid news” and surrogate advertising that many candidates resort to. According to 4.10.4 of ECI’s document of Election Expenditure Monitoring 2011, *“The candidate will have to submit the details of expenditure on the telecast/ broadcast in electronic media and advertisement/ paid news in print media. If the Media monitoring cell finds that any advertisement has been published in favour of any candidate without proper permission, they shall inform the RO immediately, and the RO will issue a notice to the candidate u/s 127 of the R.P.Act, 1951”.*

44 MLAs have declared that **they have not spent ANY amount** on campaigning through electronic/print media. The table below provides a list of the names of these MLAs.
