


Figure: Party Wise Average Attendance




Figure: Party Wise Average Number of Questions Asked

• Highest number of Questions were related to Education, Panchayat and Rural Development and Food Civil Supplies & Consumer Protection.




Figure: Top 10 - Category Wise Questions Asked

- 1 Bill was withdrawn and the house did not allow the introduction of 1 Bill.




Figure: Percentage of Bills Passed in 5th Chhattisgarh Assembly
