

Analysis of Criminal, Financial, Education, Gender and other details of Candidates contesting in the Chhattisgarh 2013 Assembly Elections

Summary and Highlights

Chhattisgarh Election Watch (CEW) and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **983 candidates out of 986** who are contesting in **90 constituencies** during the Chhattisgarh State Assembly Elections.

Criminal:

- **Candidates with Criminal Cases:** Out of the 983 candidates analysed, **113 candidates (11%)** have declared criminal cases against them.
- **Candidates with Serious Criminal Cases:** Out of the 113 candidates who have declared criminal cases, **66 (7%) have declared serious criminal cases**. These include **murder, kidnapping, criminal intimidation and crime against women**.
- **Party wise Candidates with Criminal Cases:** **18 of 90 (20%)** candidates fielded by **INC** have declared criminal cases against them while **13 out of 90 (14%)** candidates from **BJP**, **14 out of 89 (16%)** candidates from **BSP**, **3 out of 40 (8%)** candidates from **SP** and **11 out of 54 (20%)** from **CSM** have declared criminal cases in their affidavits.
- **Murder Related Cases:** Amit Aishwary Jogi of INC from Marwahi constituency and Mahesh Kumar Gada of BJP from Bijapur constituency has declared murder charges against him.

Financial:

- **Crorepati Candidates:** Out of the **983** candidates analysed, **213 (22%)** are crorepatis.
- **Average Assets:** The average asset per candidate contesting in the 2013 Chhattisgarh Assembly Elections is **Rs.1.42 Crores**.
- **Party-wise Average Assets:** The average asset per candidate for INC (90 candidates) is **Rs.9.32 Crores**, for 90 BJP candidates the average is **Rs.1.95 Crores**, for BSP (89 candidates) it is **Rs.48.22 Lakhs** and the average assets of Chhattisgarh Swabhimani Manch (CSM) (54 candidates) is **Rs.1.01 Crores**.
- **High Asset Candidates:** The top three candidates with highest declared assets are **Tribhuneswar Sharan Singh Dev of INC** from Ambikapur Constituency with declared assets worth **Rs.561.50 Crores** followed by **Raja Surendra Bahadur Singh of GGP** from Sakti Constituency with assets worth **Rs.46.10 Crores** and **Rajkamal Singhaniya of INC** from Kasdol Constituency with assets worth **Rs 33.31 Crores**.
- **Low Asset Candidates:** Out of 983 candidates analysed, a total of **8** candidates have declared **zero assets** and a total of **110** candidates have declared assets less than **Rs.1 Lakhs**. Among BJP candidates, **Satish Kumar Latiya** from Bhanupratappur constituency has declared lowest assets worth **Rs.10.43 Lakhs** and **Dilip Lahriya** from Masturi constituency with declared assets of **Rs.5.23 Lakhs** has the lowest declared assets among INC candidates.

- **Liabilities:** A total of **145** candidates out of 983 analyzed have declared liabilities of **Rs.10 Lakhs** and above.
- **High Liability Candidates:** The top three candidates with highest declared liabilities are **Arvind Kumar Sharma** of BSP from Korba constituency has declared the highest liabilities worth **Rs.2.60 Crores** followed by **Ajay Chandrakar** of BJP from Kurud constituency with liabilities worth **Rs.2.50 Crores** and **Anita Sharma** of INC from Dharsiwa constituency with **Rs.1.80 Crores** worth of liabilities.
- **Undeclared PAN:** 427 out of 983 (43%) candidates contesting in the 2013 Chhattisgarh Assembly Elections have not declared their PAN details.
- **Candidates who have not declared ITR:** 656 out of 983 candidates (67%) analysed have not declared annual income in their ITR.
- **High Income Candidates:** **Amitesh Shukla** of INC from Rajim constituency has declared the highest income of **Rs.1.70 Crores** in the last Income Tax Returns (ITR) filed for the year 2012-13 followed by **Ajay Chandrakar** of BJP from Kurud constituency with total income of **Rs.67.06 Lakhs** and **Rajkamal Singhaniya** of INC from Kasdol with an income of Rs.63.30 Lakhs for the financial year 2012-13

Other Background details (Education, Gender, Age):

- **Candidates' Education:** A total of **329 (33%)** candidates out of 983 analyzed are graduates or have higher degrees. **625 (64%)** candidates have educational qualification of 12th pass and below.
- **Candidates' Age:** A total of **720 (73%)** candidates out of the 983 analyzed, have declared their age to be between 25 and 50 years. **250(25%)** candidates declared their age to be between 51 and 70 years while 2 candidates declared their age to be above 80 years.
- **Women Candidates:** Out of 983 candidates analyzed, only **81 (8%) women** are contesting in the Chhattisgarh 2013 Assembly Elections. Among the major political parties, INC has fielded 14 women candidates while 11 women are contesting under BJP ticket and 6 women are contesting under a BSP ticket.

Analysis based on declared criminal cases

Out of the 983 candidates analysed, 113 candidates have declared criminal cases against them. Out of these 113 candidates, 66 have declared serious criminal cases.

Party-wise break up of candidates with declared criminal cases

A total of 113 candidates contesting in the 2013 Chhattisgarh Assembly Elections have declared criminal cases against them. 13 out of 90 (14%) candidates fielded by BJP have declared criminal cases against them while 18 out of 90 (20%) candidates from INC, 14 out of 89 (16%) candidates from BSP and 3 out of 40 (8%) from SP have declared cases against themselves. 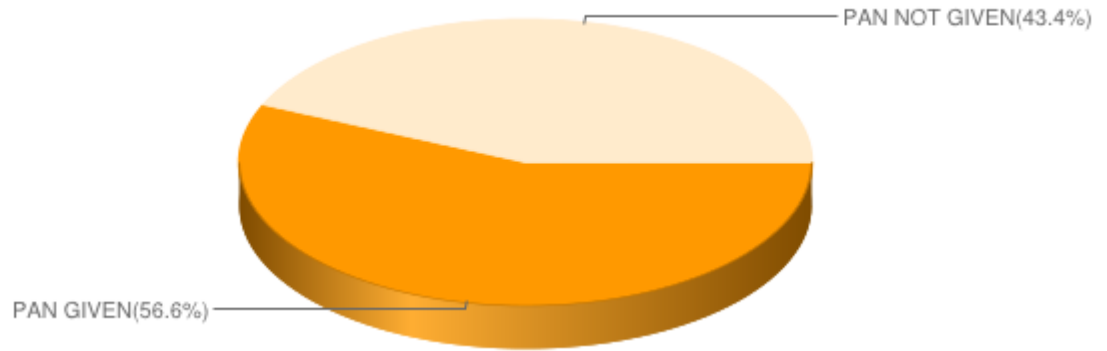
