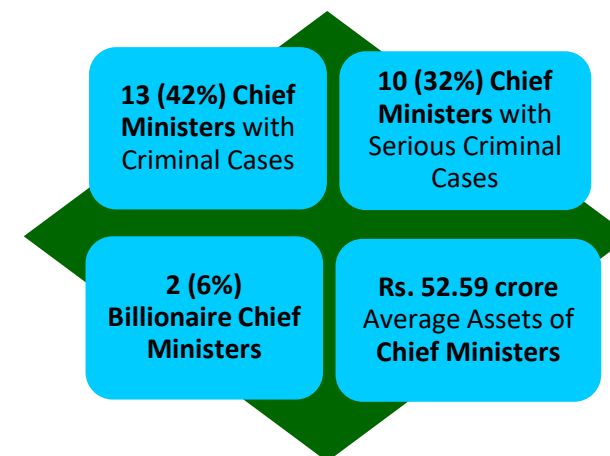

## Summary and Highlights:

Association for Democratic Reforms (ADR) & National Election Watch (NEW) have analysed the self-sworn affidavits of all **31** current Chief Ministers in State Assemblies and Union Territories across the nation. This data has been extracted from affidavits filed by the Chief Ministers prior to contesting their last elections.

### Criminal Background

- **Chief Ministers with Criminal Cases:** Out of the all **31 Chief Ministers** analysed from State Assemblies and Union Territories **13 (42%) Chief Ministers** have declared criminal cases against themselves.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable, cognizable
3. If it is an electoral offence
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned under Act Section 8 Representation of the People
7. Offences under Prevention of Corruption Act
8. Crimes against women and children

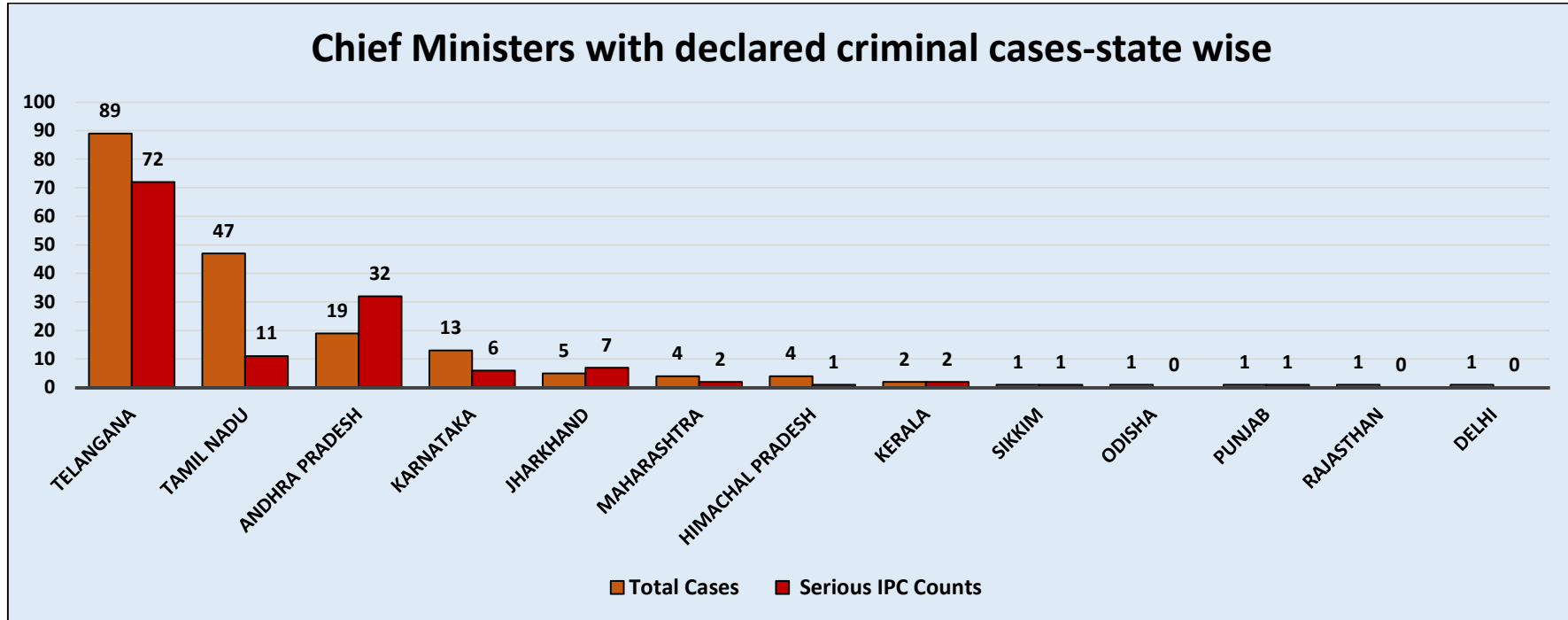


Figure: Chief Ministers with declared criminal cases – State wise

## Financial Background

- **Average Assets of Chief Ministers:** The average of assets per Chief Minister from state assemblies and union territories is **Rs.52.59 Crores**.
- **Average Self Income of Chief Ministers:** According to the Press Information Bureau (PIB), India's per capita net national income or NNI is approximately **Rs 1,85,854** for the financial year 2023-2024. Compared to this, the average self-income of a Chief Minister is **Rs.13,64,310**, which is **7.3** times more than the average per capita income of India.
- **Billionaire Chief Ministers:** Out of the **31** Chief Ministers of State Assemblies and Union Territories analysed, **2 (6%)** are Billionaires.
- **Total Assets of Chief Ministers:** The total assets of **31** Chief Ministers are **Rs. 1,630 Crores**.

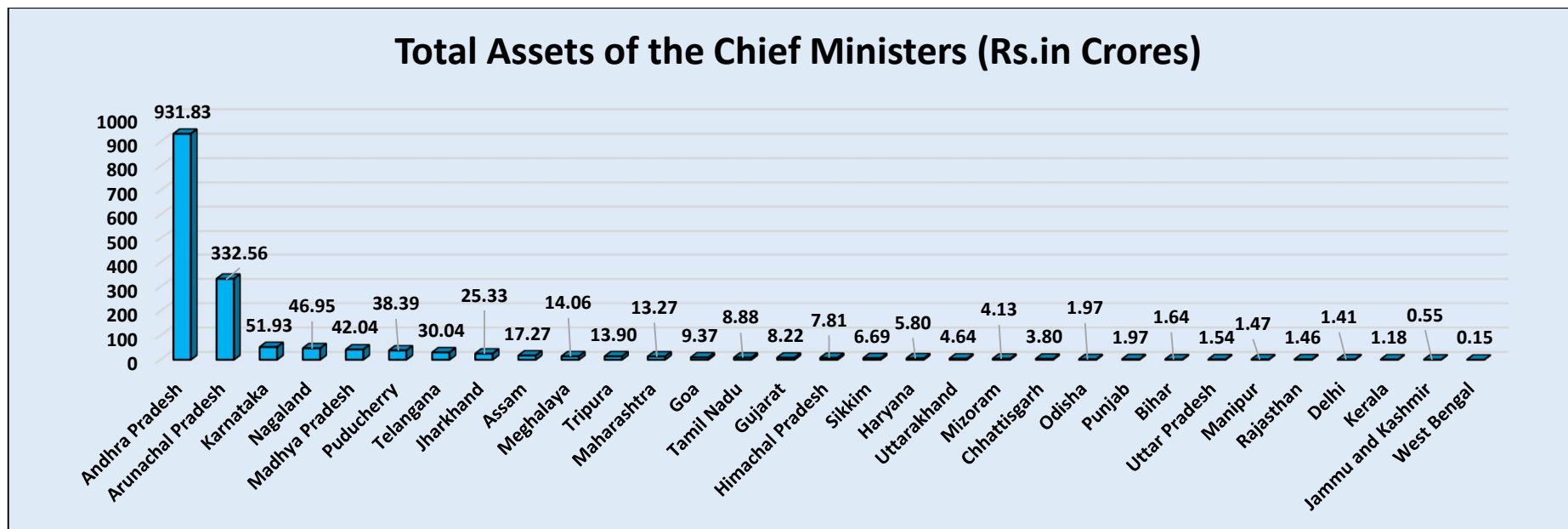


Figure: State wise assets detail of Chief Ministers

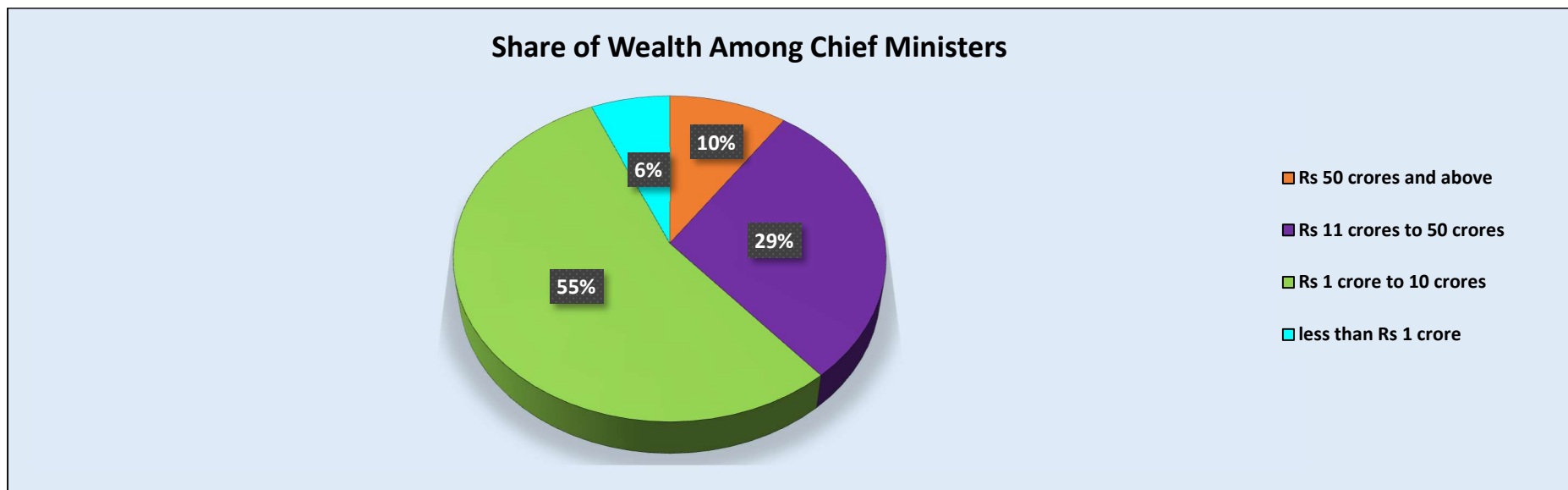


Figure: Share of Wealth among Chief Ministers

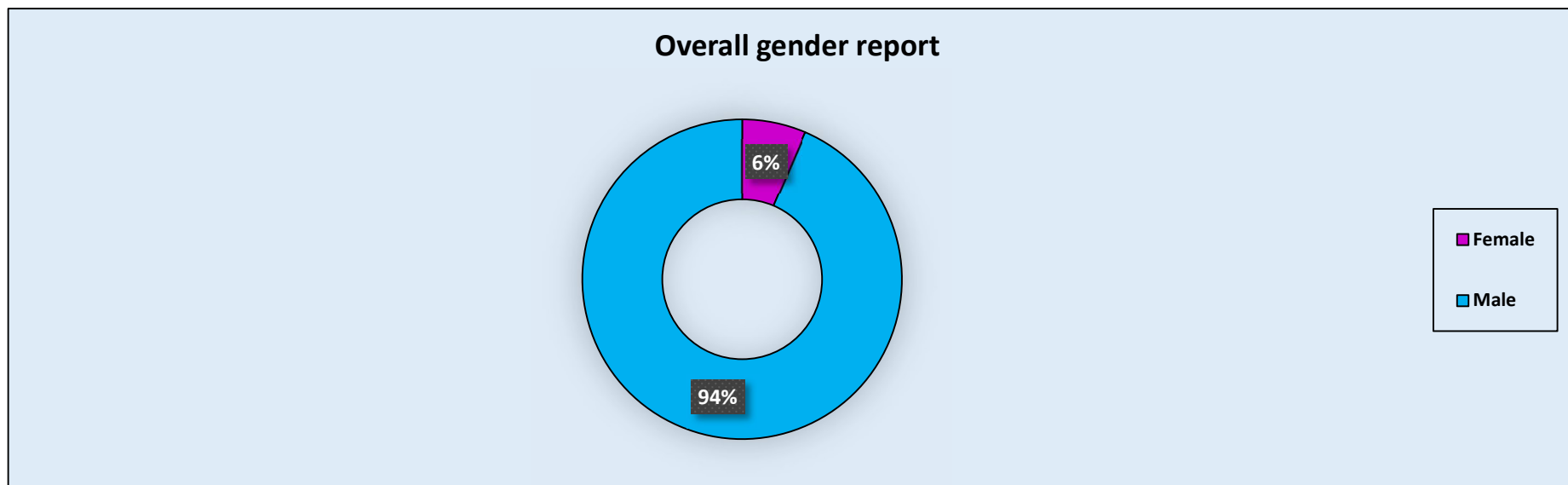


Figure: Overall gender report

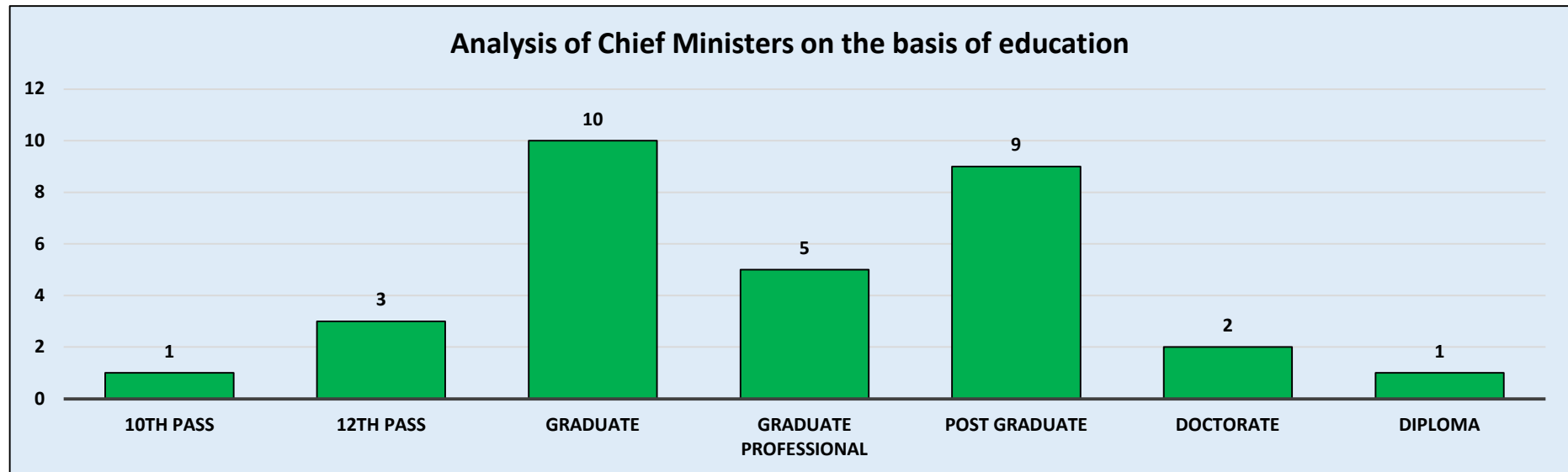


Figure: Analysis of Chief Ministers on the basis of education

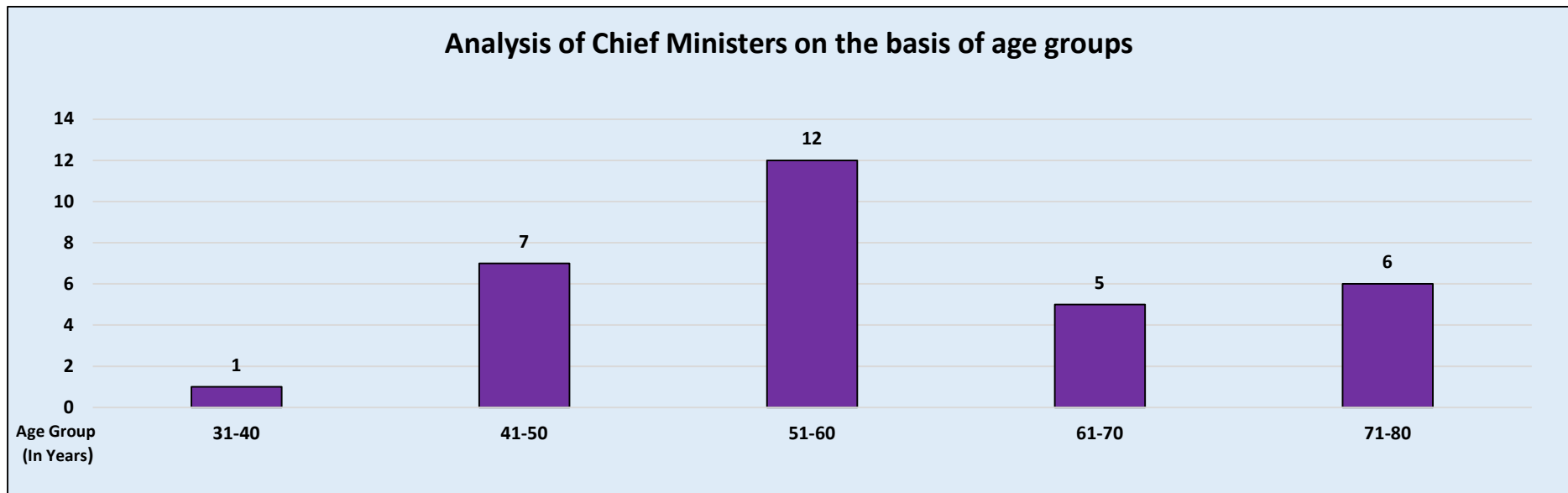


Figure: Analysis of Chief Ministers on the basis of age groups
