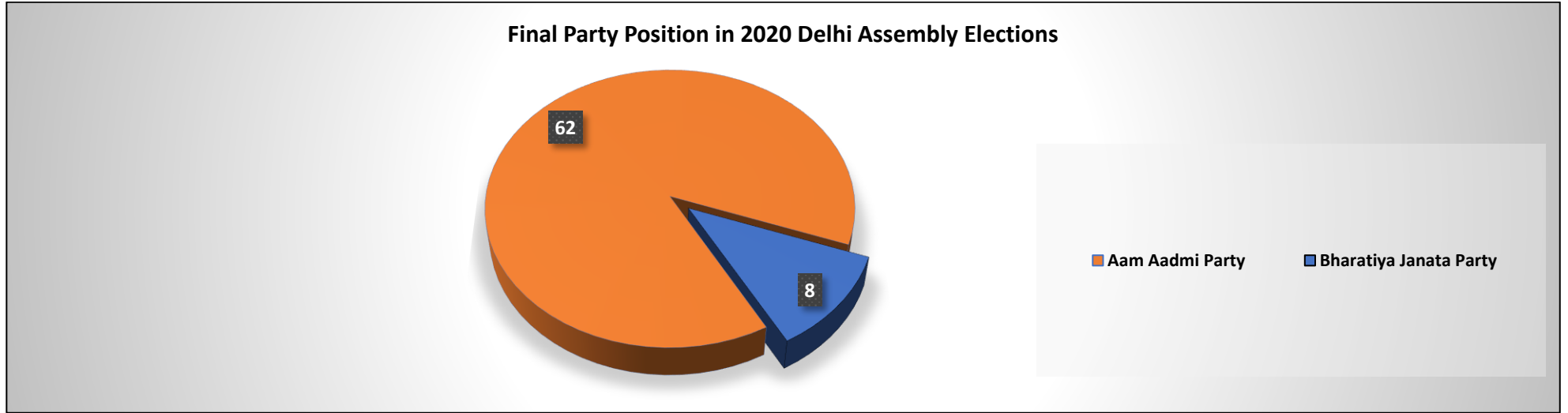

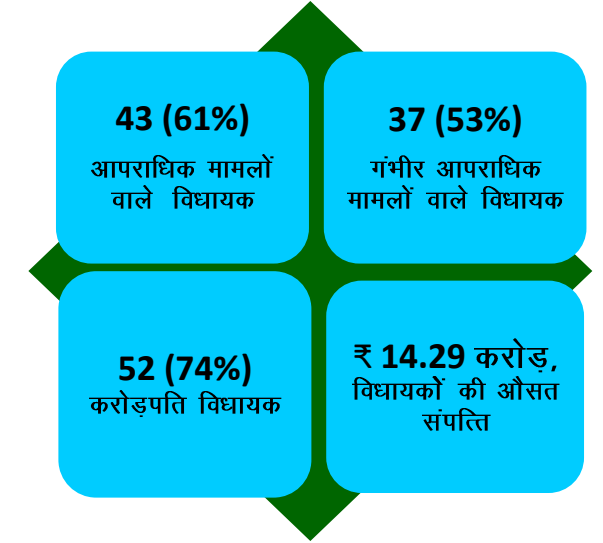

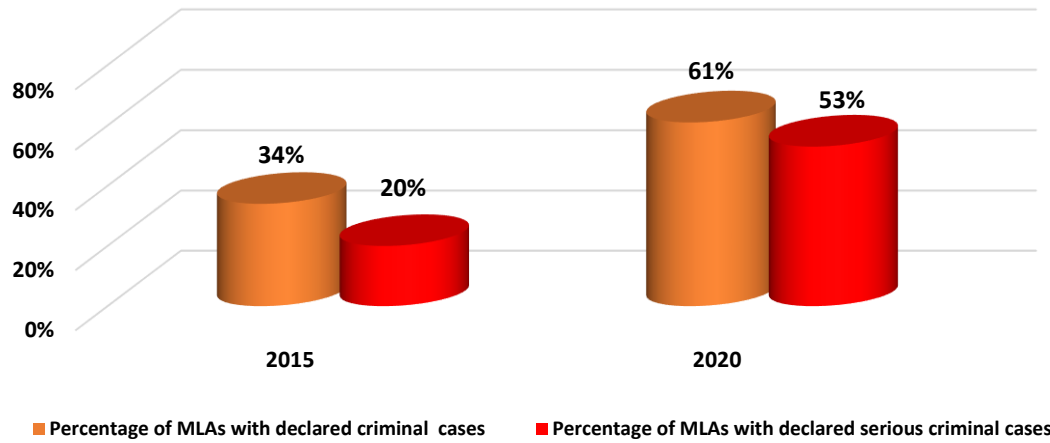

आपराधिक पृष्ठभूमि

- ☞ विधायकों द्वारा घोषित आपराधिक मामले:- दिल्ली विधानसभा चुनाव 2020 में 70 में से 43 (61 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। दिल्ली विधानसभा चुनाव 2015 में 70 में से 24 (34 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:- 37 (53 प्रतिशत) विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं, जिनमें बलात्कार, हत्या का प्रयास, महिलाओं के ऊपर अत्याचार इत्यादि से सम्बन्धित अपराध शामिल हैं।



Comparison of MLAs with declared criminal cases in 2015 vs 2020



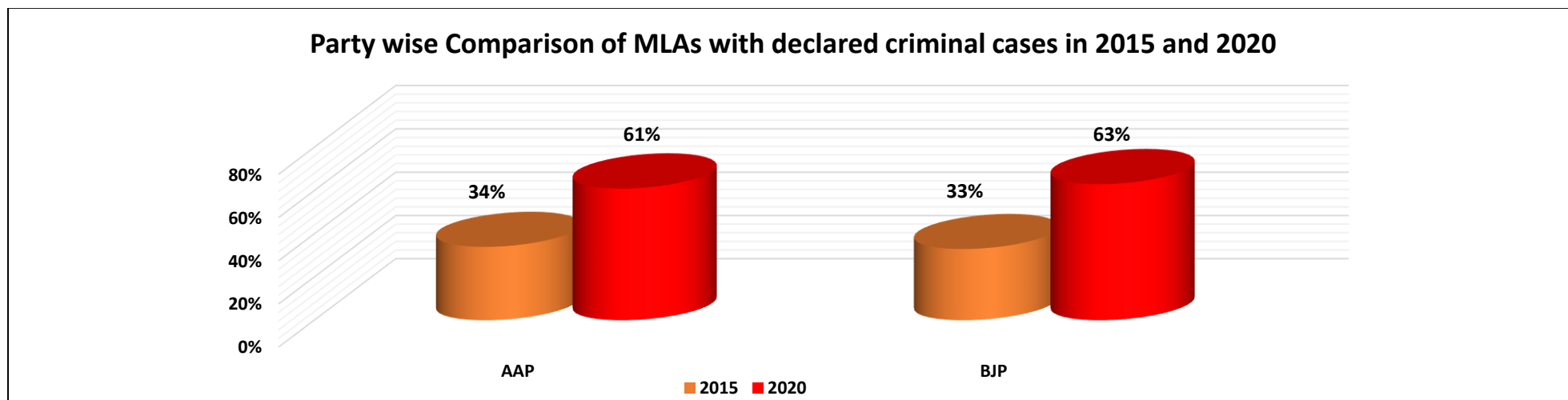

6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध

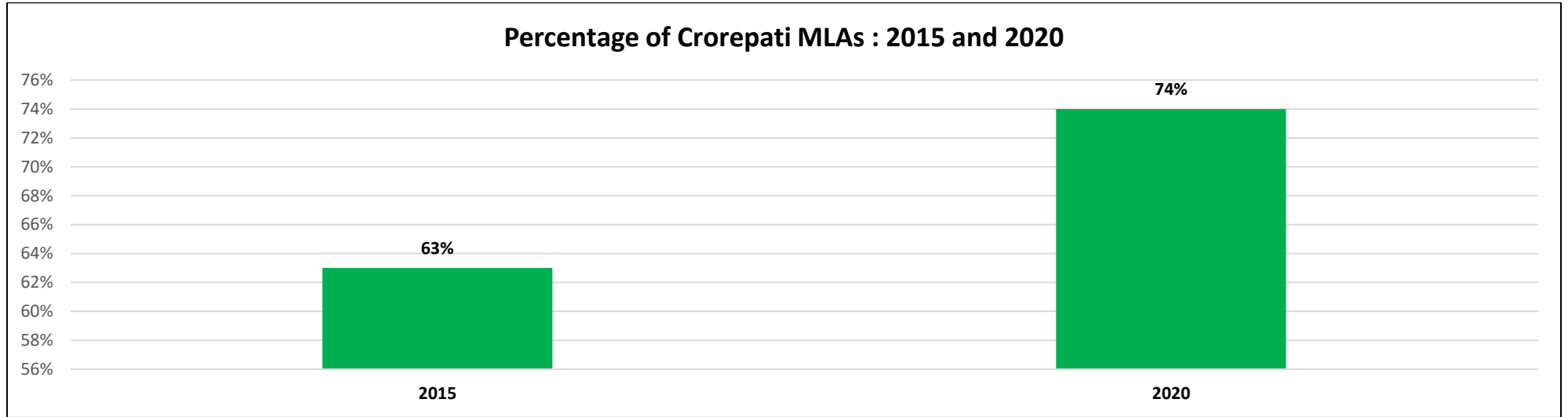

- ☞ दोषसिद्ध मामले घोषित करने वाले विधायक: 9 विधायकों ने अपने ऊपर दोषसिद्ध मामले घोषित किये हैं।
- ☞ हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले विधायक: 1 विधायक ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामले घोषित किये हैं।
- ☞ महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले विधायक: 13 विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। इन 13 विधायकों में से 1 ने अपने ऊपर **बलात्कार** (आईपीसी-376) से सम्बन्धित मामले घोषित किये हैं।
- ☞ विधायकों द्वारा घोषित आपराधिक मामले-दलवार: **AAP** के 62 में से 38 (61 प्रतिशत) और **BJP** के 8 में से 5 (63 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले-दलवार: **AAP** के 62 में से 33 (53 प्रतिशत) और **BJP** के 8 में से 4 (50 प्रतिशत) विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।

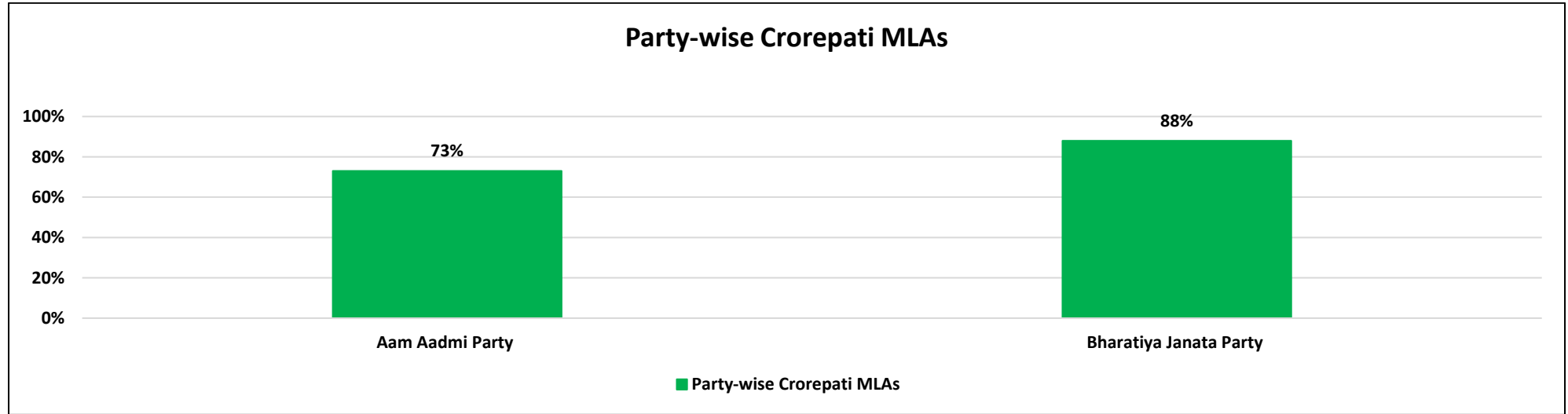
☞ **करोड़पति विधायक:** नवनिर्वाचित 70 में से 52 (74 प्रतिशत) विधायक करोड़पति हैं। दिल्ली विधानसभा चुनाव 2015 में 70 में से 44 (63 प्रतिशत) करोड़पति विधायक थे।

Share of wealth among MLAs



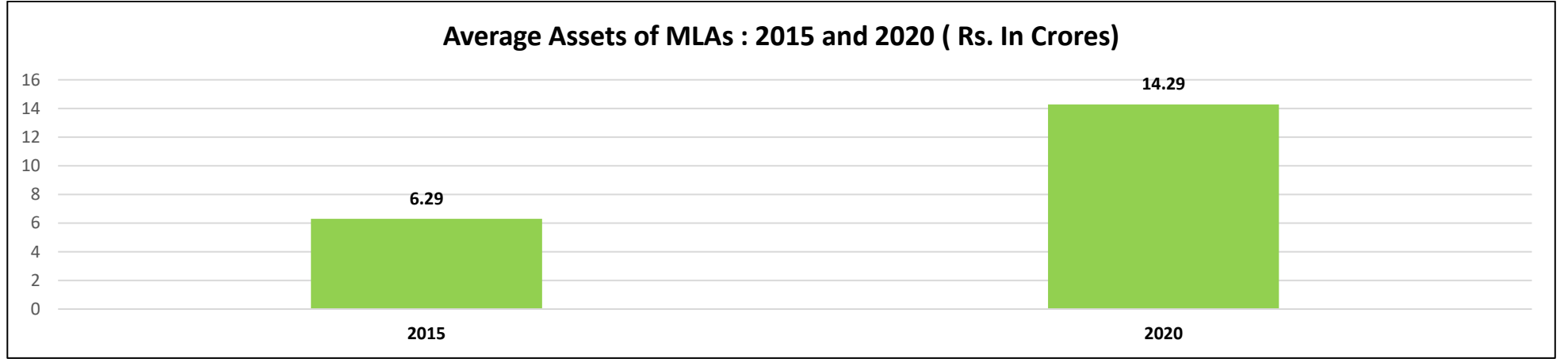

- ☞ शैक्षिक योग्यता: **23 (33 प्रतिशत)** विधायकों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की है, जबकि **42 (60 प्रतिशत)** विधायकों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की है और **5** विधायकों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की हैं।
- ☞ विधायकों की आयु: **39 (56 प्रतिशत)** विधायकों ने अपनी आयु **25 से 50** वर्ष के बीच घोषित की है, जबकि **31 (44 प्रतिशत)** विधायकों ने अपनी आयु **51 से 80** वर्ष के बीच घोषित की है।
- ☞ महिला प्रतिनिधित्व: दिल्ली विधानसभा चुनाव 2020 में **70** में से **8 (11 प्रतिशत)** महिला विधायक हैं। 2015 विधानसभा में **70** में से **6 (9 प्रतिशत)** महिला विधायक थीं।

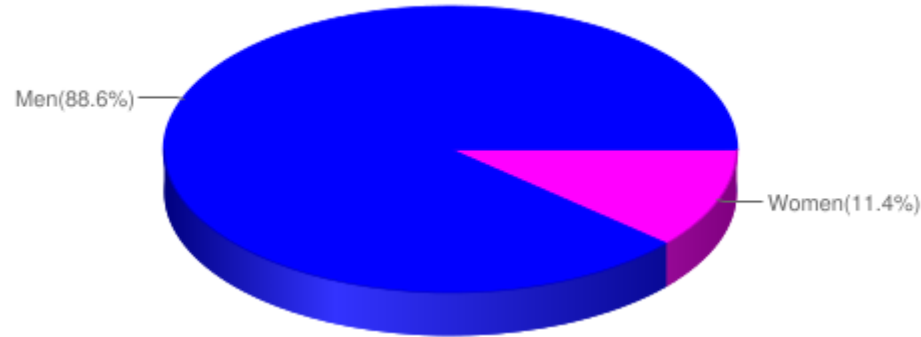
